“Neural and Vascular Interactions in the Visual System”

The brain and eyes need a steady supply of blood to function properly. This blood flow must quickly adjust to meet the energy needs of active brain cells, a process called neurovascular coupling (NVC). When NVC does not work correctly, it can lead to problems in the brain and eyes, contributing to diseases like glaucoma, diabetic retinopathy, age-related macular degeneration (AMD), and even neurodegenerative conditions like Alzheimer’s disease. This research aims to better understand how blood vessels in the eye and brain detect and respond to surrounding neural activity. Specifically, we will identify key proteins in blood vessel cells that help them sense changes in neural activity and regulate blood flow accordingly. Understanding normal NVC function will reveal how its impairment affects vision and brain health. These findings will help scientists and doctors develop better treatments for vision loss and neurodegenerative diseases.

“Building Myddosomes – Towards a Blueprint for Assembling Innate Immune Signaling Organelles”

Toll-like receptors (TLRs) play a vital role in detecting infections and activating the immune system. They do this by forming myddosomes, protein complexes that process signals to trigger immune responses. This project investigates how myddosomes work within our cells. The central idea is that two distinct types of myddosomes exist: receptor-bound proto-myddosomes and cytosolic myddosomes. I assume the proto-myddosomes exist as building blocks for the cytosolic myddosomes which then sustain immune cell activation for an optimal immune response. I will explore how proto-myddosomes are formed, how they are released, and how they mature into cytosolic myddosomes. Advanced imaging and biochemistry techniques will help me identify the factors that regulate myddosome formation and function. Ultimately, the project aims to understand how myddosomes coordinate and shape the earliest stages of our immune responses, which could lead to better vaccines and treatments for cancer.

“Investigation into the Regulation of Mitochondrial Dynamics, Intra-Organelle Communication, and Metabolic Reprogramming by the PKA-Fusion Oncoprotein”

Fibrolamellar carcinoma (FLC) is a rare and aggressive liver cancer that mainly affects adolescents and young adults, with very few treatment options available. Almost all FLC tumors contain a unique genetic mutation, the DNAJB1-PRKACA fusion, which drives cancer cell growth. My research focuses on understanding how this mutation disrupts key cell functions, particularly affecting mitochondria, which produce energy, and lysosomes, which help break down waste. Using advanced laboratory models that I developed, along with imaging techniques and metabolic studies, I aim to uncover how these changes allow cancer cells to survive and spread. By identifying these weaknesses, my goal is to develop new treatments that specifically target these vulnerabilities. This research could lead to novel therapies for FLC and improve treatment strategies for other cancers with similar metabolic changes.

"Harnessing meningeal immune cell hubs for bioengineering to promote anti-brain tumor immunity"

GBM is an aggressive primary tumor of the central nervous system, with limited available treatment options due to the heterogeneity of tumor cells and their ability to evade the immune response. The meninges are the membrane layers that cover and protect the brain and have recently been identified as important site for immune cell activation in neuroinflammation. The contribution of the dura to an immune response against glioblastoma is still unknown. This project aims at identifying anti-tumor immunity-promoting cell-cell interactions in recently identified immune cell clusters in the meninges using a novel technology called RABID-Seq. We will use this information of relevant cell-cell interactions to 1) reprogram the meninges to induce potent anti-tumor immunity by delivering mRNA-based factors and to 2) use genetic engineering of CAR T cells to improve persistence and anti-tumor efficacy. In summary this innovative approach could potentially guide new avenues for improved immunotherapeutic treatments for glioblastoma.

"Regulation of Dopamine by Cells of the Blood-Brain Barrier"

Dopamine is a chemical messenger that regulates your ability to move, focus and feel pleasure. Your brain generates dopamine using building blocks contained within your diet, which can travel via the blood to the brain. However, cells at the interface between the blood and the brain, collectively referred to as the blood-brain barrier (BBB), act as gatekeepers to control what enters and exits the brain. While building blocks for dopamine can somehow cross the BBB, dopamine itself cannot, meaning that the brain must produce its own dopamine—a role believed to be performed by specialized dopamine nerve cells. My research now suggests that the BBB also plays a crucial role in dopamine synthesis and breakdown. This fellowship will elucidate the mechanism whereby the BBB controls brain dopamine levels to devise novel therapeutic strategies to restore dopamine in a brain condition caused by loss of dopamine nerve cells called Parkinson's disease.

“Investigating the Causes and Consequences of LINE-1 Retrotransposon Activation in Cancers”

A third of our genome is composed of repetitive DNA sequences historically considered ‘junk DNA’. These repeats were derived from the activity of retrotransposons, which are mobile DNA elements that can alter our genome by making new copies of themselves. We have now established that L1, the only active, protein-coding retrotransposon in humans, becomes widely deregulated in cancers. However, our understanding of L1 role in cancer is limited. Here, my research addresses two major gaps. For one, I will characterize the mechanisms that maintain L1 silenced in cells, which will provide insights into the causes of LINE-1 deregulation in cancers. In addition, I will examine the consequences of L1 activation in cells with a focus on investigating the mutagenic consequences of L1. Results will shed light on how L1 may contribute to cancer genome evolution and on our efforts to exploit the intrinsic genotoxicity of L1 as a therapeutic strategy.

“Deciphering the Functional Role of OSR1 in Uterine Receptivity and Embryo Implantation”

We recently identified a loss-of-function mutation in the OSR1 gene in patients with infertility caused by embryo implantation failure and ectopic pregnancy (EP), linked with a thin, hormone-insensitive endometrium. OSR1 protein is present in both human and mouse endometrial tissues. In mice, *Osr1* expression peaks during implantation and in response to estrogen and progesterone. Our findings highlight a pivotal role for OSR1 in embryo implantation and suggest that altered OSR1 levels may contribute to infertility in cases of disrupted endometrial receptivity. This proposal aims to investigate the effects of *Osr1* removal from mouse uterus and to assess OSR1 levels in human endometrial and fallopian tube tissue biopsies from patients with recurrent implantation failure (RIF) and tubal EP, two prevalent but poorly understood conditions. These studies will provide insights into mechanisms of endometrial receptivity and may offer new therapeutic strategies to improve fertility outcomes for patients with RIF and EP.

“Enteric Glia Regulate Appetite and Recovery From Inflammation”

The gastrointestinal tract is unique, as it has its own independent nervous system, the enteric nervous system. A population of enteric glia, the most numerous cell type of the enteric nervous system, are found directly under the single layer of intestinal epithelial cells that separates the food and bacteria in the intestine from the rest of the body. I am interested in understanding how glia alter intestinal epithelial cell function, and thus utilize a mouse model in which we can deplete enteric glia. These mice show appetite suppression due to increased release of appetite

suppressing hormones from chemical sensing cells in the epithelium, and they recover more slowly from acute injury to the intestinal epithelium. This project aims to understand if supplementing these mice with certain proteins that are normally produced by enteric glia can fix appetite suppression or wound healing, with direct relevance to a variety of human diseases.

“Experience-dependent neuropeptide modulation of synaptic plasticity”

Our everyday experiences shape who we are and contribute to the modification of the brain’s neuronal circuits, which are essential for learning, memory, and behavior. Neuronal circuits maintain a stable balance between excitation and inhibition and can communicate through neuropeptides. In this research proposal, I will focus on the neuropeptide precursor gene *Scg2* which plays a role in regulating neuronal circuit function in the mouse hippocampus, a brain region involved in learning and memory. My experiments suggest that *Scg2* is essential for recalling memories. I will investigate how *Scg2*-derived neuropeptides contribute to brain function and the molecular mechanisms required for the intricate balance of neuronal circuit adaptation upon learning. This research could lead to better treatments for disorders in which this excitation-inhibition balance is disrupted, such as autism and schizophrenia, offering potential new strategies for therapy.

“Unraveling the mechanisms driving transmission of malaria sporozoites from mosquitoes to humans”

Malaria is a life-threatening disease that affects millions of people every year, with young children in Africa suffering the most. It spreads when an infected mosquito bites a person, injecting malaria parasites from its salivary glands. These parasites then enter the bloodstream and infect human liver cells. To invade these tissues, the parasites use specialized compartments called rhoptries, which release invasion proteins. However, we still do not fully understand how rhoptries form or what controls their development. My research will identify the regulators that control rhoptry formation and determine their roles in helping parasites invade salivary glands and human liver cells. Using advanced genetic tools and microscopic imaging techniques, I aim to uncover how these parasites prepare for infection. By uncovering this process, my research could reveal new ways to stop malaria before it even reaches humans – paving the way for better prevention strategies and saving lives.

“Unraveling the mechanisms driving transmission of malaria sporozoites from mosquitoes to humans”

Mosquitoes are the world's deadliest animals, spreading diseases like malaria, dengue, Zika, and yellow fever. To find humans, mosquitoes detect our scent using special proteins called olfactory receptors (ORs). These tiny sensors help mosquitoes pick up odor molecules emitted by humans, guiding them to bite. Our research aims to understand exactly how these smell receptors work. We will study how ORs work at the atomic level, determining how they bind and respond to odor molecules and common mosquito repellents like DEET. To do this, we will use advanced imaging techniques to create detailed "movies" of how these receptors move and change when they detect smells. By understanding how ORs function, we hope to enable the design of new, safer mosquito repellents. This work could lead to better ways to prevent mosquito bites and reduce the spread of dangerous diseases, helping to save lives worldwide.

“Mapping the Fate of Fibroblasts Across the Inflamed and Healing Gut”

Fibroblasts have recently emerged as unexpected central players in pathological conditions ranging from fibrosis, to cancer, and inflammatory bowel diseases. In these contexts, fibroblasts become activated and, beyond maintaining the extracellular matrix, orchestrate the immune response, promoting the resolution of inflammation, and favoring tissue regeneration. However, much remains unknown about the full diversity of these activated states—often referred to as inflammation-associated fibroblasts (IAFs)—across inflammation and repair, their interactions with other cell types, and the extent to which these fibroblasts retain memory of the insult. In my postdoctoral work, I shed light on some of these questions by utilizing spatial transcriptomics to characterize their response within the gastrointestinal tract (GI) of a colitis mouse model. This investigation revealed multiple IAF states with unique gene expression profiles and spatial distributions, highlighting their significant role in orchestrating the immune response within highly inflamed areas. While my study unveiled an unprecedented diversity of IAFs during the acute response, questions remain regarding how each IAF depolarizes and contributes to tissue repair, as well as how IAFs retain memory of prior insults. Similarly, it is not yet fully understood whether the nature of damage (chronic versus acute) affects the state and functions of these activated fibroblasts. The central focus of this fellowship is to address these questions by building a comprehensive atlas of fibroblasts and IAF states and their evolution across different stages of the inflammatory response in the gut. This new body of work aims to unravel how these IAFs depolarize and contribute to inflammation resolution and tissue repair (Aim 1A), whether these cells retain any long-term form of memory that can shape an altered immune response (Aim 1B) and if the fate and reprogrammed state of healthy fibroblasts depends on the nature and pacing of the insult (Aim 2).

“Molecular Mechanisms Governing Myelin Development in the Mammalian Neocortex”

Myelin is a distinctive feature of the vertebrate central nervous system (CNS) which has allowed the expansion of the brain and the emergence of complex behaviors. Myelination defects contribute to several debilitating neurological disorders. During CNS development, oligodendrocytes wrap their membrane around axons to create an insulating, lipid-rich structure called the myelin sheath. Myelin density varies greatly across the CNS, and the degree and positioning of axonal myelination varies with the class identity of the myelinated neurons. Cortical myelination follows a gradient distribution, conserved between mice and humans. Deep-layer projection neurons (PNs) are uniformly extensively myelinated, while upper-layer

PNs have more diverse patterns and are more sparsely myelinated. Despite these differences, it is unknown how oligodendrocytes select their myelination targets. Deciphering the mechanisms underlying selective myelination across mammals is fundamental to understand not only the principles driving myelin development but also its regeneration in pathological states. Here, I aim to elucidate the mechanisms that control oligodendrocyte proliferation, maturation, and target selection in the mammalian neocortex. I hypothesize that specialized interactions between PNs and oligodendrocytes may regulate those processes. Furthermore, I propose that neurons express “attractive” or “repulsive” signals along their axons, which control local interactions with oligodendrocytes, ultimately guiding myelin distribution. To address this, I will: 1) Investigate neuronal cues that regulate oligodendrocyte proliferation and maturation; 2) Identify the axonal molecular signals that control intermittent myelination; 3) Leverage human brain organoids to investigate conserved roles of the here identified molecules in humans. This work will generate mechanistic data and deeper knowledge of how neurons and oligodendrocytes interact to achieve developmental myelination in mouse and human, pioneering understanding of a process that is virtually unexplored in the mammalian cerebral cortex. These results will inform future studies to determine the potential of the identified molecules as therapeutic targets in myelin-related disorders.

“Dissecting the Cellular Hierarchies within Embryonal Tumors with Multilayered Rosettes”

Embryonal Tumors with Multilayered Rosettes (ETMRs) are pediatric brain tumors with a nearly ubiquitous fatal outcome. Poor outcome is mainly attributed to incomplete therapy response and a lack of targeted therapeutic options. Favorable outcome is currently difficult to predict, however differentiation status has been correlated with improved overall survival. The reason for this remains unknown because of an incomplete understanding of the distinct cell populations that underlie the disease. My first aim is to characterize the cellular hierarchies to identify differentiation processes that could be therapeutically targeted. I will do so by generating scRNA-seq data for 16 ETMRs, five of which will have matching scATAC-seq from the same cells. Based on preliminary data two molecularly distinct populations that resemble the unique histology of the tumor can be identified using scRNA-seq. These populations will be used to identify the most likely cell of origin by mapping each individual population on a reference of fetal developing brain. Afterwards, the transition in transcriptional networks from the most primitive population to the differentiated population will be identified to discern altered developmental pathways in ETMR. Finally, I will infer potential cell-cell communication involved in differentiation processes by integrating expression patterns of receptors, ligands and downstream transcription factor activity. My second aim is to validate whether each cell population can re-form a tumor or whether a cellular niche is necessary to sustain the tumor. I will sort out each population using FACS and inject those populations separately or combined into mice and characterize the possible outgrowth using scRNA sequencing and histology. Comparing each outgrowth will identify cell populations that can re-form the tumor hierarchies and whether the presence of other populations is necessary. Together these aims will identify

what processes could be targeted and which cell populations to target within ETMRs to treat this deadly disease.

“The Role of Histone Cleavage in Breast Cancer”

Perturbed epigenetic programs play key roles in tumorigenesis and epigenetic regulators are commonly mutated in cancer. The KDM4C histone demethylase is amplified and overexpressed in a subset of triple-negative breast cancer (TNBC), a tumor subtype with high propensity to treatment resistance and distant metastasis. KDM4C demethylates histone H3 lysine 9 tri-methyl (H3K9me3) and lysine 36 tri-methyl (H3K36me3), but whether this activity is required for its tumorigenic function is not known. KDM4C is frequently co-amplified with JAK2, CD274 (PD-L1) and PDCD1LG2 (PD-L2). Deciphering mechanisms by which KDM4C drives tumor growth will further our understanding of the role of mutant epigenetic regulators in cancer and pave the way for treatment strategies targeting KDM4C-dependent tumors. I will test the hypothesis that KDM4C drives tumor growth by preventing the proteolytic cleavage of the N-terminal tail of histone H3 by cathepsin L (CTSL) (Aim 1). This hypothesis is based on my preliminary data demonstrating growth inhibition, activation of CTSL, and N-terminal clipping of histone H3 after genetic or pharmacologic blockade of KDM4C in KDM4C-amplified breast cancer cell lines. I will generate and characterize KDM4C-dependent and independent cell models expressing N-terminal truncated or CTSL-cleavage-resistant histone H3. I will also investigate whether KDM4C modulates CTSL activity via acting on it directly as its non-histone substrate or indirectly through modulating H3K9me3 and H3K36me3 (Aim 2). Lastly, I will explore potential associations of H3 clipping with clinicopathologic and immune features in TNBC patient samples using multiplexed imaging like the CODEX system (Aim 3). In summary, this proposal aims to leverage innovative models and state-of-the-art genomic profiling to provide a deeper understanding of the role of histone clipping in breast cancer, ultimately improving therapeutic outcomes for these patients.

“Characterization of the Pathogenic Mechanisms of Cancer Cachexia using *Drosophila* as a Model”

A primary cause of death in cancer patients is cachexia, a wasting syndrome attributed to tumor-induced metabolic dysregulation. Despite the major impact of cachexia on the treatment, quality of life, and survival of cancer patients, relatively little is known about the underlying pathogenic mechanisms. As cancer cachexia is a multi-organ syndrome, investigating its pathogenesis requires understanding of how tumors remotely induce dysfunction in host organs. Despite recent advances, characterization of this whole-body syndrome has been hindered by the inability to study the organism as a whole. To address this, I performed body-wide single nuclei RNA sequencing (snRNAseq) of flies with *ykiact* tumors (*esg*>*ykiact*; referred to as *Yki* flies), a

commonly used *Drosophila* cancer cachexia model. This approach provides a comprehensive dataset to investigate tumor-host organ communication and tumor-induced metabolism dysregulation in cancer cachexia, and led me to discover that Upd3/IL-6/JAK-STAT signaling induces hepatic gluconeogenesis in the context of cachexia. In addition, this body-wide transcriptome analysis revealed an interesting misexpression of ligands of signaling pathways such as TGF- β signaling and a heterogeneity in metabolic responses to the tumor among host tissues. I propose to build on these preliminary observations and will: 1) Address the cachectic role of aberrant TGF- β signaling. I will set up combined snRNA-seq and snATAC-seq, thereby applying a multi-omics approach to systemically investigate the origin and body-wide effects of dysregulated signaling in this model, with identification of tissue-specific gene misexpression. 2) Elucidate tumor-induced metabolic dysregulation in host tissues. I will elucidate tumor-induced metabolic dysregulation in each tissue through metabolic analyses including metabolomics, lipidomics, and isotope tracing of flux. This will shed light on the origin, progression, and outcome of tumor-induced metabolic dysregulation. Altogether, findings from my proposal will provide new understanding of the pathogenesis of cancer cachexia and may pave the way to novel therapeutic strategies.

“Structural Mechanism of the Rolling Adhesion Activity of Integrins $\alpha 4\beta 1$ and $\alpha 4\beta 7$ ”

Integrins are heterodimeric cell surface receptors composed of α and β subunits that play essential roles in cell adhesion and migration. The integrin subunit $\alpha 4$ can pair with either $\beta 1$ or $\beta 7$ subunits. Whereas most integrins mediate firm adhesion, Integrins $\alpha 4\beta 1$ and $\alpha 4\beta 7$ are unique in their ability to mediate both cell rolling and firm adhesion during the lymphocyte extravasation cascade. How $\alpha 4\beta 1$ and $\alpha 4\beta 7$ mediate both rolling and firm adhesion remains unanswered. The primary ligand for $\alpha 4\beta 7$ is the mucosal addressin cell adhesion molecule- (MAdCAM) and one of the primary ligands of $\alpha 4\beta 1$ is the vascular cell adhesion molecule (VCAM). Interaction of $\alpha 4\beta 7$ with its ligand promotes homing of gut-associated lymphocytes to the gastrointestinal tract and inflammatory sites. Antibodies and small molecules blocking the $\alpha 4\beta 7$ -MAdCAM interaction attenuate inflammation making $\alpha 4\beta 7$ a relevant target in the treatment of multiple sclerosis, inflammatory bowel diseases, and some types of cancer, such as multiple myeloma. $\alpha 4\beta 7$ and $\alpha 4\beta 1$, like most integrins, equilibrate between three overall conformational states: the low affinity bent-closed (BC) and extended-closed (EC) conformations and the high affinity extended-open (EO) conformations. Although several structures of $\alpha 4\beta 7$ in complex with Fabs have been reported, the high-resolution molecular architecture of the $\alpha 4\beta 7$ -MAdCAM complex remains unsolved and there is no structural information on $\alpha 4\beta 1$ -VCAM complexes. This project aims to elucidate the structural assembly of $\alpha 4\beta 7$ -MAdCAM and $\alpha 4\beta 1$ -VCAM using cryogenic electron microscopy (Cryo-EM) and to unveil the energy landscape of $\alpha 4\beta 7$ using equilibrium binding measurements. The core findings of this project will allow us to better understand how $\alpha 4\beta 1$ and $\alpha 4\beta 7$ mediate cell rolling and firm adhesion and accelerate the discovery and further improvement of therapeutics for multiple myeloma and inflammatory bowel diseases.

“Mechanism and Viral Subversion of a Novel Antiviral Enzyme”

The mechanisms that bacteria use as immunity against their viruses, and how those viruses counter those immune mechanisms is not well understood. Understanding this basic interplay has implications for the adoption and use of these bacteriophages to improve human health. Like antibiotic resistance, a critical aspect of developing phage-derived antimicrobials will be anticipating phage resistance and actively engineering phage to overcome this resistance. In the initial stage of my postdoc, I discovered and characterized 21 previously unknown anti-phage defense systems which are conserved in bacterial pathogens. Here, I narrow my focus to extend our understanding of one of these, called CmdTAC. CmdTAC uses a novel toxic protein to ADP-ribosylate mRNA to inhibit viral translation. This enzymatic activity has not been studied before but is potentially conserved in Eukaryotes. Preliminary data show that CmdT modifies the N6 position of adenosine at 5'-GA-3 sites in mRNA. Although I have begun to elucidate the mechanism of action of the CmdTAC anti-phage system, major questions remain about how it blocks phage development and about how phages might evade this system. First, I propose to solve a crystal structure of CmdT in complex with RNA and investigate the molecular details of how ADP-ribosylated mRNA blocks translation. Second, I have discovered a small phage-encoded protein that allows viruses to circumvent CmdTAC immunity. Remarkably, its structure is similar to a previously known counter-defense to an unrelated anti-phage defense system. The existence of a broad-spectrum counter defense is of great interest to engineer into therapeutic phages. I propose a set of experiments to explore how this counter-defense functions, building a foundation for my future research to understand anti-viral mechanisms and how this particular family of counter defense proteins can overcome multiple anti-phage defense systems.

“Influence of Cortical Dopamine on the Structure of Natural Behavior”

The prefrontal cortex (PFC) is a major target of dopamine signaling in mammals, and alterations in cortical dopamine are thought to drive many psychiatric disorders, from schizophrenia to depression and attention deficit hyperactivity disorder (ADHD). Yet the functional role of these projections remains poorly understood. In particular, it has been difficult to establish a clear connection between laboratory studies of cortical dopamine and its role in human disease – in part because almost all research on PFC relies on stripped-down cognitive tasks in which human or animal subjects are immobilized, instructed in the task rules, and then prompted for simple responses across hundreds to thousands of trials.

We propose to bridge this gap by investigating how dopamine influences behavior under naturalistic conditions. Using a newly-developed method called keypoint-MoSeq, we will capture 3D body movements as mice explore a complex environment, and then parse these movements

into a detailed inventory of actions – the turns, digs, bites and rears that mice use to probe and manipulate the environment around them. These behavior measurements will be combined with neural recording and perturbation experiments that test three interrelated hypotheses that are based on past literature and our own preliminary data. First, we hypothesize that encounters with salient or novel stimuli in the environment will trigger dopamine release in PFC and propose to test this using optical dopamine sensors in conjunction with behavioral recording. Second, we will perform real-time stimulation experiments, using behavior-triggered optogenetic activation of dopaminergic axons to test the hypothesis that cortical dopamine serves to intensify and prolong interaction with environmental affordances. Finally, we will combine these experiments with dense recordings of neural activity in PFC (using fluorescent calcium sensors) to understand the mechanistic basis for dopamine's influence on behavior.

“Connecting Development and Physiology to Understand the Evolution of Novel Traits”

How novel traits originate and diversify is a critical and unresolved question in biology. The relative paucity of suitable research models is a major factor impeding progress in this field. An ideal model organism in which to study this question would possess a unique, major trait that exhibits diversity among related species resulting in a range of discrete functional and behavioral phenotypes. One remarkable example of a unique, major novel trait is the ‘leg’-like sensory appendages unique to the family of fishes known as sea robins (Triglidae). Closely-related sea robin species use their legs to facilitate dramatically distinct predation strategies, including a restricted lineage of specialists which have the remarkable ability to locate and uncover prey items buried in sand using specialized legs with enhanced sensory properties. Evolutionarily related but physiologically distinct sea robin lineages therefore represent a powerful model system that overcomes previous limitations in the field. The goal of this proposal is to elucidate the molecules, cells, and developmental programs that have transformed the ancestral pectoral fin rays into specialized sensory appendages and delineate the basis for enhanced sensitivity in digging sea robins. First, we compare the biophysical properties of sensory receptors from digging and non-digging sea robins using electrophysiology and genetic approaches (Aim 1). Next, the developmental basis for sensory leg evolution and specialization will be explored through use of transcriptional profiling, experimental genetics, and comparative approaches (Aim 2). This foundational work will establish sea robins as a model organism to study the evolution and development of specialized cells and tissues, and how evolution of novel traits can drive new physiology and behavior. Thus, these studies provide a platform to advance understanding of fundamental biological processes relevant to diseases involving cell and tissue physiology, pathophysiological adaptation and developmental or sensory processing disorders.

“Mechanisms of predisposition to multifocal lung cancer by germline EGFR mutations”

10% of Non-Small Cell Lung Cancer (NSCLC) patients present with multifocal lung cancer (MLC), the synchronous observation of multiple lung tumors. The biological mechanisms leading to the development of MLC are uncertain and clinicians have few clear guidelines for treatment. This is particularly true for a category of patients who have EGFR-mutant MLC. EGFR is a common NSCLC driver gene, with canonical oncogenic mutations accounting for 15% of all NSCLC. EGFR-mutant NSCLC is more common in people of Asian ancestry, suggesting a genetic susceptibility. In a recent project, I identified a new genetic mechanism for development of MLC in a cohort of 10 EGFR-mutant MLC patients. In some patients, I hypothesize that germline EGFR mutations have modest effects on EGFR function but predispose NSCLC development.

Aim I: To characterize the molecular effects of germline EGFR mutations on EGFR function. I observed that the germline EGFR mutations produce modestly hyperactive EGFR protein. To understand what causes this hyperactivity, I will use non-cancerous Human Bronchial Epithelial Cells (HBEC) to evaluate dimerization, internalization, and degradation.

Aim II: To determine how germline EGFR mutations predispose cancer. I observed that all tumors with germline EGFR mutations had developed additional canonical EGFR mutations. To interrogate how the germline EGFR mutations promote and/or combine with the canonical mutations to increase cancer development, I will evaluate oncogenic transformation of HBEC by the single and compound mutations and measure the rate of acquiring canonical mutations in a WT and mutant background using a biosensor.

This work will shift treatment decisions for these patients to include lung-sparing surgery, subsequent monitoring, and EGFR-targeted prophylaxis because these patients are at higher risk of developing additional tumors due to their germline predisposition.

“Delineating the Role of BMP9/ACVRL1 and Notch Signaling to Promote Human Stem Cell-Derived Endothelial Cell Transplantation into the Injured Lung Vasculature”

Pulmonary vascular disorders reflect a broad disease spectrum associated with high morbidity and mortality with limited treatment options. Endothelial cell dysfunction is a key contributor to pulmonary vascular disease and endothelial cell replacement therapy represents a promising approach towards definitive treatments, especially in the context of genetic forms of these disorders. Human induced pluripotent stem cells (hiPSCs) hold enormous potential for autologous cell-based therapies to replace diseased endothelial cells through ex-vivo CRISPR/CAS9-mediated correction of pathogenic variants prior to endothelial cell differentiation and transplantation. This approach would provide a limitless supply of healthy endothelial cells for transplantation without the need for lifelong immunosuppression; however, the feasibility of hiPSC-derived endothelial cell (iEndo) transplantation has not been demonstrated.

One key question with respect to endothelial cell-based therapies is whether iEndos require pre-patterning towards the target organ's transcriptional profile. Herein, I present my preliminary data demonstrating successful transplantation of iEndos into the mouse microvasculature following hyperoxia-associated acute lung injury. Intriguingly, the success of these studies requires pre-patterning of iEndos with BMP9 prior to transplantation, which induces the lung-specific endothelial cell marker TMEM100 in cooperation with active Notch signaling.

This proposal will test the hypothesis that BMP9/ACVRL1 and Notch signaling cooperate to induce TMEM100 expression and promote iEndo transplantation into the lung microvasculature. In aim 1, I will assess the differentiation potential, longevity, and function of iEndos transplanted into the mouse lung microvasculature. In aim 2, I will interrogate the mechanism of BMP9/ACVRL1 and Notch signaling cooperativity to promote iEndo transplantation in addition to

the functional role TMEM100 in this process. Overall, these aims will provide an essential foundation to realizing the therapeutic potential of autologous endothelial cell replacement therapies to treat pulmonary vascular disease.

“Decoding Ubiquitin Signals for Ciliary GPCR Trafficking”

Cilia are specialized cellular structures that serve as signaling hubs for many G-protein coupled receptors (GPCRs). These ciliary GPCRs function in important olfactory, visual, and developmental signaling pathways. Dysfunctional cilia or mislocalization of ciliary GPCRs can cause severe diseases, called ciliopathies, with shared clinical features like blindness, obesity and cognitive impairment. Therefore, the spatial and temporal regulation of receptors within cilia is essential for proper signaling outcomes. Receptors are removed from cilia by an active transport process triggered by ubiquitylation. However, how these ubiquitylated cargos are specifically recognized and linked to the transport machinery remains unknown. This project aims to address this gap in our understanding by identifying and characterizing the factors involved in ciliary trafficking of ubiquitylated GPCRs. The main aims are: 1) to identify ubiquitin-binding proteins that function as cargo adapters during GPCR ciliary trafficking, and 2) to obtain structural information about the interactions between ubiquitylated GPCRs and components of the ciliary trafficking machinery. To achieve Aim 1, I plan to use quantitative mass spectrometry to a) identify proteins that associate with immobilized, in vitro assembled ubiquitin chains in pulldown experiments in ciliary lysates from different organisms, and b) analyze products of ubiquitylation-dependent proximity labeling in cilia to identify evolutionarily conserved adapters. To achieve Aim 2, I will reconstitute trafficking complexes using in vitro ubiquitylated model cargo GPCR or free ubiquitin chains for structural analysis by cryo-electron microscopy (cryo-EM). Structural characterization of these interactions will provide mechanistic details on how ubiquitylated GPCRs engage with the ciliary transport machinery. The outcome of this project will significantly advance our understanding of fundamental ciliary trafficking mechanisms and GPCR signaling. By uncovering the factors involved in the recognition and transport of ubiquitylated cargos, we can shed light on the causes of ciliopathies and open new avenues for therapeutic intervention.

“Revealing Determinants of LINE-1 Retrotransposition Outcomes”

Half of the human genome is derived from the activity of Long Interspersed Nuclear Elements-1 (L1). L1 is an active protein-coding transposon in the human genome, which can ‘copy-and-paste’ itself to generate de novo genomic insertions using an RNA intermediate; this process is called retrotransposition. Insertional mutagenesis caused by L1 has been identified in 124 genetic diseases, and somatic L1 activity is a hallmark of many cancers. Recent studies suggested that L1 retrotransposition may be a common source of chromosomal instability (CIN) in cancer

genome.

We propose to test the hypothesis that cellular factors determine the 'outcome' of an L1 insertion attempt. Our working model is that L1 retrotransposition intermediates could result in:

- i.) DNA repair with no insertion
- ii.) A Canonical insertion with 6kb and target-site duplication of varied length
- iii.) A variant insertion (i.e., 5' truncated/ 5' inversion/ 3' transduced L1)
- iv.) An endonuclease-independent insertion
- v.) A double-stranded DNA (dsDNA) break, leading to a target site deletion
- vi.) A dsDNA break, leading to a chromosomal translocation

Significant technical barriers in sequencing have limited our understanding of these potential outcomes. Sequencing L1 insertions is challenging as their lengths can range from a few nucleotides to >6kb and their repetitive nature. Similarly, we have had no way to perturb cells and characterize different outcomes of retrotransposition at scale. Thus, we have little data on the frequency of these outcomes in cells and what host factors influence these outcomes. To address these technical and knowledge gaps, I propose these aims.

- 1.) Fully characterize de novo L1 insertion sequences and insertion rates in human cell lines by a novel long-read sequencing approach.
- 2.) Discover DNA repair factors that determine L1 retrotransposition outcomes by an insertion-outcome-based CRISPR-mediated forward genetic screening.

Collectively, these will illuminate mechanisms of mutagenesis and CIN in cancer.

“Sympathetic Control of Adipose Tissue Function by Non-adrenergic Mechanisms”

Adipose lipolysis, an enzyme-catalyzed process converting triglycerides into glycerol and free fatty acids, provides a major source of energy during fasting. Our preliminary studies have identified oxytocin (OXT) as a physiological driver of lipolysis. Although OXT itself is a weak inducer of lipolysis, it licenses β -adrenergic-mediated lipolysis; in the absence of OXT signaling, β -agonists are unable to fully promote triglyceride breakdown. Furthermore, our data reveal that the relevant source of adipose OXT is a previously unidentified subset of sympathetic neurons. In this proposal, I will address the mechanism by which OXT regulates lipolysis (Aim 1). To fulfill this aim, I will utilize genetic, pharmacological, and phosphoproteomic approaches to identify the specific β -adrenergic receptor (β -AR) and lipolytic modulators mediating the OXT- β -adrenergic signaling crosstalk. I will also perform co-immunoprecipitation to seek evidence for OXTR- β -AR physical interaction in adipocytes. In Aim 2, I will expand this study to characterize the role of IRAP, an oxytocinase highly expressed in adipocytes, in adipose metabolism. To do this, I will knockdown IRAP using AAV-delivered shRNA, and evaluate the effect of IRAP on the pro-lipolytic action of OXT and the anti-lipolytic action of insulin. I will also assess the role of IRAP in lipolysis by generating adipocyte-specific Irap knockout mice. This proposal will deepen our understanding of the physiological role of OXT, provide insight into OXT-based therapy for psychiatric, obstetric and metabolic disorders.

“Deciphering Mechanisms of Misfolded Protein Targeting by ERAD”

Misfolded proteins in the endoplasmic reticulum (ER) are retro-translocated into the cytosol and degraded by the ubiquitin-proteasome system, a pathway termed ER-associated degradation (ERAD). ERAD plays important roles in the degradation of endogenous proteins and in many diseases in which mutant proteins are misfolded. Misfolded proteins in the lumen are handled by the ubiquitin ligase Hrd1. I previously used disulfide crosslinking to map the path of a substrate through the Hrd1 complex during ERAD-L (ERAD of luminal proteins). My results and available cryo-EM structures suggest that substrates traverse from lumen to cytosol through a thinned membrane region near the lateral gate of Hrd1, rather than through a conventional pore. However, as the structures lack substrate it remains unclear how exactly Hrd1 selects and translocates substrates to the cytosol.

Hrd1 can also handle membrane-embedded substrates – a process called ERAD-M. Current models for ERAD-M predict that the membrane-spanning substrate enters the lateral gate of Hrd1, and ubiquitination then occurs on suitable substrate residues exposed to cytosol. But how Hrd1 recognizes substrates inside the membrane is not well understood.

Here, I will test the hypothesis that Hrd1 uses the thinned membrane region to recognize ERAD-M substrates. This model would explain how Hrd1 selects a broad range of substrates that contain diverse polar as well as positively and negatively charged residues in transmembrane segments. Specifically, I will 1) clarify how Hrd1 recognizes membrane-spanning substrates by using a novel fluorescent protein-based reporter with idealized transmembrane segments that I designed to monitor ERAD in living cells. In aim 2) I will determine how luminal substrates cross the ER membrane by visualizing purified Hrd1 complex with bound substrate using cryo-EM.

These results will clarify important biological questions, including how proteins cross a membrane, a particular mystery for misfolded polypeptides in the case of ERAD.

“Role of Mitochondrial Metabolite Flux in Cancer”

The breakdown of mitochondrial function precedes the development and exacerbation of several diseases including cancer, cardiovascular disease, neurodegenerative diseases, and type 2 diabetes. A highly regulated aspect of mitochondrial function that remains poorly understood is metabolite flux across the inner mitochondrial membrane (IMM). The IMM is impermeable and requires specific carrier proteins to allow flux of metabolites to cross the IMM. There remain several annotated mitochondrial carrier proteins that are functionally uncharacterized. The goal of this project is to elucidate an uncharacterized mitochondrial IMM metabolite flux that regulates cancer cell viability. To accomplish this, the proposal utilizes molecular and physiologic strategies coupled with mass spectrometry techniques to systematically determine mitochondrial metabolite flux in cancer. There are two independent, yet complementary aims for this proposal. First, I aim to determine whether tumor viability is dependent on the identified

uncharacterized mitochondrial carrier protein. To address this aim I employ an inducible knockout in a chemo-resistant ovarian cancer (SKOV3) xenograft model to determine tumor dependence in vivo, and I utilize 3-D culture organoid models to systematically elucidate activated cell death pathways. Second, I aim to determine the mechanistic role of the uncharacterized mitochondrial carrier in cancer mitochondria. To address the second aim, I use stable-labeled metabolite tracing of target candidates with rapid immunoprecipitation of mitochondria to identify regulation of mitochondrial metabolite flux. Additionally, I propose to determine target metabolite binding through a thermal-shift assay. These strategies will identify the necessity of the identified mitochondrial metabolite flux in cancer tumor survival and the mechanism of action. The discoveries from this proposal will provide new chemotherapeutic targets with the potential to improve treatment of human cancers.

“Epigenetic Crosstalk: Chemoenzymatic Methods for Profiling Regulation of Histone Modifications”

This proposal develops and applies chemoenzymatic methods to unravel molecular details of epigenetic repression and heterochromatin formation. Cellular chromatin consists of DNA packaged with histones in both open states, euchromatin, and compacted states, heterochromatin, which influence gene expression. The basic unit of chromatin is the nucleosome, comprised of a histone octamer with two copies each of histones H2A, H2B, H3, and H4, wrapped by ~147 bp of DNA. The dynamic changes between euchromatin and heterochromatin states are in part governed by histone H3 tail modifications including Lys methylation, acetylation, and ubiquitylation, as well as DNA methylation of CpG islands. Individual modifications of histone H3 have documented associations with either heterochromatin or euchromatin, but most cellular histone H3 has multiple modifications, the combinatorial significance of which is poorly understood. In this proposal, we apply a recently engineered form of the sortase transpeptidase enzyme to assess histone modification patterns and how they arise. We apply sortase to isolate and isotopically barcode histone H3 tails from cells. Mass spectrometry allows quantification of these barcodes and thus of changes in patterns of histone modifications across cell states, following drug treatments, and between heterochromatin and euchromatin. The patterns we identify guide biochemical analysis of how concurrent modifications of an H3 molecule modulate the activity of interacting epigenetic enzymes. Through a combination of enzymological, biophysical, cellular, and cryo-EM analyses we will elucidate mechanisms of heterochromatin maintenance enzymes DNMT1 and UHRF1. Through this research program, we will provide important new insights into the interplay of histone modifications and how epigenetic enzymes regulate chromatin function. These studies can pave the way to new biomarkers and strategies for therapeutic development for a range of epigenetic diseases including cancer.

“The Role of Genetic and Epigenetic Variation in the Progression of IDH Mutant Gliomas”

Cancers evolve through an iterative process of genetic diversification, clonal expansion, and selection. During this process, many stochastic events are inconsequential "passengers", but some will confer a fitness advantage and be selected as "drivers". Diverse driver events yield a heterogeneous tumor wherein genetic subclones, and epigenetic cell states acquire various fitness advantages. However, the mechanistic relationships between the genetic changes and the alternate epigenetic cell states that arise during tumor progression are unclear. I have applied single-cell transcriptomics and epigenomics to investigate epigenetic cell states in malignant brain tumor cells and normal developing neural cells. My preliminary data indicates that cell states in tumors can be shaped by genetic variation and exhibit a degree of epigenetic plasticity that is not evident in normal brain cell lineages. I will investigate this biology using IDH mutant gliomas as a model. My first aim will examine the role of MYCN amplification in switching cell states during the progression of IDH mutant gliomas. My second aim will examine the effect of the DNA hypomethylating agent on promoting differentiated cell states in IDH mutant gliomas. I will use single-cell genomic tools and a newly developed computational pipeline to characterize cell identities, genetic states, and epigenetic states. I will examine the mechanisms underlying cell state switching using our newly established human glioma organoid system and glioma cell lines. My study will 1) reveal the tumor progression at the single-cell level with epigenetic characterization and 2) identify the genetic and epigenetic factors that can switch the cell states and provide novel therapeutic targets.

“Development of CRISPR-based Genetic Cures for Spinal Muscular Atrophy”

Spinal muscular atrophy (SMA) remains the leading genetic cause of infantile death worldwide. Therapies that target the Survival Motor Neuron 2 (SMN2) gene with an antisense oligonucleotide or a small molecule that promotes transient increases of full-length SMN protein have led to notable results in SMA patients. However, despite this progress, there remains no permanent cure for SMA. In the present study, I propose to develop strategies to permanently edit the SMN2 gene through a one-time CRISPR-based genetic treatment. My specific aims are 1) to optimize base editors to target and disrupt intronic splicing silencer binding sites in the SMN2 gene and 2) to develop an efficient delivery approach for these CRISPR-based technologies. I have been engineering novel genome editing technologies in the Kleinstiver laboratory at Massachusetts General Hospital that now permits precise editing of SMN2. These cutting-edge genome editing approaches restore SMN2 expression in human patient-derived SMA-fibroblasts, producing more full-length SMN mRNA transcripts and higher SMN protein levels when compared to unedited SMA- fibroblast control samples. During the Charles A. King Trust Fellowship, I will extend this work by optimizing these base editor technologies and by developing the best strategy to deliver these base editors in an SMA mouse model. Success of this proposal will have a profound impact on the neuromuscular community by providing proof-of-concept data demonstrating the use of CRISPR technologies as a future treatment and potential cure for SMA. The Charles A. King Trust Fellowship would support this high-impact research program while I am finishing my training and initiate my search for an independent faculty position. In the long term, I intend to pursue novel inter-disciplinary approaches for the benefit of human health, with a particular interest in genome editing therapies for muscle and neuromuscular diseases.

“A Cholesterol Byproduct Imprints Kidney Immuno-metabolism in Health and Disease.”

Nephrons are the functional site of the kidneys and act as selective filters of the blood for toxic metabolic waste products. In nephrons, the process of blood filtration takes place in anatomical structures named glomeruli.

Alteration of the glomeruli metabolism and immunity causes kidney dysfunctionality, a condition named glomerulonephritis. However, the molecular mechanism of glomerulonephritis remains poorly understood.

This grant is based on our discovery that oxysterol 25 hydroxycholesterol (25-HC), a cholesterol metabolite with metabolic and immune regulatory functions, is required to preserve glomeruli

integrity: deficiency of 25-HC caused loss of podocytes and increased protein levels in urines. This is the first time that oxysterols' production and function will be investigated in kidneys.

We hypothesize that both dietary cholesterol and gut-derived microbial stimuli induce 25-HC production in glomeruli. Ch25h, the enzyme catalyzing the production of 25-HC, is expressed by glomerular blood endothelial cells. Thus, we will use a novel mouse line lacking Ch25h in endothelial cells (named ECΔCh25h) to identify the metabolic and cellular effect on kidney resident cells. Since podocytes are essential for the renal filtration, one of the renal functions altered in glomerulonephritis, we will determine the role of oxysterol sensing on podocytes' metabolism and integrity.

We also observed that glomerulonephritis caused by 25-HC deficiency was associated with IgA accumulation in glomeruli, a pathological condition known as IgA nephropathy. To date, the molecular mechanism of IgA nephropathy remains poorly understood. Therefore, we will investigate the role of endothelial-derived 25-HC in controlling IgA-producing plasma cell homing and effector function in kidneys during inflammation.

Overall, this project will help to advance our understanding of glomerulonephritis development and to identify oxysterol regulation as new molecular target for the prevention and treatment of IgA nephropathy.

“Targeting The Phosphorylation Of Bcl-2 Family Members In Venetoclax-resistant Lymphoid Malignancies”

Apoptotic resistance is a cancer hallmark, and Bcl-2-family protein dysfunction is an important mediator of such resistance in hematologic malignancies. Venetoclax (VEN), a BH3-mimetic that selectively targets the anti-apoptotic protein Bcl-2, is FDA-approved for treatment of chronic lymphocytic leukemia, with clinical trials underway in other lymphoid malignancies. Despite the clinical efficacy of VEN-monotherapy, complete-remission rate and progression-free survival are limited, leading to the urgent need to identify resistance mechanisms and novel therapeutic approaches to overcome them. Increase in Bcl-2-phosphorylation (Bcl-2-P) and the related anti-apoptotic protein Mcl-1 have been implicated in VEN-resistance. Increased Bcl-2-P not only enhances the anti-apoptotic function of Bcl-2, but also impedes the ability of VEN to bind and inhibit Bcl-2. Similarly, increased Mcl-1-phosphorylation (Mcl-1-P), which stabilizes its protein levels, may enhance the sequestration of pro-apoptotic protein Bim, thereby impeding Bim-induced apoptosis.

Since these mechanisms could potentially diminish the therapeutic effects of VEN, we aim to investigate in vitro whether VEN-resistant lymphoid malignant cells have enhanced Bcl-2-P and Mcl-1-P levels and whether these modifications contribute to VEN-resistance. As an in vivo proof-of-concept, we will next study these mechanisms in VEN-resistant mouse models and paired-samples from VEN pre-dose-to-progression patients.

Given that increased Bcl-2-P and Mcl-1 expression levels have been observed in lymphoid

malignant patient samples, it is imperative to identify novel treatment strategies to remove Bcl-2-P and Mcl-1-P and re-sensitize resistant cells to VEN-therapy. In this study arm, we aim to identify and target kinases responsible for Bcl-2 and Mcl-1 phosphorylation in VEN-resistant cells using a high-throughput kinase-activity mapping (HTKAM) assay. As Bcl-2-P and Mcl-1-P are regulated by protein-phosphatase-2A (PP2A), we will also utilize the PP2A-activating drugs (PADs) to reverse these modifications. We hypothesize that kinase-inhibitors and PADs will reduce Bcl-2-P and Mcl-1-P, thereby re-instating VEN-Bcl-2 binding, destabilizing Mcl-1 protein and facilitating VEN-induced cell death of lymphoid malignant cells.

“Metabolic Control of Protein Synthesis by Ribosome Stalling”

Translation is a central process for gene expression and cell proliferation but is metabolically costly and thus tightly regulated in response to environmental nutrient availability. In eukaryotes, the metabolic state of the cell is sensed by the GCN2 and mTOR pathways, which regulate the number of ribosomes initiating new protein synthesis. Recent work has revealed that the metabolism can also directly control translation by slowing ribosome elongation; during amino acid starvation, reduced tRNA charging can lead to ribosome stalling, collisions, and premature fall-off at the codons decoded by affected tRNAs. The relationship between initiation rate control by signaling and ribosome stalling is reciprocal and incompletely understood; recent work indicates that the GCN2 pathway is directly activated by ribosome stalling and collisions, and its downstream response can mitigate ribosome stalling by reducing global protein synthesis during starvation for specific amino acids. Ribosome stalling has been linked to diseases of cells that rely on high rates of protein synthesis; mutations leading to stalling cause neurodegeneration, and stalling is associated with cancer metastasis and tumor innervation. The GCN2 pathway is essential for tumors, suggesting that stalling may constrain tumors in physiological environments. It is critical to understand the causes and consequences of ribosome stalling to target it in human disease.

The objective of this proposal is to determine the factors that regulate ribosome stalling upon amino acid starvation and identify the consequences of this metabolic form of translational control. Specifically, a fluorescent reporter and CRISPR screening platform will be used to determine the metabolic states that induce ribosome stalling (Aim 1) and the genetic regulators of ribosome stalling (Aim 2). Quantitative proteomics and mouse models of cancer will then be used to assess the consequences of ribosome stalling for protein production and a physiological disease context (Aim 3).

“Molecular Mechanisms of Metastatic Colonization of the Liver by Dormant Breast Cancer Cells”

Metastatic relapse is the main reason behind >90% of cancer-related deaths and remains largely untreatable, owing to a fragmentary understanding of how extravasated but initially dormant

cancer cells engage in successful crosstalk with their distant tissue microenvironments to colonize these tissues. Breast cancer is a heterogeneous disease with variable periods of subtype-dependent, clinical latency. Breast cancer to liver metastasis is relatively common and has poor prognosis. In spite of this, breast cancer to liver metastasis remains relatively understudied. Here, I propose an experimental framework to study the transition of disseminated breast cancer cells from dormancy to colonization in the liver, through the *in vivo* transcriptional reprogramming of these breast cancer cells. I propose two independent experimental routes of generating novel transcriptomes within breast cancer cells *in vivo*, either through the activation of a cancer cell-specific factor, or a microenvironmental trigger, *i.e.*, LPS-mediated inflammation, to facilitate colonization of the liver. Using both human and murine mammary carcinoma cells in appropriate mouse hosts, I will use a combination of techniques, including single-cell RNA sequencing, followed by detailed bioinformatic analyses, to identify novel transcriptional signatures of both cancer cells and their microenvironmental partners (stromal and immune cells) that collaborate to support colonization, which will be further compared with publicly available patient datasets to identify robust targets that may be pharmacologically inhibited in future.

The long-term goal of this work is to focus on the genes identified within the framework of the current proposal, in both cancer cells and colonization-supportive liver microenvironment, to develop anti-metastatic therapies. Such 'high-confidence', therapeutically vulnerable targets will be investigated for causality in liver colonization, by targeting them with drugs, small molecule inhibitors or neutralizing antibodies, to prevent liver colonization and increase progression free- and overall survival in breast cancer patients.

"The Role of Lineage in the Temporospatial Genesis of Retinal Bipolar Cell Subtypes"

Retinal development is a complex process that results in the generation of over 100 neuronal subtypes which work together to perform a wide range of visual functions. Bipolar interneurons are one of the primary classes of retinal cells and comprise 15 different subtypes, each of which differs in abundance but is spread throughout the retina providing full coverage of their unique physiological features. The developmental mechanisms underlying the generation of such cellular complexity are not fully understood. A recent study from our lab has revealed that all bipolar subtypes are born in a "wave"-like spatiotemporal pattern in which there are hot-spots of subtype genesis that shift over time. This pattern suggests a hierarchical model of bipolar subtype genesis in which early retinal progenitors undergo a series of divisions that give rise to sub-lineages located physically adjacent to each other in the developing retina. Each of these sub-lineages then passes through a series of temporal competence windows during which they produce different bipolar subtypes. Investigation of this model requires multi-generational lineage analysis to compare the developmental timing and clonal output of distantly related sub-lineages. However, current lineage tracing tools are not capable of recording such detail. To investigate this hypothesis, I have developed SCRIBE (Sequential Combinatorial Recorder for Iterative Barcode Evolution), an "evolvable" lineage tracer that can be used to reconstruct the individual branches of a clonal lineage tree, allowing for the investigation of sub-lineage relationships within an individual clone. First, I will adapt SCRIBE for *in vivo* use in the developing

retina by performing benchmarking studies and testing several different designs aimed at optimizing its recording rate. Then, I will use SCRIBE to determine the lineage relationships of bipolar cells that emerge within clones allowing me to determine whether bipolar subtypes emerge in a hierarchical manner.

“Mechanistic Elucidation of the B Cell Receptor (BCR) Signaling Complex by Cryo-EM”

Antigen sensing and antigen receptor activation are essential for initiation of adaptive immunity. There are two major classes of lymphocytes - T and B cells. Antigen receptors including T cell receptor (TCR) and B cell receptor (BCR) are key structures responsible for antigen sensing at surface of lymphocytes, with distinct mechanisms. Each BCR has two antigen-binding sites that are located at the tips of the two antigen binding (Fab) arms of the membrane-bound form of immunoglobulin (mIg) molecule. Within each mIg, a flexible linker connects the Fab arms and the Fc component. Because of the flexibility, BCRs respond to both soluble and membrane-bound antigens, and sense more structurally heterogeneous antigens than T cells. To fulfill its antigen sensing and signal transduction function, BCR forms a complex that comprises membrane-bound Ig (mIg) for antigen binding, and the Ig α / Ig β heterodimer (also known as CD29a and CD29b) for signal transduction. All the BCR components are assembled in the endoplasmic reticulum (ER) and transported together onto the surface of a B cell. Both Ig α and Ig β are necessary and sufficient to mediate signal transduction in B cells. The molecular architecture of the transmembrane BCR complex remains unsolved despite its biological importance. This project aims to elucidate the structural assembly of the BCR complex in different conformational states by cryo-electron microscopy (cryo-EM) and to validate the structure using mutagenesis and cell biology. Understanding the assembly and the activation mechanism of BCR will not only provide new insights into B cell signal transduction, but also afford novel therapeutic strategy for precise treatment of B-cell related diseases.

“Dissecting and Therapeutically Exploiting Synthetic Lethality between NOTCH and TRIM28 to Drive Anti-Tumor Immunity in SCLC”

Small cell lung cancer (SCLC) is an aggressive subtype of lung cancer with no approved targeted therapies. SCLC harbors near universal loss of function (LOF) mutations in RB1 and TP53 and 25% of SCLCs carry LOF mutations in NOTCH. Despite SCLCs high tumor mutational burden, responses to PD-1/PD-L1 immune checkpoint blockade (ICB) are quite modest where addition of PD-L1 ICB increased survival by only ~2 months. Hence, identification of new combination therapeutic strategies to increase ICB response in SCLC are urgently needed. I developed NOTCH-Mutant (NOTCH1-Mutant or NOTCH2-Mutant) and NOTCH-WT SCLC genetically engineered mouse models using CRISPR/Cas9 and derived cell lines from these tumors. I discovered (in both cell lines and tumors) that NOTCH-Mutant SCLCs had restored expression of innate immune

signaling genes. I then used NOTCH-Mutant and NOTCH-WT cell lines to perform CRISPR/Cas9 screens to identify synthetic lethal interactors with loss of NOTCH in SCLC. I identified TRIM28 as a robust synthetic lethal interactor with NOTCH, which I have validated across human and mouse SCLC cell lines. My preliminary data suggests that the mechanism of synthetic lethality involves hyperactivation of the TBK1 innate immune signaling pathway leading to CXCL10 and interferon production, which is cytotoxic. Thus, I hypothesize that the NOTCH/TRIM28 synthetic lethality will be greatly augmented by an anti-tumor immune response in an immunocompetent host. In aim 1, I will rigorously determine the mechanisms underlying NOTCH/TRIM28 synthetic lethality using both human and mouse SCLC cell lines. In aim 2, I will use immunocompetent SCLC syngeneic mouse models engineered to be isogenic to NOTCH and/or TRIM28 and test whether TRIM28 inactivation in NOTCH-Mutant SCLC restores anti-tumor immunity alone or when combined with PD-L1 ICB. If successful, my proposed research could lay the preclinical foundation for a novel therapeutic strategy for the ~25% SCLC patients that harbor LOF NOTCH mutations.

“Understanding Polycomb Repressive Complex 2 Function and Dependencies in EZH2-mutant Lymphoma Using Drug Addiction Alleles”

The concept of oncogene addiction has played a foundational role in the development of targeted therapeutics for cancer treatment. However, the efficacy of targeted therapeutics is inevitably hampered by emergence of drug resistance. The goal of this proposal is to leverage drug resistance and addiction mutations as discovery tools to gain critical understanding into the biology of Polycomb repressive complex 2 (PRC2), provide insight into how other PRC2 cancer mutations might likewise operate, and identify new cancer vulnerabilities.

Through an innovative CRISPR mutational screen, I identified hypermorphic mutations in EZH2, the enzymatic component of the PRC2, that confer drug resistance and addiction to PRC2 inhibitors in EZH2-mutant lymphomas. Based on my preliminary data, I hypothesize that there is a minimum and a maximum threshold of chromatin signaling necessary for cancer cell survival. Aim 1 seeks to clarify the mechanisms of drug addiction in EZH2-mutant lymphoma. I will characterize the epigenetic states of the parental and drug-addicted states using genomics approaches. I generated preliminary data showing that drug-addicted cells gain excessive H3K27me3 that aberrantly spreads into and silences active regulatory elements in the genome upon drug withdrawal. I will conduct quantitative proteomic analysis of histones and their post-translational modifications in parental and drug-addicted cells, and biochemical studies with recombinant PRC2 to distinguish the mechanisms of H3K27me3 spreading. In Aim 2, I will discover new potential EZH2-mutant lymphoma dependencies using chemical suppressor and genome-wide CRISPR/Cas9 screens that are explicitly designed to select for drug addiction mechanisms.

This proposal seeks to enhance critical understanding of PRC2 function and potential resistance mechanisms to epigenetic inhibitors. The identification of drug addiction mechanisms will uncover new co-dependencies for treating EZH2-mutant tumors. This approach is readily generalizable and can be broadly exploited across other target classes to discover drug target biology and new vulnerabilities of cancer cells.

“Molecular, Circuit and Sensory Control of the Instinctive Need for Social Interactions”

Internal physiological state significantly influences the expression of animal behavior, but the underlying neuronal and circuit mechanisms are largely unknown. To tackle this question, my first attempt in a collaborative work has identified a unique neuronal population controlling fever and loss of appetite during sickness. In a second project, I aim to explore the neural basis of internal social need.

Social need is an evolutionarily selected and conserved fundamental need across animals. Social need is effectively enhanced after social isolation, as demonstrated by a rebound in social activity during reunion. I have recently identified a specific hypothalamic neuronal population with unique molecular markers located in the medial preoptic nucleus (MPN), that are specifically activated during social isolation (MPN-isolation neurons). Functional manipulation experiments demonstrate that MPN-isolation neurons are both necessary and sufficient to drive social seeking and social interaction following isolation.

To better understand how social need varies across animals with different genetic backgrounds, I monitored social rebounds in 6 lab mouse strains and uncovered a remarkable continuum in rebound intensities across strains. Remarkably, MPN-isolation neurons are highly active in an isolation sensitive strain, FVB/NJ, while they showed reduced activity in another isolation insensitive strain, C57Bl/6J. This interesting observation inspires me to further investigate the underlying neural mechanisms, particularly to examine the differential gene expressions of MPN-isolation neurons in FVB and C57 mice during both isolation and social sated states (Aim1), to investigate strain-specific connectivity patterns and their functions (Aim2), and to assess the sensory contribution to social need in two strains (Aim3). This work will provide overarching insights into the molecular, circuit and sensory controls of social need across mouse strains and suggest new avenues for treatment of social isolation induced mental disorders.

“Elucidating the role of timeless thermosensitive alternative splicing in temperature compensation”

Circadian clocks are transcriptional/translational feedback loops that control most organisms' cellular, physiological, and behavioral timing to anticipate daily environmental changes. In *Drosophila*, the molecular circadian clock is composed of Clock and Cycle, which heterodimerize during the day to activate the transcription of several genes, including period and timeless (*tim*), which repress the Clock/Cycle heterodimers. Circadian clocks are self-sustainable, entrainable, and show temperature compensation. To this date, the mechanism for how temperature compensation occurs in eukaryotes has not yet been elucidated.

Recently, we discovered that one of the thermosensitively-regulated alternative spliced isoforms of *tim* (*tim-cold*) plays a crucial role in this mechanism. Our knockdown and CRISPR-Cas9 experiments suggest that TIM-COLD and TIM-L, the canonical TIM protein, have opposite effects on locomotor behavior and that the balance between these two proteins results in the maintenance of a 24 h period at cold temperatures (18 °C).

This proposal will disentangle the role of TIM-COLD and the other three TIM isoforms of this locus in temperature compensation. For this, we will (1) perform molecular and biochemical assays to assess if TIM-COLD speeds up the clock at 18 °C and how the interactions with its molecular partner PER are affected. (2) Perform genetic screens to systematically identify genes that enhance or repress the temperature compensation deficiency observed in our *tim-cold* knockdown and knockout lines. (3) Gain a comprehensive understanding of the role of this thermosensitive alternative splicing in temperature-sensation behaviors such as the chill-comma recovery time, for which we have a striking result in our TIM-COLD null flies. Finally, as TIM is a known transcriptional repressor, we will assess the global changes in transcription in TIM-COLD flies. Our discoveries in *Drosophila* will open new frontiers in neuroscience and chronobiology, as circadian clocks are remarkably conserved and how eukaryotes achieve temperature compensation is still unknown.

“Molecular and Physical Mechanisms of Homolog Pairing in Meiotic Budding Yeast”

Meiosis is a specialized cell cycle program that produces gametes with half the ploidy of progenitor cells. A key component of meiosis is recombination. The maternal and paternal versions of each chromosome (homologs) first recognize one another and become closely coaligned along their lengths (“paired”); crossovers then emerge. Crossovers play a mechanical role to ensure that homologs to separate at meiotic division I. Thus, failure of pairing leads to aneuploidy and birth defects or genetic diseases (e.g., Down syndrome).

My long-term goal is to understand how meiotic homolog pairing occurs. Three general problems must be solved. What information do homologs use to identify one another? How do separated homologs communicate in space for such identification and to come close together along their lengths? How do these events occur without generating permanent entanglements or interlocks? Elucidation of homolog pairing mechanisms has been hampered because data has previously been derived from fixed cells. Therefore, we developed low-SNR (signal-noise-ratio) microscopy which allows to track chromosome dynamics in three dimensions for a long time. By combining this approach with fluorescent repressor operator tagging system (FROS), I have achieved 4D tracking of chromosomal loci over the entire duration of meiosis in budding yeast. Applying this system to homologous loci, I recently discovered an unanticipated new process of “rapid homolog juxtaposition”: non-associated homolog spots, separated by >1.5 μm, come close together (~400 nm) within 10-60 seconds. I also find that this event occurs synchronously at different positions along a single chromosome and that it is accompanied by a longitudinal change, likely involving chromosome compaction. None of these features has been observed previously. I now propose to apply my methodology to elucidate the molecular mechanism of

rapid homolog juxtaposition (AIM1) and the bases for, and relationship between, intra-chromosomal synchrony and longitudinal compaction (AIM 2).

“A Systems Approach to Discover Sensors and Regulators of Mitochondrial Genome Ploidy”

The human mitochondrial genome (mtDNA), which encodes essential subunits of the electron transport chain, is present in multiple copies across the mitochondrial network. MtDNA copy number varies up to 10,000-fold across tissues, with each cell type maintaining an intrinsic, optimal setpoint via yet unknown mechanisms. A decline in this setpoint causes rare but severe and phenotypically heterogeneous disorders which have no proven therapies and is also associated with common diseases of aging such as Alzheimer’s and Parkinson’s Disease.

I propose to address two major unmet needs in clinical and basic mitochondrial biology – to overcome the detrimental consequences of mtDNA loss and to understand homeostatic regulation of mtDNA copy number. Genetic studies in multiple model organisms, including my published work, reveal a conserved link between membrane potential and tolerance to mtDNA loss. In aim 1, I will determine the mechanism by which boosting membrane potential rescues the growth of mtDNA-depleted cells. My completed multi-omic profiling of mtDNA depletion and repletion states has identified a small number of candidate effectors of membrane potential which I will test using a drug that targets stress signaling, a metabolite that can be supplemented exogenously, and a protein prosthetic for redox manipulation pioneered by my mentor’s lab. In aim 2, I will take a more unbiased approach and systematically identify nuclear regulators of human mtDNA copy number for the first time using a FACS-based genome-wide CRISPR knockout screen, which I conceptualized and developed in my early postdoctoral work.

Thus, I will leverage bioenergetics, high-throughput genetics, and systems approaches to gain fundamental insight into how cells couple their fitness to mtDNA abundance and regulate their mtDNA copy number. The discovery of these basic cell biological principles will illuminate new therapeutic targets and accelerate our search for treatments of both inherited and age-associated mtDNA depletion.

“A Multiscale Approach to Study the Role of Sphingolipids in Plasma Membrane Function and as Sensors in Innate Host Defense”

The goal of this King award is to understand structure-function relationships of glycosphingolipids (GSL) that underlie plasma membrane nanodomain assembly and their function in sensing enteric pathogens.

GSLs are enriched in the apical plasma membrane (PM) of epithelial cells where they engage in membrane nanodomains. These form in the outer membrane leaflet and are thought to

compartmentalize the PM into functional domains. In my postdoctoral time, I synthesized a unique fluorescent structural library of native GM1 ceramide species that allowed visualizing GM1 trafficking in live cells. My results implicate GM1 ceramide structure in the assembly of GM1 in nanodomains as the key factor. But how nanodomains functionally operate across a bilayer and how cells regulate them in the outer membrane leaflet is unclear. Nanodomains can also serve as entry platforms of enteric pathogens, which use the GSLs as receptors for endocytosis into the host. How GSL structure impacts this process is unknown. But epithelial cells sense this binding and rapidly downregulate the apical endosome which blocks further infection. This is a novel mechanism of innate immunity that depends on assembly of the GSL receptors in nanodomains.

The central aim is to define how nanodomains in epithelial PMs can transmit signals and to elucidate how epithelial cells adapt nanodomain function to defend against pathogen invasion at the host-environment interface. In Aim 1 we will utilize the unique GM1 library to test how nanodomain assembly leads to bilayer coupling and how cells regulate this function. Aim 2 focuses on how GM1 structure affects pathogen endocytosis and Aim 3 will uncover mechanisms of how cells sense nanodomain rearrangement using a whole genome CRISPR-Cas9 screen.

Apical membranes of intestinal epithelial cells are the first line of defense against pathogen invasion and the role of lipids play in sensing the extracellular environment is still underexplored.

“Deciphering the female-specific hypothalamic pathway underlying the metabolic regulation of fertility by the melanocortin receptor 4”

Hypothalamic Kiss1 neurons are essential regulators of fertility through the direct stimulatory action on gonadotropin-releasing hormone (GnRH) neurons. Kiss1 neurons in the arcuate nucleus (Kiss1ARC), expressed in both sexes, drive the pulsatile release of GnRH/LH, while Kiss1 neurons in the anteroventral periventricular nucleus (Kiss1AVPV/PeN), vestigial in males, regulate the preovulatory LH surge driving ovulation in females.

Reproduction is tightly regulated by metabolic factors. Among those, hypothalamic melanocortins are essential in the control of metabolism. Inactivating mutations in the proopiomelanocortin (Pomc) gene or melanocortin receptor 4 (Mc4r) cause severe obesity and subfertility in humans and mice. However, whether the reproductive impairment is a direct consequence of the lack of melanocortin signaling, or indirect from the obesity phenotype, remains unknown. α -MSH (from Pomc) stimulates LH release and this action is mediated by Kiss1 neurons. Kiss1AVPV/PeN neurons express MC4R, and Kiss1-cre specific MC4RKO (Kiss1MC4RKO) females display ovulatory failure, hypothesizing that ovulation impairment in Kiss1MC4RKO females is due to the absence of melanocortin signaling on Kiss1AVPV/PeN neurons.

The goal of this proposal is to characterize -using genetic mouse models, viral/pharmacological approaches, and neuroscience techniques- the role of melanocortins in the regulation of ovulation, by focusing on the direct action of MC4R signaling on Kiss1AVPV/PeN neurons. In aim 1, I will generate Kiss1-specific MC4R reinserted mice within the otherwise MC4RKO mice

(MC4RKOKiss1-rescued). This will determine whether the reproductive impairment seen in MC4R deficient females is a direct consequence of the lack of melanocortin signaling on Kiss1 neurons, or indirect from their obesity. The preliminary data support the former. In aim 2, I will investigate the effect of the specific activation and inhibition of MC4R on Kiss1AVPV/PeN neurons on driving and blocking ovulation, respectively, and on Kiss1AVPV/PeN neural activity. This study will characterize a novel sex-dependent hypothalamic pathway in the metabolic control of ovulation by melanocortins.

“Mechanisms Governing Neuronal Population Size and Identity in the Human Brain”

How organisms control the final number and identity of cells present in their organs remains elusive. During evolution, the human cerebral cortex has increased dramatically in size and complexity, a process associated with the acquisition of human cognitive abilities. Notably, not all cortical neurons have expanded equally: the proportion of callosal projection neurons (CPN) has grown exponentially in our brains. Adult human CPNs also include a broader variety of transcriptional subtypes compared to species with a simpler cortex. The mechanisms leading to these human-specific features are poorly understood, partly due to a lack of experimentally-accessible models of human corticogenesis. In this proposal, I will leverage stem cell-derived brain organoids as well as endogenous fetal tissue to investigate how the relative proportions of different neuronal populations are established in the human cortex, and to discover the developmental programs underlying human CPN expansion and diversification. First, I will identify the origin of CPN transcriptional diversity in the developing human cortex (Aim 1). Then, I will decipher the lineage relationships and neurogenic potential of cortical progenitors, focusing on the progeny of apical radial glia, the founder progenitor of the cerebral cortex (Aim 2). Finally, I will determine the contribution of a human enriched neural progenitor class, the outer radial glia, to the expansion and diversification of the human CPN population (Aim 3). My work will shed light on fundamental processes underlying human cerebral cortex assembly, which has enabled major evolutionary adaptations of the human brain. Understanding how human neuronal lineages are generated will also inform study of neurodevelopmental disorders, where defining how individual lineages are disrupted will contribute to unravelling the etiology of these severe conditions.

“Insight into a Novel Enterococcus Pore-forming Toxin Family”

Enterococci are a part of human microbiota. As the major causes of endocarditis, urinary tract infections and bacteremia, Enterococci are well known for their multidrug resistant (MDR) leading to a high mortality rate. However, the genus Enterococcus is not known to express any potent protein toxin family with an established specificity targeting human and animal cells. To

understand how the natural reservoir of Enterococcus traits predisposes them to emerge as MDR hospital pathogens, we have collected and sequenced enterococcal strains since 2011. By bioinformatic analysis, we identified an uncharacterized family of Enterococcus pore-forming toxins (Epx), in growing numbers of Enterococcus strains isolated across the globe from environmental, animal, and human samples. However, it's unclear whether the Epxs are active toxins to human. We also have little knowledge of the host factors for Epxs. More importantly, the physiological functions of Epxs during the pathogenesis process remain elusive. In this proposal, we propose three specific aims. AIM 1: Characterize the molecular mechanism of Epxs by structural analysis. Based on our bioinformatic analysis, we hypothesize that Epxs are active and potent pore-forming toxins. Using crystallography and Cryo-EM, we propose to elucidate molecular mechanisms of Epxs pore assembling on the host cell membrane. AIM 2: Identification of host receptors of Epxs via genome-wide CRISPR-Cas9 screens. The goal of this aim is to carry out genome-wide CRISPR-Cas9-mediated loss-of-function screens to identify receptors required for the cytotoxicity of Epxs. AIM 3: Explore the physiological functions of Epxs during enterococcal pathogenesis processes. We propose to establish animal infection models for Epxs and evaluate the contribution of Epxs for colonization and pathogenesis of Enterococcus.

“Histone variant H2A.Z-mediated chromatin organization regulates brown adipocyte thermogenic function”

Brown adipose tissue (BAT) dissipates chemical energy in the form of heat and regulates triglyceride and glucose metabolism in the body, it is thus an appealing therapeutic target for combating obesity and related metabolic disorders. The thermogenic capacity of BAT is primarily conferred by the unique expression of uncoupling protein-1 (Ucp1), which dissipates energy by uncoupling the proton motive force from ATP generation.

The purpose of the proposed research is to uncover novel regulators of Ucp1, which could serve as potential therapeutic targets to enhance the activity of thermogenic adipocytes to protect against obesity. In our preliminary studies, using unbiased CRISPR/Cas9-based chromatin immunoprecipitation assay (enChIP), we identified histone variant H2A.Z as a novel trans-acting factor recruited to the promoter and enhancer region of Ucp1 by β 3-adrenergic receptor (β 3-AR) stimulation. H2A.Z is an essential and evolutionarily conserved histone variant of the canonical histone H2A. Importantly, ablation of H2A.Z in brown adipocytes led to lower β 3-AR-induced Ucp1 level and impeded the expression of other known thermogenic genes, leading to impaired cellular thermogenesis. The proposed research will extend my preliminary studies to 1) comprehensively characterize the effect of H2A.Z depletion on cellular metabolism in both murine and human brown adipocytes; 2) understand the underlying mechanisms by which chromatin incorporation of H2A.Z regulates thermogenic gene expression. My proposed research aims to understand thermogenic gene expression regulation from the perspective of 3D genome organization, which is an unexplored area in metabolism. The completion of the proposed studies will fill the critical knowledge gaps and ultimately pave the way for developing new therapeutic approaches targeting thermogenic adipocytes for treating obesity and related metabolic disease, such as type 2 diabetes and cardiovascular disease.

“Competing Effects of AgRP and POMC Neurons on cAMP Signaling in Downstream Neurons In Vivo”

The arcuate hypothalamus plays a critical role in regulating food intake, energy expenditure, and body weight. In particular, AgRP hunger neurons and POMC satiety neurons exert opposing effects in these areas by releasing the neuropeptides AgRP, NPY, and α MSH. One important common target is the satiety-promoting MC4R receptor-expressing neurons in the paraventricular nucleus of the hypothalamus (PVHMC4R). However, exactly how PVHMC4R neurons interpret and integrate the opposing signals from AgRP and POMC neurons remains unclear, especially regarding the involvement of the downstream second messenger cAMP. The central unknowns are:

- (i) How do hunger and satiety peptides alter cAMP in PVHMC4R neurons?
- (ii) How does cAMP regulate the function of PVHMC4R neurons?

The main barrier to answering these questions is the lack of tools to measure and manipulate cAMP during behaviors. I have recently overcome this barrier by helping to develop and apply a molecular and optical toolset to measure, make, and degrade cAMP. This proposal applies the new cAMP tools to understand how PVHMC4R neurons process hunger and satiety signals. I hypothesize that coordinated, opposing changes in AgRP and POMC neuron activity regulate spiking in PVHMC4R neurons via competing actions on cAMP signaling. To test this hypothesis, I propose the following aims:

Aim 1: Image cAMP dynamics in PVHMC4R neurons with the optical sensor cADDis during experimentally controlled peptide release, and to compare cAMP signaling between fasted and fed states.

Aim 2: Measure how directly increasing cAMP (using a new optogenetic tool, biPAC) and degrading cAMP (using an engineered phosphodiesterase, PDE4D3-Cat) changes plasticity and spiking of PVHMC4R neurons as well as energy balance.

The proposed experiments will enable the understanding of when, where, and how cAMP is used to titrate the activity of PVHMC4R neurons. These results will fill a substantial knowledge gap in developing and understanding treatments for obesity.

“Mitoribosomal Stalling and Translation Inhibition Regulate Cytoprotective Responses”

Mitochondrial dysfunction is a hallmark of aging that causes aberrant signaling, metabolism, and inflammatory responses in tissues. As such, declines in mitochondrial function in humans contribute to several age-associated pathologies such as cancer, diabetes, sarcopenia, and neurodegenerative disease. The goal of this project is to elucidate genetic and metabolic targets that prevent detrimental mitochondrial signaling cascades. To accomplish this, we utilize mitochondrial disease (MD) models characterized by mitochondrial gene mutations that lead to bioenergetic failure in energy demanding tissues. We recently discovered that inhibition of mitochondrial translation via tetracycline antibiotics paradoxically increases survival of MD cell lines and improves fitness of the *Ndufs4*^{-/-} Leigh Syndrome mice. Here, I propose to identify cellular mechanisms stimulated by mitoribosomal stalling that alleviate damage from mtDNA mutations. I aim to delineate the i) metabolomic and lipidomic signatures associated with mitoribosome inhibition using LC-MS/MS platforms and ii) genes that act synergistically with tetracycline antibiotics to promote cellular fitness using CRISPR-based screens. These complimentary approaches will define cytoprotective mechanism(s) downstream of mitochondrial translation inhibition that prevent cell death from mtDNA mutations and uncover novel therapeutic targets for age-associated diseases with mitochondrial etiology.

“Circadian Control of Feeding”

Food consumption is temporally organized across the circadian (~24 hour) cycle. Tightly scheduled feeding ensures that future energy deficit is prevented and that energy intake is aligned with metabolism. However, miss-timed eating due to shift-work, disturbed sleep and poor diet are major disruptors of this delicate system. Miss-timed feeding can have significant consequences on metabolic health, rendering it a major public health challenge. Despite its importance, we lack fundamental knowledge about the mechanisms controlling meal timing which has precluded an understanding of why miss-timed eating is so problematic.

The suprachiasmatic nucleus (SCN) in the mammalian hypothalamus coordinates biological rhythms and is essential for circadian control of feeding. Yet, how the SCN controls feeding rhythms remains elusive. The goal of this proposal is to identify the neural circuitry underlying feeding rhythms. We have focused on SCN control of Agouti-related peptide (AgRP)-expressing neurons in the hypothalamus which orchestrate and are indispensable for food intake. We hypothesize that a SCN \rightarrow AgRP neuron circuit controls feeding rhythms. In Aim 1, I will establish

that AgRP neuron activity has a circadian rhythm. To do so I developed an approach to perform long-term recordings of AgRP neuron activity in vivo in mice. Aim 2 will address an important conundrum: does the SCN directly control AgRP neuron activity, or does it affect feeding patterns which then drive changes in AgRP neuron activity? Preliminary data suggests that it is the former. Aim 3 will identify the neural circuit that conveys time-of-day information from the SCN to AgRP neurons. Here, I will utilize a suite of sophisticated neuroscience techniques, including viral tracing, electrophysiology, in vivo circuit-mapping, long-term recordings of neural activity and behavioral studies. This work will reveal the neural pathway underlying the temporal organization of feeding and provide insight into human pathophysiologies resulting from disrupted circadian rhythms.

“How Does the Selective Recruitment of Microglia Shape the Wiring of Inhibitory Circuits?”

Brain function relies on a myriad of events that shape our neural circuits during development. Early postnatal periods represent an exceptionally sensitive time when even subtle insults can cause alterations that last throughout life. Revealing how brain wiring is regulated is therefore key to restore normal brain function in neurodevelopmental disorders.

Interactions between the brain immune cells – microglia – and developing neuronal connections have been increasingly implicated as being essential for brain wiring. Among their multiple functions, microglia remove exuberant synapses formed during development and promote a more refined and efficient neuronal network. In our recent work, we identified a subpopulation of microglia that is receptive to signals from inhibitory cells and selectively remodels their synapses during a precise developmental period. Perturbing these specialized microglia causes long-lasting defects in inhibitory connectivity without impacting excitatory synapses and leads to stereotyped repetitive behavior and hyperactivity. The overarching implication of these findings is that interactions between microglia and synapses are not generic, with crucial significance for therapeutic intervention.

In the first aim of this project, we will answer outstanding questions about microglia-mediated inhibitory circuit remodeling: how are specific inhibitory synapses recognized by microglia? How is the subsequent synapse remodeling regulated? We will first investigate how changes in the activity of inhibitory neurons during development affect microglia-mediated pruning. Next, we will utilize a proteomic approach to study the synapse-specific molecules involved in microglia recruitment.

Our work also showed that perturbing these specialized microglia results in hyperactivity. In the second aim, we will study the interaction of microglia with inhibitory synapses in brain areas central for motor functions.

The overarching goal of this project is to obtain a more comprehensive understanding of the mechanisms regulating microglia-synapse interactions across inhibitory brain circuits and provide a biological basis for therapeutic interventions in human studies.

“Molecular Genetic, Cellular, and Circuit Analysis of Multichromatic Light Responses”

Defects in the processes that maintain and protect light-sensitive tissues can lead to disorders resulting in vision loss/blindness or skin cancer. My research is focused on characterizing novel photobiological responses of *Caenorhabditis elegans* nematode worms to further our understanding of mechanisms underlying light-sensitive tissue function and maintenance.

Color detection is used by animals of diverse phyla to navigate colorful natural environments and is thought to require evolutionarily conserved opsin photoreceptor genes. I recently discovered that despite lacking eyes and opsins, *C. elegans* can discriminate spectra of multichromatic light (colors) to guide foraging. In addition, two genes I identified thus far as required for opsin-independent color discrimination by *C. elegans* -- *jdk-1* (homolog of MKK7, an activator of c-Jun N-terminal Kinases) and *lec-3* (homolog of galectin-9) -- are evolutionarily conserved and have mammalian homologs that mediate cellular responses to stress stimuli, including ultraviolet light.

With the support of this fellowship, I will characterize the genetic, behavioral, and physiological responses to multichromatic light by *C. elegans* by identifying cellular loci underlying color discrimination by *C. elegans* (Aim I), analyzing intracellular signaling pathways for their contributions to color sensitivity (Aim II), and identifying additional molecular mediators of color discrimination by *C. elegans* (Aim III). Exploring multichromatic light responses by *C. elegans* could inform non-visual, protective photobiological responses by mammalian cells that naturally sense light, are involved in the maintenance of light-exposed tissues like the eye, and express homologs of genes required for photobiological responses by *C. elegans* (galectin, for example, has been shown to mediate survival of ultraviolet light-exposed skin cells). As multichromatic light is inherent to sunlight, etc. and pervades humans' natural environments, exploring multichromatic light responses by cells and organisms – even those lacking canonical visual opsins – addresses questions of both fundamental biological and specific biomedical importance.

“Interferon- λ Signaling Favors Immunosuppression and Tumor Growth”

Our goal is to determine how type III interferon (or, IFN λ) promotes an immunosuppressive and pro-tumorigenic myeloid cell population during chronic inflammation. Colitis-associated colon cancer (CAC) is a serious complication of inflammatory bowel disorders (IBD) and causes death in 10-15% of IBD patients. Myeloid cells, especially neutrophils, infiltrate the intestines during IBD and contribute to the development of CAC. Tumor-associated myeloid cells are a heterogeneous population and can play either inflammatory and anti-tumoral, or

immunosuppressive and pro-tumoral roles. The neutrophilic myeloid derived suppressor cells (MDSC) are often found in the tumor microenvironment and have important pathological functions. We recently showed that IFN λ can moderate neutrophil activity to limit inflammation and damage, while prolonged exposure to IFN λ can be harmful and block repair. Our new and unpublished data using mouse models of CAC show that during extended and repeated flares of inflammation, active IFN λ signaling in MDSCs favors spontaneous tumor development. Preliminary analyses using bone marrow-derived MDSC showed an IFN λ -dependent impairment in nitric oxide production, increased CD8+ T cell suppression, and a hyper state of cellular metabolism. All these IFN λ -dependent activities can be responsible for a diminished anti-tumoral immune response and increased tumor growth. Hence, this research plan is designed to (i) characterize the IFN λ -dependent skewing and quiescence of immunosuppressive myeloid cells populations, specifically neutrophils, in CAC and (ii) identify nodes for interventions by resolving the apparent conflicting roles of IFN λ in inflammation and tumorigenesis. Tissue-restricted activation makes IFN λ beneficial in alleviating acute inflammation, but persistent IFN λ may be detrimental in long-term IBD patients. Understanding the mechanism and kinetics of how IFN λ signaling reduces inflammation but induces pathological, pro-tumoral immunosuppression is critical for establishing novel immunotherapies to treat gut inflammation as well as prevent CAC.

“Structural Basis for the Motility of Airway Cilia and Insights into Motile Ciliopathies”

The human airway epithelium contains ciliated cells bearing motile cilia. These motile cilia beat rhythmically to produce metachronal waves that drive the flow of mucus. In humans, cilia-driven mucus flow clears the airways of trapped bacteria, viruses, pollutants, and allergens. It is therefore the first line of defense against airborne pathogens and an essential component of the innate immune system. However, the molecular mechanisms responsible for ciliary motility are poorly understood. In part, this is due to the size and complexity of the axoneme, the molecular machinery of cilia responsible for motility. The axoneme consists of a geometric network of axonemal complexes (dynein motors and mechanoregulatory complexes), and singlet and doublet microtubules. Impaired ciliary motility by mutations of axonemal proteins causes primary ciliary dyskinesia, a ciliopathy characterized by recurrent respiratory infections. Detailed structural information is required for a mechanistic understanding of ciliary motility, yet most structures of mammalian motile cilia come from low-resolution electron cryotomography (cryo-ET) which provides only overall morphology. I propose to use single-particle electron cryomicroscopy (cryo-EM) to determine the high-resolution structures of microtubule-bound axonemal complexes from mammalian tracheal cilia (Aim 1). These structures will provide insights into the evolution and molecular assembly of the axoneme. Mutations that cause motile ciliopathies are often related to structural defects of the axoneme. I propose to study the structure of the axoneme, ciliary motility, and mucociliary clearance from mouse models of disease-causing mutants (Aim 2). Taken together, this project will combine structural and functional analysis to reveal the basis of airway ciliary motility and to model the disease mechanisms of motile ciliopathies.

“Synthetic Lethality and Repair Protein Dynamics in Mammalian Stalled Fork Repair”

Genomic instability is a hallmark of cancer. Replication fork stalling at sites of abnormal DNA structure is a major source of genomic instability. A limitation in the study of mammalian stalled fork repair has been a dearth of tools with which to analyze this process in molecular detail. The Scully lab solved this problem by adapting the *Escherichia coli* Tus/Ter replication fork barrier (RFB) to cause site-specific replication fork stalling at a defined chromosomal locus in mammalian cells. This Tus/Ter reporter system has made HR and other and other repair processes at stalled chromosomal mammalian replication forks accessible to systematic, quantitative in vivo molecular analysis for the first time. The power of this system is revealed by my discovery that FANCM with BRCA1 synergistically suppress a novel class of repair product at stalled replication forks: the non-homologous tandem duplication (TD). Importantly, the genomes of BRCA1-linked breast and ovarian cancers similarly contain numerous small (~10 kb) TDs. Thus, the Tus/Ter system recapitulates TD formation in BRCA1-linked breast and ovarian cancer. My analysis of TDs has revealed unanticipated genetic synthetic lethal interactions between BRCA1 and FANCM in mouse embryonic stem (ES) cells. Notably, I discovered that a Fancm mutant defective only for the ATPase (motor protein) function is synthetic lethal with Brca1 mutation. Since the FANCM motor/ATPase function should, in principle, be targetable by small molecules, FANCM is expected to be “druggable”. These findings suggest that FANCM may be a promising therapeutic target in BRCA1-linked breast and ovarian cancer. My goals in this proposal are to further explore the novel Fancm-Brca1 synthetic lethal interaction in cancer cells and determine the mechanism of synthetic lethality. Further, I will explore the chromatin environment and protein dynamics at stalled fork and will study how alteration in these processes contributes to the FANCM-BRCA1 synthetic lethal interaction.

“Deconstructing ecological and genetic mechanisms of colonization resistance”

The human gut microbiome is a diverse and dynamic microbial community that collectively prevents colonization and expansion of intestinal pathogens, a function termed colonization resistance. *Klebsiella pneumoniae* is a widely-distributed opportunistic pathogen and a leading cause of severe infections in both preterm infants and later in life during antibiotic treatment. A role for microbe-microbe interactions in mediating colonization resistance to opportunistic pathogens is emerging. Which and how community members interact with *K. pneumoniae* and mediate colonization resistance is not understood. A mechanistic understanding of the ecological and genetic mechanisms is necessary for the prevention and management of opportunistic infections by *K. pneumoniae*.

Our study of microbiome dynamics in preterm infants recently published in *Nature* identified a network of novel microbe-microbe interactions centered on *K. pneumoniae*. We

computationally predicted and experimentally validated that *K. pneumoniae* exploits another community member *Staphylococcus* and is inhibited by a fungus *Candida albicans*. While these ecological interactions are central to *K. pneumoniae* colonization in preterm infants, the genetic and molecular mechanisms governing the control of *K. pneumoniae* by co-resident community members are unknown.

This proposal seeks to determine the ecological and genetic mechanisms of how *K. pneumoniae* fitness during gut colonization is shaped by different community memberships. In Aim 1, using a high-throughput forward genetics tool I created, I will define genetic underpinnings of the pair-wise interactions we identified between *K. pneumoniae*, *Staphylococcus* and *C. albicans*. In Aim 2, using the computational and experimental pipeline established in our recent work, I will investigate in antibiotic-treated mouse models how genetic determinants of *K. pneumoniae* fitness are shaped by ecological interactions within different perturbed communities.

Together, this project will provide mechanistic insights into *K. pneumoniae* gut colonization from the perspective of community ecology and will have implications for microbiome-based interventions to improve colonization resistance against this opportunistic pathogen.

“Development Of New DNA Insertion Technologies For Human Genome Editing”

Genome editing holds tremendous potential for the treatment of genetic disease and the improvement of human health. Recent breakthroughs with CRISPR-Cas enzymes have led to new molecular tools that precisely edit the genome through disrupting gene function, or by directly editing bases to correct substitutions. The targeted insertion of new genes, however, remains a key challenge in the field as it currently relies on the formation of a DNA double-strand break and the ability of the host cell to perform homologous recombination with a DNA donor, a process that is inefficient and highly dependent on cell type and state. A key objective, therefore, is to develop genome editing technologies which function independently of host cell repair pathways and allow for editing of the vast number of non-dividing somatic cells in the human body.

I have been investigating two types of bacterial transposases, enzymes which directly catalyze the movement of DNA into new target sites, and propose to develop these enzymes into new programmable DNA insertion tools for use in human cells. I specifically aim to: 1) further characterize and develop natural CRISPR-associated transposase systems for gene insertion, 2) engineer ssDNA writers in human cells, and 3) understand the cellular response to DNA transposition and genome editing tools.

The successful realization of this project will provide research tools to powerfully alter cells in new ways, and potentially new molecular therapeutics to correct gene deficiencies in patient cells and to engineer cells with new abilities.

“Heterogeneity of Firing Rate Set Points in Health and Disease”

Aberrant network activity can occur in brains of Alzheimer's disease (AD) patients decades before symptom onset. Recent work suggests some neurons become hyperactive while others become hypoactive, but the identities of these neurons and the mechanisms responsible for their aberrant activity are unknown. In healthy brains, stable mean activity levels of individual cortical neurons within the same cell type can span many orders of magnitude, but the mechanisms that determine these firing rate set points (FRSPs) are not understood. The goal of this project is to determine the basis of this activity heterogeneity within individual cell types in healthy and AD brains via the following specific aims:

- 1) Identify ion channels that underlie differences in FRSPs within cell types in healthy brains
- 2) Determine the electrophysiological changes that disrupt FRSPs in AD
- 3) Uncover the molecular determinants of FRSPs in healthy brains and the molecular changes responsible for FRSP dysregulation in AD

The key to this proposal is an approach I have developed for permanently fluorescently labeling neurons based on their FRSPs in vivo with CaMPARI2, which allows me to isolate neurons with high and low firing rates. First, I will use immunohistochemistry and patch clamp electrophysiology to determine the ion channels whose expression or conductance are correlated with FRSPs within a single cell type in mouse visual cortex. Next, I will use patch clamp electrophysiology to compare the electrophysiological properties of hyperactive and hypoactive neurons from AD mice to those of high and low activity neurons from healthy controls. Finally, I will use cell sorting and RNAseq to identify the molecular differences between high and low activity neurons in healthy and AD brains. This work will significantly increase our understanding of how the activity of individual neurons is regulated over long timescales, and how it is disrupted in AD.

“Identifying Chromatin Factors Required for DNA Repair Using a Novel, High-throughput Screening Methodology”

Mammalian cells have developed a complex, coordinated signaling network to promote repair of damaged DNA, collectively referred to as the DNA damage response (DDR). The DDR is essential for maintaining genomic stability and preventing diseases including cancer and neurodegenerative disease.

The DDR involves important chromatin-based events and in recent years many functions of histone modifications in the DDR have been elucidated. How these modifications contribute to DNA repair and maintenance of genome stability per se is still largely unknown however. Indeed, only a handful of chromatin factors have been implicated in DNA repair, and identification of factors involved in genome stability maintenance has been significantly hampered by the lack of high-throughput screening methodologies. In particular, uncovering how chromatin structure and function is re-established during DNA repair has remained elusive. Identifying new chromatin factors involved in this critical process will illuminate new therapeutic targets and novel treatment avenues for diseases underpinned by genome instability.

To address this problem, our laboratory has recently developed a high-throughput screening strategy for identifying chromatin factors involved in DNA repair. This approach uses a unique cDNA expression library of >325 predicted chromatin interactors which we have termed “ChromORFeome”. This overexpression system coupled with high-throughput imaging of UV-induced micro-irradiation, enables the visualization of novel chromatin factors recruited to DNA damage sites in sub-nuclear regions. Using this approach we have uncovered the DNA damage-dependent recruitment of a number of factors including ZNF280A, a gene mis regulated in a number of cancers but with unknown biological function.

This proposal will therefore focus on 1) mechanistically characterizing the role of ZNF280A in genome stability maintenance, determining whether it could be an important therapeutic target in cancer and 2) using our innovative approach to identify chromatin factors critical for the re-establishment of chromatin structure in the late stages of DNA repair.

“Characterize the Immunomodulatory Effects of Nuclear Receptors in Triple-Negative Breast Cancer”

Breast cancer is the most common cancer and the 2nd most common cause of death from cancer in

women worldwide. Triple-negative breast cancer (TNBC) is a subtype that is negative for both Estrogen Receptor (ER), Progesterone Receptors (PR) and Human epidermal growth factor receptor 2 (HER2) and represents 15-20% of all breast cancer cases. TNBC is associated with the most advanced stage at diagnosis, highest risk of metastasis, and poorest outcomes, with treatment options that are very limited. The recent success of immune checkpoint blockade (ICB) therapy in multiple cancer types could provide a novel option for TNBC management, but only ~10% of TNBC patients respond to ICB therapy, as most are refractory with limited T cell infiltration or impaired T cell function. Recent studies showed that intratumoral immunity can be modulated by combination therapy to facilitate the efficacy of ICB. One strategy with great potential for accomplishing this is targeting a family of transcription factors (TFs) called nuclear receptors (NRs). Several NRs have shown immunomodulatory effects in cancer, and most NRs have known bio-available drugs to agonize/antagonize their downstream pathway activation. However, designing NR-ICB combination therapy is hampered by our limited knowledge in two aspects: (1) function of each NR in each immune population in the tumor microenvironment; (2) how to combine NR manipulation with ICB treatment to optimize therapeutic outcome. My long-term goal is to identify the immunomodulatory effects of NRs that can be used in combination with ICB therapy. To achieve this, I will first characterize the expression and activity pattern of each NR in TNBC (Aim 1), test the immunomodulatory effects of two prioritized NRs (GR and ESRRB) in TNBC progression (Aim 2), and assess the effect of temporal order in NR perturbation and ICB combination therapy (Aim 3).

“Big-Data AI to Quantify Normal and Abnormal Brain Aging in Children”

Brain age is related to brain health. A novel biomarker, Δ BrainAGE, which quantifies the discrepancy between MRI-revealed brain age (predicted by artificial intelligence or AI) and the individual's actual chronological age, can reveal subtle and early changes of brain health related to diseases or environment. However, success of this biomarker is only established for adults in recent years. Our objective is to build this brain health biomarker for children. We will first build a big-data and AI-powered age predictor from structural brain MRI, for children 0-22 years of age. We will extend our new AI model that obtained a promising accuracy in a pilot study consisting 1,640 subjects in this age range. Then, we will test our age predictor in survivors of pediatric brain tumor (Aim 2), to quantify how the tumor and treatment has changed the brain age compared to their actual chronologic ages. We will use our unique data of 153 survivors, whose brain MRIs are read normal by radiologists. Recent molecular studies revealed risk of abnormal aging in this vulnerable population, but a bottleneck question is to which extent, and whether the abnormal aging affects survivors differently by sex or by ages at diagnosis or treatment. Addressing these open questions by our novel age predictor is in response to Congress and NIH's urgent call in 2018 to better understand and improve the life quality in childhood cancer survivors in the next decade. Once successful, we will have a first big-data and AI-powered sensitive age predictor for this age range, which can be widely used to quantify abnormal yet subtle and hard-to-perceive abnormal aging in numerous pediatric brain disorders.

“Molecular Mechanisms Underlying Neuronal Subtype-specific Myelination”

The overarching goal of this project is to understand the mechanisms that govern myelin formation, distribution, and functionality in the mammalian central nervous system (CNS) to gain a finer understanding of demyelinating diseases.

Myelination of axons represents a unique milestone in vertebrate brain evolution, which has enabled the expansion of the brain and emergence of complex brain functions. Myelin, a lipid-rich membrane produced by oligodendrocytes (OL) that wraps the axons of neurons, increases the velocity of action potentials and thereby enhances the efficiency of long-distance neuronal transmission. Disrupted myelination contributes to many debilitating neurological disorders, including multiple sclerosis and schizophrenia. Until recently, it was assumed that myelin was distributed uniformly along all myelinated axons; however, our lab recently showed that distinct mammalian neurons are endowed with different profiles of myelin distribution (Tomassy et al., 2015). Notably, a subset of neurons in layer 2/3 of the cerebral cortex, which are responsible for higher-order cortical functions, present an “intermittent” myelination pattern with large portions of their axons being surprisingly “naked”. These findings provide a new conceptual framework to investigate the roles of myelin in circuit functionality, and suggest the possibility that different neurons may use myelin in unique ways to implement different strategies for long-distance communication.

Here, I will 1) use molecular profiling of oligodendrocytes across different cortical layers to map layer-specific differences in their transcriptome. Next, I will 2) employ a screen to understand how diverse populations of neurons and oligodendrocytes interact to achieve neuron type-specific programs of myelination, and 3) examine how intermittent myelination is controlled, and whether long unmyelinated regions may have specific functional roles. These studies will provide a new conceptual framework for how neurons and oligodendrocytes interact to achieve differential myelination and explore the role of differential myelin distribution in circuit function and complex behavior.

“Cellular and Molecular Bases Of Short Range Attraction In Anopheles Mosquitoes”

Mosquito-borne diseases kill >500,000 people annually. Understanding mosquito host-seeking can help improve vector control and limit disease transmission. Host-seeking relies on multiple sensory cues. While detection mechanisms for signals like CO₂ and odors, which alert mosquitoes to hosts meters away, have been widely studied, less is known about the detection of cues like temperature and humidity, which act over centimeters. These short-range cues influence landing and are detected spatially and temporally closer to blood-feeding, suggesting they may be effective targets for disrupting disease transmission. Our lab’s prior work found that a family of ion channels called Ionotropic Receptors (IRs) mediate temperature and humidity detection in *Drosophila*. With colleagues, I recently demonstrated that one IR, IR21a, drives heat-seeking in the malaria vector *Anopheles gambiae*. However, humidity-seeking’s molecular basis remains unknown. This proposal further probes how IRs regulate host-seeking by targeting the *Anopheles* orthologs of IR93a, a co-receptor involved in both humidity and temperature detection in *Drosophila*, and IR40a and IR68a, which mediate dry and moist sensing, respectively, in flies. In Aim 1, I will generate mosquito knock-ins targeting Ir40a, Ir68a and

Ir93a. Each knock-in will provide genetic access to neurons expressing these receptors and mutants for studying receptor function. With these tools, I will map peripheral locations and central projections of these neurons. In Aim 2, I will use electrophysiology and calcium imaging to characterize the stimulus response properties of these cells and assess their dependence on Ir40a, Ir68a and Ir93a. In Aim 3, I will examine how these mutations affect host seeking and blood feeding. Together, these data and reagents will provide new insights into host-seeking's cellular and molecular basis, offering new targets for vector control while providing a foundation for future work examining peripheral detection mechanisms and sensory integration occurring during the deadly, multimodal process of host-seeking.

“Bacteriophage Defense Mediated by Toxin-antitoxin Systems”

The majority of bacteria and archaea carry small genetic elements, termed toxin-antitoxin (TA) systems, on their chromosomes. Each system is encoded from a single operon and consists of a growth-inhibiting toxin and a cognate, neutralizing antitoxin. Despite their prevalence, their biological function has been the source of much debate and controversy. These systems were long thought to act as effectors of the bacterial stress response; however, I pursued a detailed *in vivo* characterization of TA activation in the model organism *Escherichia coli* and found that despite strong transcriptional induction under various stress conditions, toxin was never actually freed. This raised the question of why cells maintain up to dozens of these systems and expend vast resources on preventing their activation. Based on the observation that some TA systems have the capacity to protect against infection by bacteriophage, and TA systems are often encoded near other phage defense elements, I hypothesize that many or all TA systems may be phage defense elements. The work proposed in this project will aim to answer this question by combining a detailed mechanistic study of a known phage defensive TA system, RnlAB, with a broad screen to identify additional examples and define the prevalence of TA-mediated phage defense. More specifically, Aim 1 seeks to characterize the mechanisms by which the RnlAB system is activated by T4 phage, and subsequently how activated RnlA toxin inhibits phage infection. In Aim 2, I will identify additional TA systems with phage defense function by testing systems with proximity to other known phage defense elements against a diverse panel of phage. Tools and information generated in Aim 1 will facilitate and inform additional characterization on the newly identified systems. Together, these two aspects will lay the groundwork for my future independent research program.

“Understanding How YbeY and its Partner Proteins Facilitate Ribosomal RNA Processing and Ribosome Assembly”

The advent and spread of multi-drug resistant bacteria is one of the greatest human health concerns facing us today. Advancement and expansion in the repertoire of antibiotics is essential to manage the antibiotic resistance problem. YbeY is a highly conserved protein present in most bacteria. YbeY is essential for growth in certain bacteria like *Bacillus subtilis* and *Vibrio cholerae*. Depletion of YbeY

reduces the survival of some bacteria inside mammalian hosts. These properties make YbeY an attractive drug target for the development of a broad spectrum antibiotic or an antibiotic adjuvant. YbeY is a zinc-dependent single-strand-specific endoribonuclease. YbeY interacts with many proteins involved in ribosome assembly. Cells lacking YbeY, accumulate 16S ribosomal RNA (rRNA) precursors and have reduced amount of mature ribosomes. YbeY, therefore, plays an important role in 16S rRNA processing and ribosome assembly. However, the ability of YbeY to act on the ribosomal precursors in vitro is not yet demonstrated. The proteins that act together with YbeY in these processes are also unknown. In this project, I propose to obtain a complete picture of how YbeY functions in the 16S rRNA maturation process to predict the effectiveness of small molecule inhibitors for YbeY function as antibiotics. In my first specific aim, I propose to determine if YbeY can act directly on 30S precursor subunits by in vitro reconstitution of the 16S rRNA processing reaction. I also propose to determine YbeY's protein binding partners required for this process. In my second specific aim, I propose to use the Rend-seq method to identify RNA ends globally to determine if YbeY plays any role beyond rRNA processing. I also propose to study the uncharacterized YbeY binding partner, YbeZ protein. Finally, in my third specific aim, I propose to perform a fluorescence-based high-throughput screening assay to identify small molecule inhibitors of YbeY.

"Inhibition of P-selectin Binding for Suppression of Colorectal Cancer Metastasis"

The development of tumors that metastasize to other parts of the body is primarily responsible for colorectal cancer-related deaths. Once disseminated, metastatic success is largely influenced by evasion of immune surveillance and establishment of a specialized microenvironment that supports tumor adhesion and growth. Direct binding to activated platelets is among the early events that occur in the blood, which contributes to tumor shielding from natural killer cell-mediated lysis, facilitates arrest of tumors in the vasculature, and enhances extravasation. Platelets mediate cell/cell interactions using a major cell surface receptor, P-selectin, which recognizes ligands that are glycosylated with a tetrasaccharide epitope, sialyl Lewis X (sLeX). To date, molecular details of the pro-metastatic colorectal cancer/platelet P-selectin interaction remain unresolved, owing to the vast complexity of glycan structures, which are assembled in a non-templated manner by the combinatorial action of ER- and Golgi-resident enzymes and incorporated site-specifically to a variety of underlying scaffolds. In this project, we will (i) sequence the glycans and glycopeptides on colorectal cancer cells that bear sLeX, (ii) quantify the relative amounts of sLeX in early and late stage cancer tissues, and (iii) filter through defined sLeX-containing structures according to their ability to bind P-selectin. This information will provide a framework to evaluate the biomarker and therapeutic potential of relevant sLeX-glycoconjugates on colorectal cancer cells that are recognized by activated platelets. Recently, our laboratory developed a molecular library of P-selectin-specific antagonists bearing varying forms of core 2-based sLeX, among which GSnP-6 ($K_d \sim 22$ nM) was selected as a lead compound. Using in vivo colorectal cancer models, we will assess the capability of GSnP-6 in reducing metastatic tumor formation. Application of glycopeptide mimetics as P-selectin-targeted therapies holds significant promise for use as early intervention procedures against metastasis, mitigating risk of off-target effects, and improving prognosis of patients with colorectal cancer.

“Mechanistic Insights Into Lysosomal Nutrient Efflux”

Many RAS-transformed aggressive cancer cells escape cytotoxic chemotherapy and survive in near-starvation conditions. What makes them so hard to kill is their ability to obtain nutrients through scavenging of extracellular proteins and recycling the cellular components using autophagy. Both of these pathways converge on lysosomes which digest the internalized molecules and recover free amino-acids. The process of scavenging and internalization is known as macropinocytosis, and cancer cells acquire mutations to upregulate it when faced with nutrient-poor conditions. To fight such cancers, researchers are currently targeting the macropinocytosis machinery; however, because this process is not very well studied, and likely involves hundreds of proteins with redundant functions, such therapy might prove challenging to execute without involving multiple drugs. We propose a better way of targeting nutrient-scavenging cancers by focusing on a downstream process of releasing digested nutrients to cytosol. The Sabatini Lab showed that the release process is orchestrated by the mTORC1 pathway, and specifically by SLC38A9, a lysosomal membrane protein. SLC38A9 senses the rising levels of digested amino-acids, and activates its transporter function to efflux essential non-polar amino-acids from lysosomes to cytosol. Importantly, RAS-transformed pancreatic cancer cells that scavenge extracellular protein were unable to efficiently form tumors in the absence of SLC38A9, which presents a novel therapeutic idea. In this two-year project we will elucidate the molecular mechanism of releasing digested amino-acids from lysosomes to cytosol via SLC38A9, and therefore provide a rational approach to drug discovery. In parallel, we will screen for small molecules that specifically bind to SLC38A9, and develop them into chemical probes that modulate its transport activity. Impaired efflux function of SLC38A9 will lead to entrapment of macropinocytosis-derived amino-acids within the lysosomes. We expect that this treatment will impair the growth of tumors addicted to scavenging, while sparing normal cells that do not eat extracellular proteins.

“Determining the Role of Menin in Leukemic Self-renewal”

Nucleophosmin (NPM1) mutated acute myeloid leukemia (AML) is one of the most common types of cytogenetically normal AML and is caused by a cytoplasmic mislocalization of the NPM1 protein (NPM1c). Despite its high prevalence, the molecular mechanisms of leukemogenesis remains poorly understood and targeted therapy options are lacking. We recently uncovered that NPM1c infers aberrant self-renewal onto committed myeloid progenitor cells through the upregulation of stem cell genes. With the acquisition of self-renewal capacity, these preleukemic progenitors also develop new dependencies on the chromatin modifying complex composed of histone methyltransferase MLL1 and adaptor protein Menin. Normal hematopoietic stem cells require a similar self-renewal gene expression program, which includes many MLL-target genes such as homeobox transcription factors (HOX) and their co-factor MEIS1. However, these normal stem cells are less dependent on the Menin-MLL interaction and seem to have alternative mechanisms to maintain their expression. This suggests that the epigenetic machinery regulating normal versus malignant hematopoietic self-renewal are distinct and that this can be utilized to specifically target malignant clones. In the proposed project we want to

gain deeper insight into the epigenetic changes that occur during leukemogenesis as cells shift from normal hematopoietic stem or progenitor cells to preleukemic NPM1c mutant cells (Aim 1). To determine the epigenetic machinery that regulates self-renewal we will use a proximity labeling and mass-spec approach to gain insight into the composition of the wildtype MLL-complex employed by NPM1c mutant leukemia cells (Aim 2). Lastly, we want to identify which MLL-complex components and associated complexes are unique dependencies in preleukemic cells compared to normal stem cells using a targeted CRISPR drop-out screen (Aim 3). In summary the insights gained from this proposed project will help to advance our understanding of leukemia development with the goal of improving leukemia treatment and prevention strategies in the future.

“The Role of Epigenetics in the Evolution of Multicellularity in Dictyostelium”

The evolution of multicellularity from simpler, unicellular organisms, was a pivotal moment in the history of biology and has transformed the ecological landscape of our planet. Despite the importance of this transition, it remains poorly understood how multicellularity arises from unicellularity. The slime mold *Dictyostelium discoideum*, represents a particularly attractive model through which to address this problem, as it exists in both unicellular and multicellular states and can easily be induced to transition between them. *Dictyostelium* undergoes dramatic morphological and physiological changes when food is scarce, transitioning from a single celled vegetative amoeba to a multicellular fruiting body within a day. As the same genome regulates *Dictyostelium* in its unicellular and various multicellular states, I hypothesize that epigenetic changes help drive cellular specification and multicellular stage transition. I have generated exciting preliminary data that suggests that both transcriptional regulation and epigenetic modifications control this transition. Here, I propose to extend these initial observations by using state of the art technologies to characterize at single-cell resolution the epigenetic and transcriptional alterations that occur in *Dictyostelium* as it transitions between unicellular and multicellular states. I will further perform a comparative epigenomic analysis of *Dictyostelium* with other unicellular and multicellular eukaryotes to identify epigenetic features that are shared within multicellular organisms. I will complement these analyses with directed epigenetic manipulations to test whether specific epigenetic modifications that I identify are necessary and sufficient to induce multicellularity. To address these questions, I propose the following specific aims:

Aim 1: To characterize the role of transcription factors (TF) in unicellular to multicellular transition in *Dictyostelium*

Aim 2: To determine the role of epigenetics in regulating multicellularity in *Dictyostelium*

These experiments will provide fundamental insight into the genetic and epigenetic mechanisms underlying the transition from unicellularity to multicellularity.

“The Effect of Inflammasome Activation in Hyperactive Dendritic Cells on Anti-Tumor T Cell Immunity.”

Dendritic cells (DCs) are unique in their ability to stimulate protective T helper 1 (Th1) and cytotoxic T lymphocytes (CTL) responses. Although toll-like-receptor (TLR)-activated DCs are viewed as capable of stimulating antigen-specific T cell responses, the clinical efficacy of DC-based immunotherapy using conventional TLR stimuli remains unsubstantiated. One of the reasons for this clinical failure is that we still lack a consensus on the optimal ways to stimulate DCs to generate long-lived protective immunity. TLR signaling alone fails to induce essential regulators for long-lived memory T cell generation, such as the secretion of interleukin-1 β (IL-1 β). IL-1 β release from DCs is commonly elicited by the FDA-approved adjuvant alum, which enables release of IL-1 β upon inflammasome-driven pyroptotic cell death. Despite this gain in activity, pyroptotic DCs are dead and cannot participate in the days-long process needed to stimulate T cells in the dLN. We hypothesized that the ideal strategy for inducing long-lasting anti-tumor immunity would be by generating hyperactive-DCs, whereby DCs can release IL-1 β while maintaining viability. We discovered that stimuli that hyperactivate DCs are uniquely capable of stimulating durable T cell mediated anti-tumor immunity. No other strategy of DC stimulation results in the ability of DCs to induce complete tumor elimination. The proposal herein is designed to explore the novel anti-tumor activities of hyperactive DCs. I will assess the mechanism(s) by which hyperactive DCs potentiate antigen-specific CTL responses (Aim1) and identify the endogenous hyperactive DC subset(s) in vivo that mediate anti-tumor protection (Aim2). These discoveries will provide the foundation to explore the novel anti-tumor activities of hyperactive DCs to the elderly population, which represent the ideal model to evaluate cancer immunotherapies. In summary, this study may shift the paradigm in DC-based immunotherapy, regarding the activation state employed in adoptive cell transfer, and may provide new venues to design protective cancer vaccines.

“Regulation of Cytosolic DNA Sensing Through cGAS Phase Separation”

Detection of cytosolic DNA is required for activation of the immune response to cancer and pathogen replication. Cyclic GMP–AMP synthase (cGAS) is a recently discovered immune enzyme that functions as a major sensor of cytosolic DNA. Once activated by binding to cytosolic DNA, cGAS synthesizes the second messenger 2'3' cyclic GMP–AMP (2'3'- cGAMP) to elicit downstream Type I interferon and NF- κ B signaling. Inappropriate activation of cGAS is a direct cause of severe autoimmunity, and loss of expression of cGAS signaling is associated with oncogenesis. Thus, precise regulation of cGAS activity is critical for the maintenance of immune homeostasis.

I am working to understand how human cGAS is regulated to accurately control cytosolic DNA sensing. Critically, my results provide the first structure of human cGAS in an active conformation and explain how cGAS-DNA-sensing in humans is adapted for enhanced control of immune surveillance (Zhou*, Whiteley* et al., Cell 2018). Very recently, evidence has emerged for a new form of regulation controlling cGAS function through liquid-liquid phase separation. However, why cGAS phase separation is required for cytosolic DNA sensing and how it is regulated are unknown. Here, I describe my research

plan that builds on my previous work and the new concept of cGAS phase separation to reveal how liquid droplet formation contributes to regulation of cytosolic DNA sensing.

My preliminary studies suggest that cGAS phase separation does not directly influence 2'3'- cGAMP synthesis and is instead critical to limit activity of the cytosolic exonuclease TREX1. I aim to further test and expand this working model. Specifically, I will determine the molecular mechanism of cGAS phase separation and define its role in resisting DNA degradation by TREX1. Insights from my mechanistic experiments will reveal a novel model of regulation that controls cGAS signaling during pathogen infection, autoimmunity, and antitumor immune responses.

“The dynamics of 3D genome structure during whole-body regeneration”

Select animals possess the remarkable capacity to regenerate their entire bodies from even a small fragment of the original host. An understanding of the molecular and genetic underpinnings of this capacity has potential to impact many areas of human health, including regrowth of missing structures and cancer. While whole-body regeneration has been studied extensively at the level of gene expression, little is known about how these genes are activated and repressed by the regulatory elements of the genome. Here, I propose to attain an understanding of how the three dimensional folding structure of the genome acts to promote the process of whole-body regeneration. I hypothesize that chromatin conformation is a crucial component to initiating and maintaining regeneration by orchestrating the necessary connections between target genes and their regulatory elements. As my first specific aim, I propose to perform chromatin conformation assays during regeneration in *Hofstenia miamia*, an acoel worm which is capable of robust regeneration. As a second aim, I propose to determine the role of architectural proteins in whole-body regeneration by knocking down their expression and performing chromatin conformation assays to determine how their role in restructuring the genome during regeneration. Taken together, this project represents the first attempt to understand how the physical structure of the genome is changed in order to orchestrate the regeneration of entire bodies.

“Mechanisms of Thyroid Hormone Mediated Bone Patterning”

The mechanisms underlying skeletal development, remodeling and repair during post-embryonic stages remain largely elusive. A comprehensive understanding of how bone morphology is established during development and maintained through subsequent bone remodeling and repair is of critical importance in treating bone diseases and injuries, and can enhance our ability to prevent ectopic bone growth such as bone spurs. The proposed research project builds on the novel finding that thyroid hormone plays a role in skeletal patterning, and employs a range of genetic, developmental and molecular approaches to investigate how thyroid hormone determines bone shape in the zebrafish caudal fin during both development and regeneration. The first aim will take advantage of a transgenic hypothyroid zebrafish line to characterize the roles of thyroid hormone in fin ray patterning and test the hypothesis that developmental exposure to thyroid hormone establishes permanent positional memory of branch location that can be re-deployed during regeneration. The second aim adopts a targeted approach to test the interaction between thyroid hormone, sonic hedgehog and retinoic acid signaling during branch formation. The third aim takes an unbiased approach to identify other genes and pathways involved in branch formation. By comparing transcriptome and chromatin landscape changes associated with fin ray

branching during development and regeneration, this aim will uncover novel genes and pathways underlying the establishment and redeployment of positional memory of branch location during fin outgrowth. Overall, the research proposed here will illuminate the mechanisms by which thyroid hormone regulates skeletal patterning, and will provide insights into how positional information is established and remembered. Moreover, this project will complete the molecular developmental biology and bioinformatics training of a scholar with a background in evolutionary biology, and will establish the foundation for his independent research laboratory.

“Unravelling the Role of Lipids in the Development of *Plasmodium falciparum* in the *Anopheles* Mosquito”

Anopheles gambiae mosquitoes are the primary vectors of *Plasmodium falciparum* in sub-Saharan Africa, a region devastated by malaria infections. Despite immense human disease burden the biological processes shaping *Plasmodium* transmission by the mosquito vector are still inadequately understood. *Anopheles* females feed on vertebrate blood in order to acquire nutrients for egg development (oogenesis). This process takes approximately 3 days and is largely orchestrated by the mosquito steroid hormone 20-hydroxyecdysone (20E). If the blood meal is infected with *Plasmodium*, parasite development begins in the *Anopheles* female midgut within minutes of ingestion and within 14 days mature infectious sporozoites invade the salivary glands. Oogenesis and the initial phases of parasite development are therefore temporally coupled within the female mosquito. However, until recently there was little evidence that the two processes may be physiologically linked. We have recently discovered a 20E-mediated positive correlation between mosquito egg and parasite oocyst numbers. We have also shown that impairing oogenesis by multiple manipulations of 20E signaling induces a concomitant decrease in parasite intensities. Intriguingly, these manipulations also accelerate *Plasmodium* growth rates, allowing sporozoites to become infectious sooner via the accumulation of mosquito lipids in oocysts, which are trafficked by the mosquito lipid transporter Lipophorin (Lp). In this project we propose to characterize the role of lipids in parasite development and transmission. Specifically, we will (i) identify Lp-cargoed lipid species affecting parasite growth as well as mosquito egg development; (ii) identify the parasite factors that mediate lipid uptake during mosquito stages; and (iii) assess the role of mosquito lipids in the infectivity of sporozoites to humans. These data will provide novel insights into the transmission biology of malaria parasites, aiding in the generation of new concepts and tools for preventing malaria transmission to humans.

“Understanding How Dicer Partner Proteins Establish microRNA Target Specificity”

MicroRNAs (miRNAs) influence every physiological process, and dysregulated microRNAs have been linked to human diseases, including cancer. MicroRNAs are processed from the double-stranded stem of stem-loop precursor RNAs (pre-miRNAs) by the ribonuclease Dicer. Human Dicer and fly Dicer-1 (Dcr-1) can also process long double-stranded RNA (dsRNA) into small interfering RNAs in vitro, but exclusively

make miRNAs in vivo. Moreover, Dicer can process some pre-miRNAs into multiple miRNA isoforms—i.e., isomiRs—whose cellular profiles change dynamically during differentiation and development. Here, I propose single-molecule biochemical and structural studies to answer the following questions: What restricts Dicer to miRNA processing? How do Dicer partner proteins affect kinetics of miRNA processing? How does Dicer make isomiRs?

In Aim 1, I will use single-molecule fluorescence microscopy to measure the kinetic behavior of fly Dcr-1 on long dsRNA or pre-miRNA substrates in the presence or absence of its partner protein Loquacious (Loqs). These studies will reveal if Dcr-1 rejects or inefficiently cleaves dsRNA, or if Loqs prevents Dcr-1 from binding or cleaving dsRNA. Using pre-miRNA substrates will reveal if Loqs enhances miRNA and isomiR processing by improving the binding or cleavage of pre-miRNAs. In Aim 2, I will use single-particle cryogenic electron microscopy to determine if Loqs induces isomiR production by changing the contour length of pre-miRNA stem or by changing the structure of Dcr-1. These studies take advantage of preliminary data, methods, and reagents available in the Zamore laboratory. Because alternative processing of pre-miRNAs by Dicer can change the entire target repertoire of miRNAs, understanding how Dicer selects and processes its substrates is essential for understanding how miRNAs regulate gene expression—in normal and disease cells—and for developing miRNA-based therapeutics.

“Ovarian Signaling: A Nexus for Interorgan Communication”

From development to adulthood, organs secrete signals to ensure proper growth and to maintain homeostasis during stable and stress conditions. These signals establish an interorgan communication network (ICN) that enables organs to harmoniously function together. While we are beginning to elucidate the identity of these signals and the interorgan axes that they establish, the role that reproductive organs have, particularly the ovaries, in communicating to non-reproductive organs remains poorly understood. The fruit fly *Drosophila melanogaster* has emerged as a model system for investigating the molecular genetic basis of ICNs, where one can identify and functionally manipulate interorgan communication signals.

I have identified reagents and developed a protocol that utilizes an established in vivo BioID protein labeling method to specifically label ovary-derived peptides. Once these labeled peptides are transmitted to their target organs, they can then be isolated and identified. With this method I will identify novel interorgan communication signals. In Aim1, I will use this method to label and identify secreted factors from the germline and somatic cells of the ovaries, and then determine their interacting organs. In Aim2 I will functionally manipulate these signals in the ovaries, using CRISPR and RNAi methods, and subsequently assay the status of non-reproductive organs including the gut, muscle, fat body, and brain, at a cellular and metabolic level. Finally, in Aim3 I will investigate the dynamic change in ovary-derived signals as a function of aging and malnutrition. Interorgan signals identified thus far are highly conserved, and several fly organs are analogous in function to human organs. Therefore, this project may yield novel insight into interorgan signaling in humans, predictions of how similar signals interact in the context of human aging and nutritional stress, and provide potential targets for disease models.

“Pan-Genome Wide Scale Analysis of the Evolution of Gene Essentiality in *Streptococcus pneumoniae*, and the Design of Synergistic Drug Interactions”

Streptococcus pneumoniae is a pathogenic bacterium frequently carried in the human nasopharynx, which triggers severe disease when it disseminates to the lungs or blood. Prevention of *S. pneumoniae* infection is achieved by vaccines, while an acute infection is controlled by antibiotic treatment. However, strains not included in current vaccines are becoming more prevalent, along with an alarming increase in antibiotic resistant infections as well. This creates an urgent need for the development of new antimicrobial strategies. One promising approach is the use of drug combinations that act synergistically. Essential genes connected through metabolic interactions are suitable targets for drug combinations. However, a new paradigm is arising, which suggests that essential genes have different probabilities of being compensated when inactivated, which can undermine their potential as a target. Over the last two years, I have used genomics approaches including Tn-Seq to collect a robust and high-confidence functional data set that describes essential genes in *S. pneumoniae*. Considerable limitations are imposed by the genetic background of a strain; meaning that some genes are not

essential in every strain. Here, I consider in detail the genetics of the bacterium *S. pneumoniae* in the context of its pan-genome. By integrating my results in functional and metabolic networks I have been able to identify several processes that could eventually be used as scaffolds for the design of synergistic therapies. In order to improve the power of these networks, I will pursue the following aims: In aim 1 I determine the potential (evolvability) of an essential gene to become non-essential; in aim 2 I identify the compensatory mechanisms present in the genome of strains that overcame the essentiality of a gene; and in aim 3 I rationally design and validate synergistic drug treatments based on the analysis of previous aims, using a mouse model of infection.

“Mechanism of epigenetic silencing by the HUSH complex”

This project has led to my interest in studying the co evolution of how newly integrated proviruses are incorporated into cellular programming and in turn how these provirus shape the cellular response. The HUSH complex bridges exogenous retroviruses and endogenous retroelements and may contribute to driving evolutionary adaptation of genetic networks. By gaining a better understanding of how exogenous reteroviruses are able to escape transcriptional control evolved to repress and limit the damage caused by parasitic genetic elements we can gain deep knowledge about the evolutionary pressures driving our evolution. Retroelements make up over 50% of our genome and the rules of how they are regulated by the genome and how they antagonize each other in a arms race will unravel many new discoveries about how we evolved and came to be. The major differences between us and our nearest relatives are not the coding sequences of proteins but the gene regulation of those proteins which may in part be driven by the need to regulate species specific transposable elements. By gaining a better understanding of how the HUSH complex recognizes and makes decisions as to what elements to repress it will unravel new interesting biology.

“The Biochemical and Molecular Pathogenesis of Batten Disease”

Neuronal ceroid lipofuscinoses (NCLs) are the most prevalent childhood neurodegenerative disease group with an incidence of 1 in 12,500 live births in the United States. These diseases are characterized by accumulation of lipoprotein aggregates (lipofuscin) in the lysosome and a progressive loss of vision, motor skills and cognitive abilities leading to early death. Juvenile neuronal ceroid lipofuscinoses (known as Batten disease) is the most common form of NCL and is caused by mutations in *CLN3* gene, which encodes a lysosomal transmembrane protein. *CLN3* has been implicated in many cellular processes but its exact molecular function remains elusive. Pinpointing the molecular function of *CLN3* will aid in deciphering how its loss drives the cellular changes that lead to the neurodegenerative symptoms typical of NCLs. Through our recently developed lysosomal metabolomics approach, we identified a group of phospholipid-derived metabolites (glycerophosphodiester, GPDs) to massively accumulate in the lysosome upon loss of *CLN3*. In this proposal, we hypothesize that *CLN3* is a lysosome transporter for GPDs, a function that is essential for maintaining neuronal cell function and survival. To test our hypothesis we will:

Aim 1: Determine whether *CLN3* is a transporter of GPDs in vitro and in vivo.

Aim 2: Determine how *CLN3* dysfunction alters phospholipid metabolism in the lysosome.

Aim 3: Determine the effects of GPDs accumulation in the lysosome on neuronal homeostasis in Batten disease models.

We believe that our work will establish a direct link between phospholipid metabolism and neurodegeneration and identify novel nodes that can be targeted to improve the management of Batten and other neurodegenerative diseases. In the long term, this work will set up a new paradigm for studying lysosomal storage diseases by focusing on the effects of gene mutations on lysosome-specific metabolism, which will help to better understand the molecular basis of these debilitating disorders.

“Understanding the Developmental Programs that Control Transcription in Inhibitory Neurons”

Dysfunction of inhibitory neurons underlies diverse neurodevelopmental and psychiatric disorders. To understand how such dysfunction can occur, it is important to understand how inhibitory neurons mature in the normal brain. Neurons undergo dynamic changes in morphology and function during brain development, and this process is associated with changes in expression of specific genes. However, the gene programs underlying this process are poorly understood. By analyzing gene expression profiles in specific inhibitory neuron subtypes over a developmental time-course, I have identified many genes with specific neuronal functions that become highly expressed during the early postnatal period, and

found that this process occurs in a neuron subtype-specific manner. The goal of this proposal is to uncover the molecular mechanisms controlling these developmental changes in gene expression. My preliminary results suggest that increases in gene expression are mediated in part by the activation of neuronal subtype-specific enhancers. These enhancers are significantly enriched for sequence motifs recognized by AP1 transcription factors, which are induced by growth factors and neuronal activity. Furthermore, by performing whole-genome DNA methylation analyses in specific neuron subtypes, I have found that DNA methylation patterns are dynamic at these enhancers such that methylation is actively removed during neuronal maturation. Based on these preliminary findings, I hypothesize that the maturation of inhibitory neurons is mediated by a combined action of extrinsic factors in a neuron's environment (e.g. neurotrophic factors or neuronal activity) and intrinsic factors (e.g. DNA demethylases) within the neuron that together lead to the licensing of enhancer sequences that control inhibitory neuron gene expression in a neuronal subtype specific manner. In this application, I propose two specific aims that will test this hypothesis: 1) Identification and functional testing of regulatory elements that control developmental gene programs in maturing neurons and 2) exploring the role of DNA methylation in controlling enhancers.

“The Role of Circulating aP2 in the Pathogenesis of Allergen Induced and Obesity Related Asthma and New Therapeutic Strategies Against Asthma Using anti-aP2 Agents”

Asthma is a chronic inflammatory airway disease with increasing prevalence and limited treatment options. The pathogenesis of asthma is not fully understood, importantly, it has a major immunometabolic component, as lipid mediators are directly promoting airway inflammation. Interestingly, accumulating evidence implicates obesity as an important risk factor for asthma, where these lipid mediators are upregulated. There is a great need for novel treatments for obesity-related asthma, which is less-responsive to conventional therapies.

The fatty acid binding protein aP2 is a fundamental immunometabolic regulator, which is increased in obese humans and mice. aP2 deficiency improves the dysregulated metabolic outcomes of obesity, diabetes and atherosclerosis, which share similar lipid derangements and immunometabolic underpinnings. Moreover, we reported that aP2 secreted from adipose tissue acts as an endocrine hormone, supporting inter-organ communication.

We detected elevated aP2 levels in bronchial epithelium and broncho-alveolar lavage fluid (BALF) in mice models of asthma and higher serum aP2 levels in overweight/obese asthmatic humans. Notably, aP2 expression in lung tissue and aP2 levels in serum and BALF were highly responsive to Th2 cytokines IL-4 and IL-13, important asthma regulators. Strikingly, aP2^{-/-} mice were markedly protected against allergen-induced asthma. We propose to study the role of aP2 in allergen-induced and obesity-related asthma and evaluate its potential as a therapeutic target in the following aims: 1) Determine the mechanistic role of aP2 in the pathogenesis of airway inflammation and hyperresponsiveness (AHR) in allergen-treated mice and in genetic models of obesity, 2) Examine the therapeutic activity of a neutralizing monoclonal anti-aP2 antibody and a small molecule inhibitor of aP2 in mouse models of asthma, and, 3) Determine the levels of aP2 in serum and BALF from asthmatic vs non-asthmatic overweight and obese humans. With this line of investigation, we hope to generate critical insights into

“Regulation of Immune Gene expression and Inflammatory Disease by the Cellular Nucleic Acid Binding Protein (CNBP)”

An inducible program of inflammatory gene expression is a hallmark of antimicrobial defenses. Germline-encoded receptors recognize microbial products and activate signaling pathways that lead to the expression of hundreds of inflammatory response genes. This proposal expands on these studies by defining a new regulator of immune gene expression; the CCHC-type zinc finger protein cytosolic nucleic acid binding protein (CNBP). We have generated mice lacking CNBP and found that CNBP-deficient macrophages fail to induce transcription of the IL-12/IL23 family. Cnbp resides in the cytosol of macrophages and translocates to the nucleus in response to multiple microbial ligands and pathogens. Cnbp regulates IL12 via c-Rel, an NFB/Rel family member known to control IL12 gene transcription. c-Rel nuclear translocation and DNA binding activity require Cnbp. Furthermore, Cnbp itself a DNA binding protein bound the IL12 promoter. CNBP-deficient mice were more susceptible to acute toxoplasmosis associated with reduced production of IL12, as well as a reduced Th1 cell IFN response essential to control parasite replication. Collectively, these findings identify Cnbp as a new signaling molecule downstream of multiple Pattern Recognition Receptors, that acts as a key regulator of IL12 gene transcription and Th1 immunity. This proposal will test the hypothesis that CNBP represents a novel signaling molecule that acts as a transcriptional coactivator to bind the genome and coordinate expression of IL12p40 to regulate IL12 and IL23 in innate cells and direct TH1/TH17 dependent adaptive immunity and inflammation. We will explore these hypotheses using the following specific aims: (1) defining detailed molecular mechanisms of CNBP-dependent control of the IL12/IL23 gene family; (2) defining the cell type specific contributions of CNBP in control of Th1 immunity to *Toxoplasma gondii* and TH17 responses to *Candida Albicans*; and (3) defining the role of CNBP in controlling Inflammatory Bowel Diseases using DSS colitis and related models.

“Systematic Analysis of Genetic Redundancy in the Wnt Signaling Pathway”

Wnt signaling is a highly conserved pathway for intercellular communication, with numerous critical roles during development and adult life in all multicellular animals. While the core components of this pathway have been characterized in great detail, both the ligands for this pathway and their receptors belong to large families of duplicated genes (paralogs), which retain partially overlapping functions in different contexts, and have therefore proven challenging to study via traditional loss-of-function genetic analysis.

I have developed two new potent and scalable techniques for studying redundant paralogs in *Drosophila*, and I propose to apply these tools to perform the first systematic analysis of redundancy amongst Wnt ligands and their receptors. Specifically, I will perform comprehensive pairwise double

knock-outs in multiple tissues using multiplexed CRISPR, and a series of targeted gain-of-function experiments using Cas9-based transcriptional activators. In Aim 1, I will generate and validate reagents for all pairwise double knock-outs and over-expression of the seven Wnt ligands and four Frizzled receptors. In Aim 2, I use these reagents to perform a systematic double knock-out screen in multiple tissues enriched for Wnt family gene expression. In Aim 3, I will adapt the “split-Gal4” technique to characterize, and gain genetic access to, the specific tissue domains that co-express pairs of ligands or receptors. Together, these studies will provide new mechanistic insight into how multiple closely related ligands and receptors for a single signaling pathway can shape pathway output in different cellular contexts. Because aberrant Wnt signaling is implicated in numerous diseases, these results may also have biomedical implications.

“Characterization of the Role for Non-canonical Wnt/Planar Cell Polarity (Wnt/PCP) Signaling in Growth and Self-renewal of Rhabdomyosarcoma”

Relapse is a major clinical problem in rhabdomyosarcoma (RMS), with continued tumor growth maintained by undifferentiated self-renewing tumor-propagating cells (TPCs). My long-term goal is to define therapeutically relevant pathways that maintain TPCs. The objective of this proposal is to characterize the role of the non-canonical Wnt/Planar Cell Polarity (Wnt/PCP) signaling pathway in RMS and uncover novel targets to inhibit relapse in patients. My work has defined a role for Van Gogh-like 2 (Vangl2), a core regulator of Wnt/PCP signaling, in self-renewal of RMS (Hayes et al., in press). VANGL2 knock-down inhibited growth, led to reduced TPC number, and increased differentiation of human RMS. In a zebrafish model, Vangl2 expression enriched for TPCs, revealing novel approaches to dynamically visualize cells in live animals and isolate them to further characterize TPCs on a molecular basis. The rationale for this work is that factors involved in Wnt/PCP signaling are highly expressed in the majority of human RMS and therapeutic strategies based on Wnt/PCP inhibition could potentially benefit many patients. Aim 1 will further assess the role for Wnt/PCP in tumor growth, testing my hypothesis that Wnt/PCP signaling regulates self-renewal and maintenance of TPCs in RMS. Aim 2 will characterize Vangl2 as a marker of TPCs in zebrafish ERMS, providing unprecedented access to dynamically visualize roles for the Wnt/PCP pathway in self-renewal and cell fate choices in vivo. Aim 3 will define the effector pathways downstream of Vangl2 and Wnt/PCP signaling, further elucidating roles of the small GTPase, RhoA. Given that factors involved in Wnt/PCP signaling are expressed in other tumor types, I expect my work will have significant translational impact by advancing the understanding of processes that affect self-renewal in human cancer. This work will also provide pre-clinical data supporting Wnt/PCP targeting for the suppression of RMS tumor growth in vivo.

“Platform for Study of Peptidoglycan and Lipid II Binding Molecules”

Antibiotic resistant bacteria, and methicillin-resistant Staphylococcus aureus (MRSA) in particular, account for 0.7 million deaths every year and thus present a significant global economic and health

burden. Many important antibiotics used in the clinic target bacterial cell wall synthesis, which is essential for cell survival. Peptidoglycan (PG), a major component of the cell wall, is synthesized from the lipid-linked precursor Lipid II. Our previous studies have shown that Lipid II is an essential and druggable substrate in the PG pathway and established methodologies to isolate and modify *S. aureus* Lipid II. These studies led to the development of a novel concept for Lipid II (or its glycopolymer) immobilization on a solid surface using enzymatic or chemical modification, where the immobilized Lipid II enables affinity-based characterization of Lipid II binding proteins and molecules that may reveal new antibacterial treatment strategies to supplement current approaches. Here, I seek to develop chemical tools enabling affinity-based study for proteins and small molecules that bind Lipid II or nascent peptidoglycan glycopolymer. My research will apply multidisciplinary approaches to develop technologies for discovering new antibiotics and protein targets, to understand the biogenesis of bacterial cell wall, and to exploit this knowledge for designing new treatments. The Walker lab and Harvard Medical School provide an ideal environment for my research with unique resources that will enable me to conduct the proposed research and continue building additional skills. The proposed research integrates chemical biology and bacterial genetic approaches with the aim of providing insight into our understanding of protein networks governing peptidoglycan synthesis, identifying potential targets for development of new therapeutics, and applying this methodology to other important pathogens. The research and career development plan I proposed will provide the basis for me to make significant contributions to the microbial pathogenesis research community.

“Convergent and Divergent Coding in Insular Cortex and Amygdala Across Hunger and Thirst”

Physiological need states, such as hunger and thirst, produce powerful motivations to obtain specific goals, such as food or water. Yet it remains unknown how the specificity of goal-seeking is achieved. How is one goal prioritized over another to satisfy the current physiological need? (e.g., water-seeking but not food-seeking during thirst).

Human neuroimaging studies implicated insular cortex (InsCtx) in these phenomena. However, it remained unknown how InsCtx activity guides action based on current physiological state. We have recently investigated the influence of hunger on InsCtx processing of food-predicting cues. We developed a microprism-based method for cellular-resolution imaging of InsCtx in behaving mice. InsCtx neurons demonstrated food cue-biased responses that were abolished following satiation. Circuit mapping and pathway-specific manipulations uncovered an underlying pathway linking hypothalamic “hunger neurons” (AgRP-expressing) to InsCtx, via paraventricular thalamus and basolateral amygdala (BLA).

This proposal builds on these findings to explore how specificity of need-driven goal-seeking is achieved. We hypothesize that InsCtx receives predicted reward information from BLA and combines this with current physiological state information. Thus, InsCtx produces specific predictions of whether the associated outcome will satisfy current physiological need (“how will this make me feel?”). We will test this hypothesis by contrasting InsCtx and BLA→InsCtx responses to food-and water-predicting cues during hunger and thirst in the following aims:

1. Determine whether InsCtx neurons respond to water-predicting cues during thirst but not after its quenching, and whether this can be rescued by activation of “thirst neurons”.
2. Determine whether different InsCtx neurons respond to distinct need-relevant cues specific to hunger or thirst.
3. Determine whether BLA→InsCtx neuronal responses to reward-predicting cues are not specific to distinct need states (hunger/thirst).

These experiments should provide important insights into decision making during natural and pathological need states that underlie various clinical conditions, from compulsive eating to drug addiction.

“Molecular Dissection of MDA5 Filament in Antiviral Immunity”

Effective immune defense against viral infection is dependent upon efficient detection of viral RNA by innate immune receptors. One such receptor is MDA5 that recognizes double-stranded RNAs (dsRNAs) originated from a broad range of viruses and elicits the type I interferon response to restrict viral propagation. While its proper function is critical for host defense against viral infection, mis-regulation of MDA5 causes a variety of auto-immune and auto-inflammatory diseases. More recently, MDA5 was also shown to be important for successful cancer immunotherapies. Despite the importance, deep molecular mechanisms of how MDA5 recognizes viral RNAs and activate signaling are incompletely understood. Previous studies from the Hur lab showed that MDA5 forms filaments upon dsRNA binding and filament formation is required for signal activation. However, key molecular events that occur between filament formation and signal activation remain poorly characterized. The goal of my research is to dissect these poorly understood molecular events using a combination of structural biology and biochemistry. In particular, my current focus is on the role of ATP binding and hydrolysis by the MDA5 helicase domain, the activity implicated in multiple functions, including MDA5 filament regulation and auto-inflammatory diseases. Using a combination of cryo-electron microscopy, biochemistry and cellular assays, I am currently investigating the structural basis for ATP-mediated MDA5 filament disassembly and the role of ATP in regulating of MDA5 auto-repression. This work builds upon my previous work in the Hur lab, which led to one co-first authored publication in Cell and another first authored manuscript under revision in Nucleic Acid Research. Together with my expertise from Ph.D. in virology, I believe the proposed work in structural biology and biochemistry will help me achieve my goal of becoming an independent scientist who explores new important questions in host-virus interaction using a multi-disciplinary approach.

“Dissection of Self/Non-self Nucleic Acid Recognition and Signaling”

A long-standing question in eukaryotic gene regulation is how, and to what extent, are the nuclear events of transcription and splicing coupled to the subsequent cytoplasmic events controlling mRNA

translation. Argonaute systems provide potential links between these fundamental steps in gene expression. In *C. elegans*, Argonautes engage both mature cytoplasmic transcripts and nascent nuclear transcripts. For example, the Argonaute CSR-1 binds chromatin and mRNAs of active genes, while WAGO Argonautes target silent genes and mRNAs. This connection is best understood for the WAGO/silencing pathway wherein chromatin factors, including homologs of Polycomb and heterochromatin protein 1 (HP1), are required for WAGO-mediated silencing. Thus, mRNAs produced within silent chromatin are thought to feed the amplification and maintenance of silencing, while mRNAs produced within euchromatin are somehow protected. Recently, I analyzed mRNA targeting by a third Argonaute system in the germline, the piRNA/Piwi Argonaute pathway. Targeting by piRNAs, which are genomically encoded, triggers WAGO-dependent silencing. My analysis revealed that piRNA targeting follows microRNA-like “seed” and supplementary base pairing rules. Surprisingly, even expressed mRNAs, although protected from piRNA-induced silencing, are abundantly targeted by piRNAs within both their open reading frames (ORFs) and untranslated regions (UTRs). I hypothesize that the piRNA pathway senses features of mRNAs that reflect their origin within euchromatin or heterochromatin and, in response to these cues, recruits distinct downstream factors that regulate the fates of their target mRNAs. Here, I will explore the downstream factors recruited to mRNAs by piRNA targeting (Aim 1) and the upstream factors that modulate targeting (Aim 2). I will also search for new factors that influence transcriptome surveillance and epigenetics (Aim 3). This study will uncover fundamental mechanisms that link transcription and translation in the germline, and perhaps other tissues, and will further our understanding of epigenetic programming important in both normal development and disease.

“Deciphering the Deregulated Network Driven by Transcription Factor Isoform Switching in Melanoma”

Accumulation of genomic mutations within oncogenes or tumor suppressor genes is widely seen as the primary cause of cancer progression. However, another mechanism of molecular perturbation, likely just as important yet vastly understudied, is the widespread changes in alternative splicing typical of all cancers. Indeed, alternative splicing changes the composition and expression levels of protein isoforms, drastically remodeling the cancer transcriptome and proteome. These changes are particularly impactful in the rewiring of gene regulatory networks (GRNs) through changes in the primary structure of transcription factors (TFs). Despite recent studies correlating isoform expression with cancer phenotypes, how cancer TF isoforms functionally impact cancer progression remains largely unknown. Therefore, new global approaches are needed to dissect the mechanistic implications of dysregulated splicing on GRNs at genome-scale.

We have selected melanoma as a model system to initiate global studies of cancer-specific TF isoforms. In my preliminary studies, I observed that MITF, a central factor in melanocyte differentiation whose locus is frequently amplified in melanomas, undergoes an isoform switching event by which non-melanocyte MITF forms become the dominant isoforms. Here, I will comprehensively discover melanoma-specific TF isoforms using a novel isoform capture technology that I developed. This technology enables enrichment of transcripts from target genes of interest for their subsequent full-length sequencing, creating a deep-coverage census of aberrant splice changes correlated with melanoma. I will perturb the expression of these isoforms in melanoma short term cultures to assess their functional effects on melanoma proliferation and growth. Furthermore, to understand the

underlying mechanisms of differential isoform functions, I will employ a high-throughput functional profiling platform I helped develop where I will map changes in protein-protein/protein-DNA interactions between normal and cancer specific isoforms. This work will set a new paradigm for assessing the global rewiring of cancer-specific networks and will likely result in precise therapeutic targets.

“Elucidation of Molecular and Cellular Events that Drive Ocular Tissue Regeneration in Axolotls as a Basis for Future Therapeutic Approaches”

Incurable eye diseases that cause blindness currently affect eleven million Americans. Loss of vision is due to degeneration of retina cells, a destroyed optic nerve, or a cloudy lens, all associated with the pathophysiology of common eye diseases including age-related macular degeneration, diabetic retinopathy, glaucoma and cataracts. My plan is to induce autologous regeneration, so the human eye can repair itself and restore function. To accomplish that I will study how regeneration of ocular tissues occurs naturally in axolotls. These amphibians have tremendous regenerative abilities and a wealth of available genetic and molecular tools that will enable me to study the mechanism in detail. My long-term goal is to find how amphibians utilize the eye's pigmented epithelium to regenerate the retina and the lens following injury, and translate this mechanism to innovative medical treatments. I will focus on axolotl lens regeneration; following removal of the whole lens, the iris pigmented epithelium (IPE) will reprogram to regenerate a new lens in just three days. Using this model, I can tease apart the molecular and cellular events involved in regenerating a new ocular tissue. My experimental design utilizes cutting-edge axolotl editing technologies including novel transgenic as well as CRISPR/Cas9-based knock-in and knock-out animals, to unbiasedly investigate: (SA1) a previously identified candidate gene for axolotl lens regeneration, Eyes Absent 2 and its role during IPE cell reprogramming, and (SA2) whether specific IPE cell subpopulations are responsible for lens regeneration. These experiments will provide fundamental insights on the molecular and cellular mechanisms underlying the reprogramming of the pigmented epithelium during regeneration of ocular tissues. Understanding how this process is controlled naturally in amphibians is critical to safely induce autologous regeneration in humans. Translating this mechanism to the clinic will revolutionize regenerative medicine and provide groundbreaking treatments to incurable human eye diseases.

“Elucidate the Cellular and Molecular Mechanisms for Slow Wound Healing Upon Chemotherapy”

Chemotherapy combined with surgery is the most prevalent approach to treat cancer. However, chemotherapy leads to significantly delayed injury repair in the skin. Slow wound healing hinders surgical recovery and increases the chance of life-threatening infections. These side effects increase the mortality rate and create physical and emotional burdens for cancer patients and caretakers. Nevertheless, the cellular and molecular mechanisms leading to delayed wound healing upon chemotherapy remain poorly understood. This gap in knowledge prevents the development of

strategies to enhance injury repair in chemotherapy patients.

Chemotherapeutic drugs ablate fast-dividing cells. Most somatic stem cells rarely divide and are spared during chemotherapy. By contrast, stem cells' fast-dividing progeny, transit-amplifying cells (TACs), are often destroyed. Work published from the Hsu lab, including my own, suggest that TACs of the hair follicle (HF-TACs) play diverse regulatory roles in the skin. My preliminary data further suggest that HF-TACs are indeed ablated by chemotherapeutic agents. Moreover, my preliminary data suggest that HF-TACs are involved in wound repair. Therefore, loss of HF-TACs might be the basis for the slow wound healing observed during chemotherapy.

My objective is to elucidate the cellular and molecular mechanisms by which HF-TACs regulate skin injury repair and to identify genes and/or pathways that can enhance wound healing under chemotherapy. My central hypothesis is that HF-TACs govern changes in diverse skin cell types to promote wound healing through secreted factors. In Aim1, I will focus on delineating the function of Sonic Hedgehog (SHH, a known HF-TAC secreted protein) in wound healing. In Aim2, I will test the function of other secreted proteins expressed by HF-TACs in promoting wound healing during chemotherapy. Results from these aims will be the foundation to new therapies that can promote injury repair in cancer patients that have undergone chemotherapy and surgery, thereby enhancing treatment efficacy.

“Colonization, Dissemination, and Transmission of the Enteric Pathogen *Listeria Monocytogenes*”

L. monocytogenes is Gram-positive foodborne facultative intracellular pathogen that can disseminate from the gastrointestinal tract to distal sites and cause systemic infection. Numerous studies have been performed of bacterial and host factors that mediate its internalization and intracellular spread, as well as of the host response to intracellular bacteria. In contrast, there has been minimal analysis of *L. monocytogenes* as an enteric pathogen, and the genetic requirements for *L. monocytogenes* colonization of the GI tract have not been determined. In addition, little is known about how *L. monocytogenes* responds to the harsh environment within the gallbladder, a distal colonization site that we found is the source of fecally shed bacteria, nor about how the gallbladder responds to the presence of the pathogen.

Using a murine model of infection, we determined that a relatively small number of bacteria (generally <100) give rise to the population at each colonization site, despite use of large infectious doses. However, we have found that pretreatment of mice with streptomycin markedly augments these “founding populations”, and thereby enables analysis of bacterial factors required for colonization using transposon insertion libraries (TnSeq).

The long term objective of this proposal is to understand how pathogen and host factors control the proliferation of *L. monocytogenes* within the gastrointestinal tract and gallbladder, in order to better combat pathogenesis and improve the biosafety of *L. monocytogenes*-based vaccines. Toward that end, we propose to:

1. Characterize the genetic requirements for *L. monocytogenes* to overcome host defenses and colonize the gastrointestinal tract.
2. Analyze the interplay between *L. monocytogenes* and the gallbladder.

Using several high throughput approaches, and a selection of bacterial mutants and knock-out mice, we will identify bacteria factors that *L. monocytogenes* relies on to colonize the gastrointestinal tract and gallbladder, and also define the gallbladder transcriptional response to *L. monocytogenes* infection.

“The Effect of Gasdermin E Cleavage by Caspase-3 and Granzymes on Inflammation and Tumor Responses to Chemotherapy and Tumor Immunity”

Pyroptosis, the inflammatory death triggered by cytoinvasive pathogens and danger signals was mediated by inflammatory caspase cleavage of gasdermin D (GSDMD). The N-terminus of cleaved gasdermin D forms pores in the membrane to permeabilize and kill the cell and release inflammatory cytokines. GSDMD belongs to a family of six homologous human gasdermin (GSDM) proteins, most of which exhibit pore-forming activity. However, how other family members are activated is unknown. An exception is GSDME. Two recent studies found that GSDME is cleaved and activated by caspase-3, the key effector caspase protease in apoptosis, suggesting that noninflammatory apoptosis secondarily activates pyroptosis. I found that two granzymes, the death-inducing serine proteases in NK and Cytotoxic T cells, also cleave GSDME to liberate an N-terminal fragment that causes cell death. GSDME are expressed in many normal tissues but its expression is diminished in multiple human cancer cell types because of promotor hypermethylation. Moreover, spontaneous GSDME mutations have been found in many cancers. I hypothesize that loss of GSDME expression or loss-of-function (LOF) mutations protects cancer cells from inflammatory death induced by caspase-3 and granzymes to promote tumor survival and growth. Furthermore, I hypothesize that proinflammatory cytokines and other inflammatory mediators are released in a GSDME-dependent manner during pyroptosis, which activates immune responses to the tumor and enhances the effectiveness of chemotherapy, i.e. that GSDME activation of pyroptosis leads to “immunogenic” tumor cell death. In this proposal, I will determine if GSDME cleavage causes secondary pyroptosis and whether cancer cells inactivate GSDME to avoid caspase-3 or Gzm-induced pyroptosis. I will also use mouse model to determine the roles of GSDME and pyroptosis in cancer cell elimination. Understanding this new inflammatory pathway that some cancer cells evade may provide insights into developing novel cancer therapeutics and understanding drug resistance.

“MYC-driven Core Regulatory Circuits in Neuroblastoma”

Despite their known importance in cancer, direct targeting of MYC and MYCN as a therapeutic strategy in pediatric tumors such as neuroblastoma has proven extremely challenging. However, we now know

that in tumor cells, MYC functions in concert with a small group of highly expressed transcription factors referred to as the core regulatory circuit (CRC) that uniquely establishes cellular identity and disease states. In neuroblastoma, this CRC includes the highly expressed transcription factors HAND2, ISL1, PHOX2B, GATA3 and TBX2, which along with MYC or MYCN, form a feed-forward autoregulatory loop that regulates the entire cellular transcriptome. The goal of this proposal is to understand how the malignant state of neuroblastoma cells is supported by the CRC, and how this process can be exploited for the benefit of patients. My central hypothesis is that disruption of the CRC and the signaling pathways it regulates will result in loss of malignant cell viability and provide novel strategies for targeted therapy. Furthermore, by elucidating the epigenetic mechanisms through which maintenance therapy with retinoic acid regulates the neuroblastoma CRC, I will provide critical insights that will inform the development of future treatments. The specific aims for this project are: 1) dissect the specific mechanisms by which disruption of individual core regulatory circuitry (CRC) component genes inhibit the growth and survival in human neuroblastoma cells.; and 2) determine the epigenetic mechanisms through which retinoid-based therapeutics reprogram the neuroblastoma CRC and lead to differentiation, arrest or apoptosis in human cells and PDX tumors in mice. The information gained from these approaches will be critical to the rational design and use of circuitry-directed therapeutics that will be used to treat malignancy on a disease-specific basis.

“Regulation of Macrophage Activation by Mitochondrial Metabolism”

Macrophages form an innate immune line of defense against invading pathogens. During a microbial infection, macrophages respond to LPS, a component of gram negative bacteria, by upregulating inflammatory cytokine production and antimicrobial activity. While LPS activation is important for host defense during microbial infection, exaggerated inflammatory responses impair tissue functions and must be restrained by negative feedback mechanisms. Indeed, sustained exposure to LPS stimulates entry to an unresponsive state called LPS tolerance, in which macrophages are profoundly refractory to LPS stimulation and fail to induce an inflammatory response. How macrophages coordinate the switch between induction and suppression of inflammatory responses to allow for optimal host defense yet limit excessive and maladaptive inflammation is not known.

Our preliminary studies demonstrate that, upon LPS signaling, AKT mediated glucose utilization impinge on the mitochondria to determine the state of macrophage activation or tolerance. A critical regulator of this process is GPD2, a component of the electron transport chain (ETC) that receives electrons from glycolysis to link glucose utilization to electron transport chain activity. Acute/low dose LPS signaling stimulates GPD2 activity to increase ETC activity, TCA cycling, Ac-CoA availability, and histone acetylation at inflammatory genes. However, sustained/high dose LPS signaling prolongs glucose utilization to saturate electron transport capacity, leading to reduced Ac-CoA availability and histone acetylation at inflammatory genes. In this way, mitochondria monitor the extent of LPS signaling to orchestrate the switch between LPS activation and tolerance.

The goal of this project is to further test the working model proposed above. Specifically, I will determine the roles of Akt, glucose utilization, and GPD2, in regulating LPS activation and tolerance. I will also determine if GPD2 regulates inflammatory response induction and suppression in vivo. These studies will reveal novel modes of regulation that control macrophage function in the context of inflammatory diseases.

“Structural Characterization of Silent Chromatin Domains by Single Particle Cryo-EM”

Transcriptionally silent and structurally distinct chromatin domains, known as heterochromatin, play critical roles in gene expression regulation, cellular identity, and chromosome stability in eukaryotic cells. Heterochromatin nucleation at specific genomic loci requires specific DNA sequences and associated proteins, which recruit effector complexes that contain both histone-modifying activity and

modification-binding domains. Following initiation, the effector complexes spread out tens to hundreds of kilobases without sequence specificity, presumably by stepwise modification and binding to nucleosomes.

The structure and functions of heterochromatin are strikingly conserved through evolution. Homologous complexes of human heterochromatin machinery have been identified in other mammals, flies, and unicellular fission yeast. However, despite considerable progress in characterizing heterochromatin systems in various model organisms, models of heterochromatin formation, epigenetic inheritance, and function remain largely speculative, due to the absence of high resolution structural models of heterochromatin.

My postdoctoral research has focused on quantitative studies of heterochromatin as a biomolecular assembly process. I arrived at a new understanding of how yeast silencing complexes organize on chromatin to form heterochromatin domains. Here, I describe a research plan that builds on my previous work to determine the first atomic resolution models of heterochromatin domains by cryo electron microscopy. Preliminary negative stain EM images of single particles and the resulting class averages confirm the success of the proposed strategy in structural characterization of heterochromatin. Ultimately, the findings are expected to provide fundamental insights on how silencing factors change the structure of chromatin and restrict access to DNA.

“The Physiological Role and Regulation of Splicing Factor 1 in Aging and Longevity”

Aging is driven by a loss of cellular and organismal homeostasis, and is the key risk factor for multiple chronic diseases. Interventions that attenuate or reverse systemic dysfunction seen with age therefore have potential to reduce overall disease risk and prolong healthy years in the elderly. Dietary restriction (DR) is currently the most potent intervention known to increase health- and lifespan and protect against multiple chronic diseases. Loss of protein and transcriptional homeostasis are well-established causes of aging. However, a link to RNA homeostasis and splicing fidelity, key processes in the central dogma of molecular biology, in aging was largely unexplored. Using in vivo splicing reporters in *C. elegans* and RNA-Seq, we recently showed that RNA splicing deregulates with age and DR promotes longevity via increased pre-mRNA splicing efficiency. I identified splicing factor 1 (SFA-1) to be specifically required for DR and target of rapamycin complex 1 (TORC1)-mediated longevity. Further, we identified TOR signaling as a mediator of the effects of *sfa-1* in DR. Our transcriptome data suggest that SFA-1 mediates longevity via regulation of lipid metabolism. Lastly, increased expression of SFA-1 is sufficient to extend lifespan of wildtype nematodes, suggesting that interventions targeting RNA splicing present novel therapeutic avenues for age-onset diseases.

The current proposal aims at specifying the role and mechanism of SFA-1 in aging and longevity. First, I aim to define the downstream physiological effects and targets of *sfa-1* to promote healthspan, lifespan extension and in DR/TOR-mediated longevity. The second aim will delineate the regulation of *sfa-1* in aging and by TORC1 on translational level. I will combine *C. elegans* and mammalian tissue culture approaches to assess the mechanistic link between *sfa-1* and TOR signaling in splicing regulation. Together, this proposal will lead to increased mechanistic understanding of SFA-1 both on gene and

“Circuit Mechanisms Underlying Sustained Behavioral States in *C. Elegans*”

The internal state of our mind--whether we are sleepy or alert, motivated or satiated--can have profound influences on our behavior. Despite much effort in research, we still lack circuit-level understanding of how internal brain states are generated and maintained over long time scales. Past studies have revealed a key role of neuromodulators, such as serotonin and dopamine, in impacting brain states. However, only in a few cases have we successfully uncovered the circuit-level mechanisms by which neuromodulation impacts internal and behavioral states.

In this study, I will use *C. elegans* as a model to examine circuit-level mechanisms underlying internal brain states and their control by neuromodulation. Many behaviors of *C. elegans* are modulated by the satiety state of the animal. When exposed to food, *C. elegans* exhibits two long-lasting locomotory states, the roaming state and the dwelling state, during which the animals exhibit sharp contrast in locomotory speed. A recent study by Dr. Flavell found that serotonin and the pigment dispersal factor (PDF) function antagonistically to extend the durations of roaming and dwelling, respectively. It remains unclear what types of circuit activity underlie the roaming-dwelling states, and how neuromodulatory effects propagate through its immediate target neurons to exert global impact on the circuit.

To address these open questions, I propose to image circuit-wide neural activity in freely moving animals during roaming and dwelling behaviors. I will then use a combined computational and experimental approach to identify the circuit-wide activity patterns that causally impact the roaming-dwelling states. Next, I will measure and analyze circuit activity patterns in mutant animals with disrupted neuromodulation. Finally, I will use data-driven network modeling to decipher the mechanism by which neuromodulation impacts circuit-wide activity states. This study will be one of the first to connect circuit dynamics with network topology, neuromodulation, and emergent behavior.

“Identifying and Functional Characterizing Imprinting Control Regions of Novel DNA Methylation-Independent Imprinting Genes”

Genomic imprinting is an allelic gene expression phenomenon that is controlled by differential DNA methylation at the imprinting control regions (ICR). Imprinted genes play important roles in a wide range of biology processes and dysfunction of these genes is the cause of several human syndromes. Despite the role of DNA methylation in controlling imprinted gene expression, recent studies have revealed several genes that exhibit DNA methylation-independent imprinted expression, raising the possibility that novel imprinting mechanisms may exist. By comprehensive mapping of allelic-specific DNase I hypersensitive sites (DHSs) and gene expression using physically-separated parental pronuclei, as well as gynogenetic embryos, we identified several dozen paternally-expressed genes that harbor paternal allelic DHSs (Ps-

DHSs) that are highly enriched for tri-methylation H3K27 (H3K27me3) but devoid of DNA methylation in maternal allele. Importantly, ectopic removal of the H3K27me3 turns Ps-DHSs into bi-allelic DHSs and induces maternal allele expression in genes that include all the known DNA methylation-independent imprinted genes *Gab1*, *Sfmbt2*, *Slc38a4*, and *Phf17*. These results establish maternal H3K27me3 as a novel DNA methylation-independent genomic imprinting mark.

The discovery of the novel imprinting mechanism and the identification of new non-canonical imprinted genes provide me the opportunity to dissect the novel imprinting mechanism. Toward this goal, I propose to identify and characterize ICRs of this group of non-canonical imprinted genes with the following two aims:

- 1) Define the ICRs of the H3K27me3-controlled imprinted genes through integrated analysis of allelic H3K27me3, allelic DHSs, and allelic gene expression affected by H3K27me3-specific Kdm6b injection;
- 2) Functionally validate putative ICRs by CRISPR-based epigenome editing.

Completion of the proposed study will not only identify ICRs of the newly discovered non-canonical imprinted genes, but also prove that H3K27me3 as a novel imprinting mark. Understanding this novel imprinting mechanism has important implications for understanding imprinting related disorders.

“Alleviating Solid Stress to Enhance Immunotherapy in Metastatic Breast Cancer”

Metastatic breast cancer (mBC) is the chief cause of mortality among breast cancer (BC) patients. Our incomplete understanding about many aspects of the microenvironment of BC metastatic lesions currently hinders our treatment of the disease. In this fellowship application, I will explore how mechanical forces in the mBC microenvironment affect its immune evasion and resistance to immunotherapy. In primary BC, the mechanical pressure accumulated within the solid components of the tumor-- termed solid stress-- is elevated, and causes pronounced vascular compression. This vascular compression leads to decreased blood perfusion and increased hypoxia, both of which promote BC immunosuppression. The cause of elevated solid stress in primary BC is desmoplasia, characterized by high levels of cancer-associated fibroblasts and extracellular matrix deposition. Primary BC desmoplasia and solid stress can be reduced using angiotensin II receptor 1 blockers (ARBs). What remains unknown, however, is whether solid stress elevation in the metastatic setting of BC is also associated with desmoplasia, angiotensin II signaling and hypoxia, and what are the consequences of elevated solid stress on the tumor immunology of mBC. I will address these questions by modulating solid stress in a mouse model of triple-negative BC brain metastases through direct mechanical manipulation (Aim 1) and pharmacological inhibition of angiotensin II signaling (Aim 2). In the pharmacological approach, I will use a novel ARB-based therapeutic that becomes selectively activated in the mBC microenvironment, minimizing systemic side effects. I will characterize the changes in the immune microenvironment in response to solid stress alterations. Importantly, I will test whether alleviation of solid stress can improve the outcome of immune checkpoint inhibitors in mBC. By elucidating the contribution of solid stress to mBC immunosuppression, the proposed work will lead to new paradigms for treating mBC, where anti-desmoplastic agents are rationally applied to enhance the efficacy of promising immunotherapeutics.

“Studying Methionine Flux and its Role in Aging and Neurodegeneration”

Aging is a risk factor for various human pathologies including neurodegenerative diseases. Using targeted high-throughput metabolite profiling in *Drosophila melanogaster* at different ages, we have demonstrated that methionine metabolism changes during aging. Methionine generates the methyl donor, S-adenosylmethionine (SAM), which is converted via methylation to S-adenosylhomocysteine (SAH). Ahcy13 is the only known enzyme and the rate-limiting step in the conversion of SAH into homocysteine. Elevated homocysteine level in human plasma is a known risk factor for dementia, Alzheimer's disease, and stroke. Understanding how the flux via methionine metabolism is reprogrammed with age will help develop strategies that prevent its age-dependent changes and have a great impact on human health.

We previously showed that SAH accumulates with age and that downregulation of dAhcyL1/dAhcyL2, which can heterotetramerize with Ahcy13 and inhibit its function, extends life- and healthspan. Based on our model, downregulation of dAhcyL1/dAhcyL2 activates Ahcy13 that promotes SAH and homocysteine processing, activates flux via methionine metabolism and phenocopies the effect of methionine restriction (MetR). However, how the flux via methionine metabolism is reprogrammed into alternative pathways during aging is unknown, representing the critical knowledge gap. My central hypothesis is that tissue-specific activation of methionine flux promotes SAH and homocysteine processing and extends *Drosophila* health- and lifespan. An important corollary of this hypothesis is that activation of methionine flux can improve healthspan of *Drosophila* models with age-dependent neurodegeneration. Ultimately, translating findings from the *Drosophila* model to mammalian systems may provide better therapeutic options for patients with age-dependent neurodegenerative diseases.

To address my hypothesis, I propose two Specific Aims:

Aim 1: Test whether downregulation of dAhcyL1/dAhcyL2 prevents muscle and brain age-dependent changes, and improves healthspan of *Drosophila* models with age-dependent neurodegeneration.

Aim 2: Determine how aging reprograms methionine flux and establish *Drosophila* genetic MetR model for characterizing tissue-specific effects of MetR.

“The Killer Protein Gasdermin D: Activation Mechanism and a New Potential Therapeutic Target”

While inflammation is an important defense mechanism against pathogens and other types of dangers, it often causes serious human diseases when overactivated. One source of inflammation is elicited from intracellular macromolecular complexes dubbed as inflammasomes, which activates inflammatory caspases such as caspase-1 and caspase-11. Activated caspases cleave pro-IL-1 β and other pro-inflammatory cytokines into the active isoforms thus amplifying the inflammatory response. For a long time, it is known that inflammasomes also induce a form of pyroptotic cell death characterized by cell

lysis. However, the specific molecule involved in pyroptosis was not elucidated until recent research indicated that caspase-1 cleaves Gasdermin D (GSDMD), a member of the Gasdermin superfamily, to cause cell death. Our preliminary studies show that the GSDMD N-terminal fragment triggers pyroptosis by forming pores that compromise the integrity of the cell membrane. Therefore, inhibition of pyroptosis by targeting GSDMD may represent a unique therapeutic strategy to limit cell death and overt inflammation. In this application, I propose systematic studies on elucidating the pore assembly mechanism of Gasdermin D, and on identifying small molecule inhibitors against the pore formation. The molecular understanding on how the N-terminal region of Gasdermin forms lytic pores would not only provide new insights on the mechanism for pyroptosis but also afford a new therapeutic strategy for human diseases especially sepsis and other inflammatory diseases.

“The Type 3 Secretion System Translocon Pore in Bacterial Pathogenesis”

Diarrhea is a leading cause of death and morbidity of children less than 5 years old. Globally, Shigella is the leading cause of diarrhea in children. To cause disease, Shigella invades and spreads among intestinal epithelial cells; both invasion and spread requires activity of a type 3 secretion system (T3SS). T3SSs are required for the virulence of approximately 30 different bacterial pathogens that cause disease in humans. Contact with a mammalian cell activates the T3SS to form the translocon pore in the membrane of the cell. This pore is essential for the T3SS to deliver virulence proteins into the mammalian cytosol. T3SSs, including the translocon pore, are highly conserved and further understanding of how they function will likely identify conserved virulence strategies shared among these human pathogens. At invasion, the T3SS translocon pore interacts with intermediate filaments, structural proteins in mammalian cells. This interaction enables docking of Shigella to cells by unknown mechanisms. Docking activates secretion of virulence proteins through the T3SS. In contrast to invasion, Shigella spread requires T3SS activity, but it occurs without intermediate filaments. The overall goals of this project are to investigate how the translocon pore supports Shigella infection and to test whether the translocon pore can be used as a therapeutic target to block infection. Aim 1: To test whether the conformation of the translocon pore protein IpaC is different in docking competent versus docking incompetent translocon pores. Aim 2: To test whether docking is required to activate secretion of virulence proteins. Aim 3: To test whether the conformation of the T3SS translocon pore can be manipulated. Due to the conserved and important role of T3SSs among bacterial pathogens, this proposal is likely to identify novel bacterial virulence mechanisms that have the potential to be exploited for the development of new therapeutic interventions.

“Mechanisms of Microtubule-Based Transport via Organelle Contacts”

Eukaryotic cells use microtubule-based transport and molecular motors for the delivery of vesicles and organelles required for cell growth, maturation, and survival. Perturbations in microtubule-based transport are an early hallmark of neurological diseases. My long-term goals are to determine how

movements of a diverse set of cargos are spatially and temporally regulated in cells, and how they go awry in disease. The canonical view of how cargos move is that each cargo has an adaptor protein that directly links it to the transport machinery. In contrast to this view, my postdoctoral work, and other recent studies, revealed a new mode of transport called "hitchhiking": some organelles can move by connecting to rapidly moving endosomes that have already recruited the transport machinery. Consequently, hitchhiking cargos bypass the need to recruit their own set of molecular motors, and are tightly coupled to the movement of endosomes. Peroxisomes, lipid droplets, and the endoplasmic reticulum all achieve motility in filamentous fungi by hitchhiking. My preliminary data demonstrates that peroxisomes also hitchhike on endosomes in hippocampal neurons.

The molecular mechanisms dictating organelle hitchhiking are not well understood. My published work identified the novel tether PxdA as a central regulator of endosome-mediated hitchhiking of peroxisomes, but how it achieves this remains unclear. To determine the mechanism of organelle hitchhiking, I will use a combination of live-cell imaging, electron microscopy, biochemistry, and genetics. In aim 1 I will determine how peroxisomes, lipid droplets, and endoplasmic reticulum hitchhike on endosomes in the filamentous fungus, *Aspergillus nidulans*. In aim 2 I will determine if hitchhiking is conserved in mammals. I will follow up on my preliminary observations that peroxisomes hitchhike in neuronal axons and determine if other organelles hitchhike in neurons. These experiments will lead to a mechanistic understanding of hitchhiking, a new paradigm in microtubule-based transport.

"Dissecting Mechanisms that Control Hepatic Glucose Production Using a Newly Identified Anti-Diabetic Drug"

Type 2 diabetes is currently a world-wide epidemic with an urgent medical need for novel anti-diabetic drugs. Suppression of hepatic glucose production ameliorates diabetic symptoms, suggesting that targeting regulatory components within this pathway can potentially be used to treat diabetes. The transcriptional coactivator PGC-1 α is a potent activator of hepatic glucose production during fasting and diabetic states, through induction of genes encoding enzymes in the gluconeogenic pathway. PGC-1 α gluconeogenic activity is negatively regulated through acetylation catalyzed by the GCN5 acetyl transferase, decreasing its ability to promote hepatic glucose production. Thus, small molecules that induce PGC-1 α acetylation could be potential drugs that might be used to control systemic blood glucose levels. We have designed and developed a high-throughput chemical AlphaLisa screen and used MLPCN and DOS libraries to identify chemical scaffolds that increase PGC-1 α acetylation. As a proof of concept for the potential use of selective targeting of PGC-1 α as treatment for diabetes, I have shown that a single compound from this screen, SR-18292, potently improves whole body insulin sensitivity leading to improved glucose homeostasis in diabetic mouse models. The improved glucose homeostasis is a result of reduced hepatic glucose production, since glucose uptake is not affected.

I will use compound SR-18292 as a tool to gain new insights into how hepatic glucose production is regulated. This is an exciting opportunity since the proteins or enzymes that are targeted by this compound are currently unknown. In aim 1, I will use biochemical and proteomic tools to determine the molecular pathways that are activated in response to SR-18292 treatment and lead to formation of an inactive PGC-1 α transcriptional complex. In aim 2, I will identify the molecular changes, at the proteome,

genome and metabolome levels, to dissect the molecular changes whereby SR-18292 confers improved glucose homeostasis.

“System Genetics of Tuberculosis Susceptibility”

The outcomes of *Mycobacterium tuberculosis* (Mtb) infections are extremely diverse. Many infected individuals show no signs of disease. Among those that do become ill, the timing, location, and severity of pathology are also variable. Genetic diversity in the host is a major contributor to this variability, but the responsible alleles and mechanisms are poorly defined and have been difficult to address experimentally. In this project, I approach this inherently complex problem by modeling host diversity using the Collaborative Cross (CC), a genetically diverse panel of mice. The unique structure of this population allows the sequential evaluation of variable traits that reflect distinct aspects of pathogenesis. I have used the CC combined with high-throughput bacterial genetics to dissect the genetic basis of tuberculosis (TB) susceptibility at multiple levels, including the gross disease and underlying physiological levels. By defining genetic interactions between host and pathogen, I have developed a system to understand how natural genetic variation in the host alters the immune stresses experienced by Mtb and ultimately influence outcome of infection.

My initial studies implicated Kit Ligand (KitL) variation as an important determinant of TB disease in mice and humans, and associated this genetic variation with alterations in myeloid cell differentiation that I hypothesize to underlie susceptibility. Here, I aim to causally link KitL to TB susceptibility and elucidate the underlying mechanisms driving susceptibility to disease by 1) Investigating the molecular basis of KitL linked TB susceptibility and 2) Defining the biological basis of KitL association with TB susceptibility.

In the long term, this proposal will serve as a blueprint of the strategies I will use in my future independent career to couple this genetically diverse mouse panel with high throughput bacterial genetics to identify new susceptibility genes and interrogate the underlying biological mechanisms driving outcome to TB.

“Resolution of T2D after Gastric Bypass Surgery: Deciphering the Impact of ESM1”

Roux-en-Y gastric bypass (RYGB), considered the gold standard procedure of bariatric surgery, is increasingly recognized as a potent approach for the treatment of both obesity and type 2 diabetes (T2D), as it results in not only sustained weight loss but also diabetes remission and/or improvement in diabetes control. The primary factor(s) and underlying molecular mechanisms contributing to these effects of RYGB to improve glycemic control remain largely undetermined, but are essential to understand in order to develop novel nonsurgical approaches to treat T2D. We have performed comprehensive analysis of the proteome in human blood samples obtained from our longitudinal clinical trial, which randomized individuals to RYGB or intensive medical management and followed them for 3

years postoperatively. This study revealed rapid and sustained improvement in glycemic control in the surgical group as compared with medical management. Proteomics analysis revealed sustained, and significant >2-fold upregulation of 3 members of the IGFBP superfamily: IGFBP1, IGFBP2 and a novel related protein ESM1. All 3 proteins are inversely correlated with hemoglobin A1c. Moreover, upregulation occurred as early as 3 months, before significant weight loss, suggesting the possibility that these factors represent weight-independent contributors to improved glucose levels. These 3 proteins share high protein sequence similarity, including the ability to interact with cell surface integrin β receptor. Therefore, in this proposal, we delineate our plans to investigate the impact of ESM1 in physiology and metabolism by AAV-mediated overexpression of ESM1 in the liver of mice with diet-induced obesity, and to study the impact of ESM1 on hepatic metabolism, signal transduction and transcriptional regulation. Our translational study thus represents an important first step toward determining whether ESM1 may have novel therapeutic potential for the non-surgical treatment of T2D, and to decipher the mechanisms responsible for improved glycemic control after bariatric surgery.

“Targeting the ER-Mitochondrial Interface to Combat Age-Related Disease”

The combination of an aging global population and the prevalence of age-onset diseases is generating a public health burden that is becoming insurmountable. Interventions causing real or perceived energy-depletion, e.g. dietary restriction or activating the low-energy sensor AMPK, robustly protect against age-related pathology and disease, but carry clinically unacceptable side-effects precluding use as therapeutic regimes. Using an AMPK-dependent model of longevity in *C. elegans*, we uncoupled the negative side-effects of energy-depletion from the benefits on aging through the conserved AMPK target and transcriptional coactivator, CRTC-1. We showed that the longevity-specific mechanisms downstream of AMPK/CRTC-1 involve reprogramming of mitochondrial metabolism and dynamics.

New data indicate that the unfolded protein response (UPR) of the ER interacts with this same AMPK/CRTC-1 pathway to promote longevity. Through this link, we subsequently identified the first example of an interaction between ER and mitochondrial behaviors that plays a role in aging. Emerging research has revealed that the ER plays critical roles in regulating mitochondrial dynamics and function through interorganelle contact sites, but how the mediators of the UPR play a role in this regulation is not well described. Through the genetic strengths of *C. elegans* and their amenability to *in vivo* microscopy, I will expand on preliminary data to reveal the mechanism by which mediators of ER homeostasis regulate mitochondrial behavior to promote healthier aging. I will define how ER-mitochondrial communication changes during normal aging. Finally, I will combine synthetic and genetic approaches to directly modulate interorganelle communication between ER and mitochondria to begin defining how these organelle interfaces impact the aging process and how they can be targeted to protect metabolic homeostasis in aging animals. Through these aims, the ultimate goal of this proposal is to understand how evolutionarily conserved energy-sensing pathways coordinate subcellular interorganelle communication with metabolic function to promote healthier aging.

“Role of the Basal Ganglia in the Learning and Execution of Motor Sequences”

The basal ganglia (BG) play an important role in learning and producing motor skills vital to our everyday lives, such as speaking and writing. Their dysfunction - which can be caused by disorders including Parkinson's or Huntington's disease -- gravely impair the execution of learned skills and the capacity to acquire new ones. Despite the importance of motor skills, little is known about the neural mechanisms underlying their learning and execution and the contributions made by the BG.

Motor sequence learning in the BG is usually studied in simple sequencing tasks. These studies have led to models of the BG as high-level controllers that select and initiate entire movement sequences stored in downstream circuits. However, these studies do not monitor movement kinematics or timing of skilled motor sequences, leaving open the question of whether these low-level motor features are encoded by the BG. I will determine whether the BG encode sequence microstructure using a novel sequence learning task for rodents. I will also utilize a chronic extracellular recording platform I developed to track the activity of single neurons in the BG over several weeks, in combination with high-resolution behavioral tracking as rats are performing skilled sequences. I will analyze these datasets to determine whether neural activity encodes low-level microstructure of motor sequences, and if so, what the encoding scheme is. I will then utilize our long-term recording platform to determine how the motor representations in the BG change over the time-course of skill learning and how acquisition of a novel sequences affects representations of pre-existing motor sequences such as grooming. These experiments will identify the role of BG circuits in motor sequence learning and execution that will inform basic understanding of how the brain generates motor skills and inform clinical practice relating to a variety of movement disorders.

“Dissection of a Newly Discovered DNA Damage Response Pathway in Early Zebrafish Embryogenesis”

Cells with extensive DNA damage are typically eliminated via apoptosis, but pre- and early-gastrulation embryos of most organisms cannot induce apoptosis. What happens to damaged cells in early embryogenesis? I profiled zebrafish embryos by single-cell RNAseq and discovered a new cellular expression program expressed in 'seven-sleeper' cells, which combines genes associated with apoptosis, cellular stress, p53 activation, and several developmental regulators. I hypothesize this program replaces apoptosis in response to damage in the early embryo. Indeed, my preliminary data shows that this program can be induced by DNA damage. Surprisingly, they do not die, even after apoptosis becomes active. The goal of this project is to dissect this newly discovered program and determine its roles in early development and in responding to DNA damage.

In Aim 1, I will determine the origin of the 'seven-sleeper' cells by testing what forms of DNA damage induce them, whether the 'seven-sleeper' cells have encountered DNA damage in vivo, and what aspects of traditional apoptosis they activate. In Aim 2, I will track 'seven-sleeper' cells' fate using two live reporter lines to quantify how many cells die later in development, whether they alter their cell cycle, and which tissues they contribute to. In Aim 3, I will test mutants for each gene in the 'seven-sleeper' pathway for changes in embryonic viability, cell survival, DNA repair, and changes in the expression in other 'seven-sleeper' genes to reconstruct the regulatory cascade and determine the role of this pathway in development.

Together, these experiments will determine how embryonic cells respond to DNA damage without apoptosis, and may shed light on the question of why embryos inhibit apoptosis. Finally, since many of the genes in this pathway are expressed in the immune system or tumor cells, understanding 'seven-sleeper' cells may have implications in other tissues or disease.

“Regulation of Th17/Treg Balance by Gut Bacterial Modification of Bile Acids”

Gut commensal bacteria play critical roles in shaping the host immune system. Perturbations of this community are linked to multiple autoimmune diseases such as inflammatory bowel disease (IBD) that increases the risk of colorectal cancer, and autoimmune uveitis, a major cause of blindness. Interestingly, both IBD and autoimmune uveitis are driven by T lymphocytes, especially recently identified subset of CD4+ T helper cells that secrete interleukin-17 (Th17). On the other hand, anti-inflammatory T helper cells, known as regulatory T (Treg) cells, act to counter-balance pro-inflammatory responses and control autoimmunity. Recent studies have provided compelling evidence that gut bacteria and their metabolites directly modulate both Th17 and Treg cell differentiation and function.

Our small molecule screens identified several bile acid derivatives in regulating Th17 and Treg cell differentiation. Bile acids are produced by enzymes encoded in the mammalian genome, but are further transformed by bacterial enzymes. In fact, one of bile acid derivatives that we identified as a potent Th17 suppressor can be produced in vitro with the help of human commensal bacteria from precursor bile acids. Furthermore, our preliminary data suggest that this particular bile acid metabolite is present in mouse fecal samples. Moreover, we also identified another bile acid metabolite as a potent enhancer of Treg differentiation, with minimal effects on Th17 cells.

In sum, we hypothesize that bacterial modification of bile acids represents a previously unrecognized mechanism of immune regulation in the gut, contributing to Th17/Treg balance as well as immune homeostasis. Such a regulatory mechanism may provide therapeutic benefits in autoimmune inflammation, associated cancer and blindness. In this proposal, I aim (1) to elucidate molecular mechanisms by which the identified bile acids enhance Treg differentiation and (2) to identify commensal bacteria and their specific enzymes responsible for necessary modification of bile acids to produce biologically active ones.

“Determine Pathophysiological Mechanisms How Mutations on OPTN and TBK1 Cause Glaucoma”

Glaucoma is a neurodegenerative eye disease caused by damages to the optic nerve that conveys the retinal signal to brain. While it is the second leading cause of blindness affecting ~2% of people over ages of 40, there is no cure, mostly due to the lack of our knowledge on the disease progression. Interestingly, recent genome-wide association studies revealed that mutations in Optineurin (OPTN), an autophagy receptor, and TBK1 kinase, a known interacting protein of OPTN, are tightly associated with glaucoma progression. In my recent work as well as that of others has uncovered a pathway by which OPTN and TBK1 promotes selective autophagy of protein aggregates, pathogens, and damaged mitochondria. Consistent with their critical roles in autophagy, series of studies showed abnormal autophagy in cells expressing glaucoma-associated mutations in OPTN and TBK1. The goal of this proposed study is, therefore, to systemically characterize the molecular defects associated with mutations in these genes found in glaucoma, which, I believe, will provide inroads into therapeutics.

In this proposal, utilizing various disciplines including a state-of-the-art quantitative proteomics approach, I will systemically examine the molecular defects caused by OPTN mutations and elevated TBK1 levels found in glaucoma. First, I will elucidate how glaucoma-associated OPTN mutants alter flux through selective autophagy systems. Secondly, I will define the pathophysiology of TBK1-associated glaucoma and identify the regulatory mechanisms for autophagy-dependent TBK1 activation. I am confident that I can successfully accomplish my goal with my expertise obtained from my training. I believe that this work will provide a mechanistic understanding of how mutations found in OPTN and TBK1 in glaucoma affect their functionality in clearance of organelles and proteins and will set the stage for curing the glaucoma patients.

“Early Role of Complement and Microglia in Mediating Synapse Loss in Alzheimer's Disease”

Region-specific synapse loss is an early critical hallmark of Alzheimer's disease (AD); however, mechanisms underlying synaptic vulnerability remain elusive. Recent genome-wide association studies suggest microglia to play a major role in AD pathogenesis, but their biological significance is unknown. Whereas phagocytic microglia have been implicated in plaque clearance and neuroinflammation in late stages of AD, it is not yet known whether, or how, microglia contribute to synapse loss and dysfunction.

Emerging research in healthy brain is providing insight into fundamental roles of microglia and immune molecules in brain wiring. Recent works suggest microglia eliminate developing synapses partly through complement-dependent mechanism, raising the intriguing hypothesis that dysfunction of such microglia-synapse interactions may lead to synapse loss and dysfunction during disease.

My studies in AD mouse models suggest that C1q, the initiating protein of the classical complement cascade, is upregulated and deposited onto vulnerable synapses early, long before plaques deposit. Moreover, genetic or antibody-mediated inactivation of C1 protects synapses against synaptotoxic A β oligomers. Interestingly, microglia in A β -challenged adult mouse hippocampus were found to engulf synaptic material, suggesting that microglia may act as cellular mediators of synapse loss. I thus propose a model in which C1q and A β oligomers act in a common pathway to drive microglial engulfment of synapses early in AD. I propose to address the following: 1) Do microglia play an early and active role in driving synapse loss in AD? 2) Do A β and C1q interact to eliminate specific synapses? 3) Does inactivation of complement ameliorate synaptic deficits in AD models? This mechanistic proposal highlights a potential role of microglia in very early, pre-plaque stages of AD when synapses are already vulnerable. Furthermore, I propose to test novel mechanisms by which A β and C1q mediate early synapse loss that will elucidate new pathways underlying synapse loss in AD.

“Improving the Efficiency of Precise CRISPR/Cas9 Mediated Genome-Editing”

The nearly exponential reduction in both cost and speed of genome sequencing has led to an enormous wealth of genetic data that can be used to study genetic variation. A major challenge associated with repositories of human genome sequencing data is correlating single nucleotide polymorphisms (SNPs)

with functional outcomes such as being causative for disease. Scientists can use genome editing technologies to recapitulate SNPs in cell-lines or organisms to determine whether genetic variation is involved in disease progression and subsequently develop targeted therapies.

One recently described genome editing technology that can be used for such applications is derived from the bacterial clustered regularly-interspaced short palindromic repeats (CRISPR) immune system. CRISPR-associated protein 9 (Cas9) is an endonuclease that can easily be programmed to generate double-strand breaks (DSBs) in DNA at specified sites in human cells. While this platform has been transformative in its ability to knockout genes by disrupting coding frames via non-homologous end-joining (NHEJ) DNA repair, precise changes necessary to model SNPs proceed through the homology-directed repair (HDR) pathway and are generally much less efficient.

Therefore, the purpose of this proposal is to investigate methods that increase the efficiency of the precise HDR-mediated repair. To do so, I will: 1) determine whether the inherent properties of the Cas9 nuclease can be engineered or exploited to improve HDR, 2) optimize a protein tethering strategy to enable recruitment of pro-HDR factors to the sites Cas9-induced DSBs, and 3) utilize genome-wide libraries of molecules to identify previously unknown endogenous factors that may bias DNA repair to HDR outcomes instead of NHEJ. The implications of this proposal are of broad interest to both the academic and therapeutic communities, as methods to increase the efficiency of precise DNA repair will enable scientists to more rapidly generate disease models and to develop targeted disease therapies.

“Modeling the Effects of Gene Regulation on Cancer Survival”

Cancer is a complex, heterogeneous disease that results from the intricate interplay of diverse cellular and molecular factors, including genetic, epigenetic, and proteomic factors. Data from large-scale projects, such as The Cancer Genome Atlas (TCGA), have shown that each individual tumor is characterized by a unique set of genetic mutations and a distinctive pattern of gene expression. A natural extension of this is the hypothesis that each individual tumor should be defined by a distinctive gene regulatory network that mediates the link between genotype and phenotype. We recently developed two computational methods, one that integrates protein-protein interactions, DNA binding, and gene expression to model phenotype-specific gene regulatory networks (PANDA), and a method that allows us to extract robust gene regulatory networks for individual patients (LIONESS). In this application, we propose to reconstruct single-sample cancer gene regulatory networks by applying these methods on a large publicly available cancer dataset from TCGA, which includes data for >2,000 individual cancer patients and 30 different cancer types. For each individual cancer type, we will analyze these single-sample networks to identify features predictive of patient survival and to identify biological pathways that are aberrantly regulated in poor survivors. We will also perform a pan-cancer analysis to identify pathways associated with poor survival across different cancer types. We have already started analyzing single-sample glioblastoma networks, and found that genes in the PD1 signaling pathway are repressed in patients that have relatively good survival profiles. We are looking forward to expanding our methodology, and to analyzing all TCGA cancers. We believe our approach will identify potential targets for treatment of each cancer type, will help find pathways that influence cancer survival, and will demonstrate the potential of precision network medicine.

“Mechanism of Global mRNA Decay During Apoptosis”

Apoptosis is an orchestrated program of cell death. Defective or inefficient apoptosis is the acquired hallmark of cancer cells. Understanding underlying mechanisms of apoptosis should improve our ability to design effective immune and cytotoxic therapies for cancer. Our laboratory recently uncovered global mRNA decay as an overlooked key event of apoptosis. mRNA decay arrests new protein synthesis and promotes cell apoptosis. During apoptotic decay, mRNA decay intermediates are 3'-uridylylated near the stop codon and further digested by the 3'-5' exoribonuclease DIS3L2, which specifically recognizes 3'-uracils. However, the trigger and complete molecular mechanism responsible for mRNA decay during apoptosis are unknown. This proposal aims to identify the trigger of mRNA decay and further elucidate the downstream pathways. Using a cell-free system, I found that mitochondrial material released during mitochondrial outer membrane permeabilization (MOMP) specifically triggers the decay of mRNAs, but not noncoding RNAs. Thus, I hypothesize that a component(s) of the mitochondrial intermembrane space released during apoptosis triggers mRNA decay. My preliminary data identify the exoribonuclease PNPT1, located in the mitochondrial intermembrane space, as the trigger of mRNA decay in apoptosis. PNPT1 is released at the onset of apoptosis and its knockdown inhibits apoptotic mRNA decay. I plan to use biochemical and genetic methods, including deep sequencing of RNA decay intermediates, to confirm the mitochondrial trigger and to define the pathway of apoptotic mRNA decay. Knowledge of the trigger and enzymes responsible for apoptotic mRNA decay could be exploited to enhance cancer cell killing and potentially sensitize resistant cancer cells for eradication.

“Dissecting the Neural Circuitry of Loneliness”

The formation and maintenance of social bonds is vital for a social species to develop and thrive. Situations of social isolation, exclusion, or disconnection can lead to loneliness, which is a highly aversive emotional state in humans and severely detrimental to physical and mental health. However, we have a poor understanding of the neural circuitry which underlies our fundamental need for social connection. I have gathered exciting preliminary data implicating an understudied population of dopamine neurons in the dorsal raphe nucleus (DRN) in representing the subjective experience of social isolation. These neurons are sensitive to acute social isolation, and manipulations of their activity in vivo can induce or suppress a 'loneliness-like' state, in a manner predicted by social rank. With the experiments proposed here, I seek to unravel this dopaminergic circuit, and identify the essential components of this system which underlie our innate need for social contact.

Specific Aims:

Aim 1. Map the input-output connectivity of DRN dopamine neurons and determine which components are modulated by acute social isolation.

Aim 2. Establish the functional role of divergent DRN dopamine projections.

Aim 3. Determine the causal nature of the correlation between DRN dopamine function and social hierarchy.

Dopamine is heavily implicated in the control of social behavior and the pathogenesis of numerous neuropsychiatric disorders and, consequently, is a popular target for symptomatic treatment. However,

current treatments fall short in their efficacy and specificity, in part, owing to indiscriminate targeting of a system which exhibits considerable functional heterogeneity. The broader objectives of this project are to transform our understanding of how social behavior is regulated by a heterogeneous dopamine system. This will not only shed light on the neural representation of loneliness, but also has strong potential to reveal new targets for the treatment of social impairments.

“Epigenetic Inheritance of Paternal Environmental Conditions”

Several studies show that parental nutrient availability can affect metabolic phenotypes in the offspring. However, the mechanisms by which parental conditions influence offspring remain poorly understood. Previously we found that mice fed on low protein diet sire offspring with altered lipid and cholesterol metabolism. My recent work showed that small RNA in sperm, specifically tRNA-derived fragments (tRFs), play roles in the inheritance of paternal dietary information. Protein restriction in mice affects small RNA levels in mature sperm, with decreased let-7 levels and increased amounts of 5' fragments of glycine transfer RNAs. These studies also revealed surprising dynamic aspects of small RNA biogenesis during sperm maturation; tRFs are scarce in testicular sperm but increase in abundance as sperm mature in the epididymis. To further examine the mechanism of this RNA-mediated epigenetic inheritance, this project aims to address two broad questions 1) how are sperm small RNAs generated in response to low protein diet 2) what is the effect of sperm RNA on early embryonic development? To address the first question, here I propose to first definitively identifying the tissue of origin of tRFs in sperm (Aim1). I will use three distinct methods for generating "tracer" RNAs specifically in a tissue of interest to uncover the tissue of origin for tRFs. Secondly, my data shows that the small RNA payload of sperm changes during epididymal maturation. This has important implications for assisted reproduction in humans, which in some cases utilizes relatively immature sperm from testicular biopsies, for example, to fertilize oocytes. It is therefore of biomedical interest to investigate the function of sperm small RNAs in embryonic development. Here I propose to generate embryos using a variety of combinations of sperm and exogenous RNAs and characterize regulatory consequences in early development, and later phenotypic consequences in offspring carried to term (Aim 2).

“Modeling and Disrupting Non-Coding Regulatory DNA Sequences to Inform Sickle Cell Disease Therapy”

Elevated fetal hemoglobin (HbF, $\alpha_2\beta_2$) levels in red blood cells are predictive of milder disease in sickle cell anemia patients. Strategies to increase β -globin expression have been ineffective, primarily because mechanisms of β -globin gene silencing are poorly understood. BCL11A is a major negative regulator of β -globin expression. We defined an erythroid specific enhancer of BCL11A whose activity can be disrupted without affecting BCL11A's essential functions in brain, immune, and blood stem cells. This proposal seeks to define the minimal DNA element(s) required for human BCL11A erythroid enhancer activity. Interpretation of the functional consequences of modification or deletion of human BCL11A enhancer sequence requires an in vivo model. I will "humanize" the murine BCL11A locus by swapping low HbF or high HbF associated human enhancer variants into the orthologous region in mouse embryonic stem

cells (mESCs). Enhancer activity will be assessed by BCL11A and globin gene expression in mice derived from the "humanized" mESCs. This new model will further develop BCL11A as a therapeutic target. Deletional mapping of genomic DNA from patients with elevated HbF suggests γ -globin expression can also be affected by cis-regulatory sequences within the β -globin gene cluster. To identify novel repressors of HbF, I will interrogate the entire β -globin gene cluster using CRISPR/Cas9 genome editing technology in a human erythroid progenitor cell line. Application of this high throughput mutagenesis will allow rapid examination of non-coding DNA elements necessary for proper regulation of the human globin gene locus.

Collectively, these studies will contribute to a fuller understanding of γ -globin gene regulation and provide in vivo models for molecular characterization of hemoglobin switching. Both approaches aim to identify critical DNA sequences that are required for maximal γ -globin gene silencing. Defining the minimal sequences to target for HbF reactivation are crucial for the advancement of gene therapy as a treatment option.

"Roles of Recurrent DNA Break Cluster Genes in Neural Development and Disease"

We have employed unbiased, high-throughput, genome-wide, translocation sequencing (HTGTS) to discover 27 recurrent DNA double strand breaks (DSBs) clusters ("RDCs") in mouse neural stem and progenitor cell (NSPC) genomes. Most RDCs occur in long genes ("RDC genes") that have large numbers of exons separated by long introns. Moreover, most RDC genes are involved in synapse function and/or neural cell adhesion, with majority also implicated in mental disorders. As RDC-genes lie in single topological-associated domains, the frequency of joining between two separate DSBs within an individual RDC-gene should be high. Therefore, we hypothesize that joining of frequent DSBs within long introns of RDC-genes may lead to deletion of exons or other rearrangements that promote expression of altered products. Such "hard-wired" RDC-gene changes might be transmitted to daughter cells, including mature neurons, and contribute both to genomic mosaicism of the brain and also to neural diseases. To test this hypothesis, our first aim proposes to adapt HTGTS to map junctions between separate endogenous DSBs within given RDC-genes. Furthermore, we will employ RNA-Seq to examine NSPCs and mature neurons for the expression of implicated new transcripts. Many RDC genes also are implicated in human cancers, with several located near genes implicated in medulloblastoma (MB), a deadly pediatric cancer. We have generated a robust mouse model for MB that exhibits characteristic translocations and amplifications. In our second aim, we propose to perform whole genome sequencing to identify the recurrent breakpoints of these MB genomic alterations. We will use this information to tailor HTGTS studies of NSPCs and cerebellar granule cell progenitors (likely MB precursor cells), to both identify DSBs that lead to recurrent MB genomic alterations and also to elucidate mechanisms that cause them. Our proposed aims should shed light on the roles of DSBs in brain diversification and brain diseases including cancer.

"Decoding the Origin and Development of the Newborn Gut Microbiome"

The human gastrointestinal tract harbors one of the highest densities of microorganisms on Earth. There is clear evidence that early events in microbial colonization bear a profound effect on immune education in the gut, thereby impacting disease susceptibility. Starting from birth, microbes from the mother and the surrounding environment colonize the infant intestine and microbial composition differs markedly between different delivery modes. For example, children born by C-section have a decreased microbial diversity and increased susceptibility to autoimmune diseases such as asthma and allergies. While healthy neonatal colonization of intestinal microbiota is critically important to host physiology, neither the microbial drivers nor the environmental sources of newborn microbiota have been fully elucidated. I propose to decipher the source of the newborn microbiome and how it develops with respect to a child's delivery mode. To this end, I will establish an unprecedented prospective birth cohort of 120 families analyzing infants born vaginally and by elective or non-elective C-section. I hypothesize that non-elective C-section may result in an intestinal microbiota that is distinct from vaginal or elective C-section, as the child may have been exposed to the microbiota of the birth canal. Infant stool (as a proxy for their gut) will be collected along with potential bacterial "source" samples, including the birth canal, maternal stool, parental skin, hospital bassinet, and breast milk. By performing metagenomic sequencing of these samples, I will characterize initial bacterial colonization in the context of various delivery modes. I will construct a temporal map of the newborn gut microbes (by analyzing several time points post-delivery) along with identifying their potential source. This study will provide a baseline for newborn gut microbiome development. A clear understanding of the microbial trajectory in relation to birth mode, will provide the foundation for future infant microbiome disease-focused studies.

“Capturing Conformational Change in Flavivirus Membrane Fusion”

Flaviviruses (West Nile, Dengue) are pathogens with a global human health burden. The envelope protein (E), as the membrane fusogen mediating cell entry, represents a prime under-explored target for antiviral treatment. Viruses distill fundamental principles of membrane fusion providing general insight into cellular membrane processes. The E-protein undergoes a series of conformational rearrangements to mediate membrane fusion. Understanding the relationship between E-protein structural changes and membrane remodeling requires that we study the reaction mechanism and visualize the macromolecular complex in multiple intermediate states. To date, I have adapted a single-particle TIRF method to study flavivirus hemifusion with target membranes, and through mutagenesis and kinetic simulations developed a model for the sequential conformational rearrangements that the E protein undergoes on the virion surface (Chao et al., eLife 2014).

The research proposed here will determine new structures by electron cryo-microscopy (cryo-EM) to reveal the regulatory mechanisms that control flavivirus membrane fusion. I will determine a sub-nanometer cryo-EM reconstruction of a full-length post-fusion West Nile virus (WNV) E to visualize essential trans-membrane and membrane-proximal interactions important for late stages of membrane fusion. I will determine by cryo-EM a structure of an intermediate form of the virion immediately following low-pH triggered dimer dissociation and subunit extension. I will characterize the extension of the envelope protein due to pH and temperature and the importance of interactions between E and M seen in the fully compact, pre-fusion state. I will use fluorescent conjugates of small-molecule inhibitors to determine the relationship between stoichiometry of inhibitor binding and observed delay in hemifusion. Finally, I will develop new approaches to study the late-stage transitions to test models derived from the cryo-EM structures using new probes for membrane pore opening.

“Interplays Between ADAR1 And MDA5 In The Pathogenesis Of Aicardi-Goutière Syndrome”

MDA5 is a conserved viral double-stranded RNA (dsRNA) sensor in vertebrates. While an appropriate function of MDA5 is important for effective immune defense against viral infection, my recent study showed that its dysregulated activity via gain-of-function (GOF) mutations can lead to a severe inflammatory disease, Aicardi-Goutières Syndrome (AGS) (Rice* and del Toro Duany* et al, Nat Genetics, 2014, *co-first authors). The goal of this proposal is to further elucidate the molecular mechanisms by which these mutations cause chronic inflammation and AGS. In particular, I will focus on defining the potential relationship between MDA5 and a dsRNA-modifying enzyme, ADAR1, of which loss-of-function (LOF) mutation has been also shown to cause AGS in the absence of the mutations in MDA5. I hypothesize that MDA5 and ADAR1 represent two balancing arms of the immune-tolerance relationship. That is, cellular dsRNAs, such as inverted Alu elements, are normally prevented from stimulating MDA5

through modification of adenosine (A) to inosine (I) by ADAR1, whereas LOF mutations in ADAR1 or GOF mutations in MDA5 may allow stimulation of MDA5 by these endogenous dsRNAs.

To test this hypothesis and further expand our understanding of the AGS pathogenesis, I here propose a multi-disciplinary research project involving a combination of biochemistry, biophysics and cell biology. I will first determine the impact of A-to-I modifications on the MDA5:dsRNA interaction using biochemical and biophysical assays that we have developed in our laboratory (Aim 1). I will next identify the endogenous dsRNA stimulating MDA5 using cells derived from AGS patients (Aim 2). This project builds upon my previous work on the molecular mechanisms of MDA5 and the strong preliminary data. I believe that the proposed research would provide novel insights into the pathogenesis of AGS, and also help us define a new paradigm of the complex interplays between the pathogen sensing and cellular RNA modification.

"The Mechanism Of Replication Termination In Vertebrates"

DNA replication terminates when replication forks converge, but the mechanism is unknown. Furthermore, it is unclear how replisome components are removed from DNA, particularly the CMG replicative helicase, which forms a closed ring around the DNA. I have developed a powerful new system to study replication termination in vertebrates. A plasmid containing a lac repressor (LacR) array is replicated in *Xenopus* egg extracts, causing two forks to stall on the outer edges of the array. When IPTG is added, LacR dissociates, forks resume synthesis, and termination occurs synchronously in a narrow zone.

Using this system I elucidated a model for vertebrate termination in which replisomes converge and freely pass each other, allowing leading strands to be rapidly ligated to downstream lagging strands. The CMG helicases, which normally translocate along single-stranded DNA, are unloaded after the DNA is fully ligated, implying that they pass over and encircle dsDNA. CMG unloading occurs during decatenation of the daughter molecules by Topoisomerase II, suggesting these processes may be linked.

In Aim 1, I will determine the trigger for CMG unloading. I will test whether CMG unloading is initiated once it encircles dsDNA, or whether fork convergence or decatenation is the signal for CMG unloading.

Recent work shows that CMG ubiquitylation is required for its unloading, and implicates the ATP-driven 'unfoldase' p97 in this process. In Aim2 I will determine when CMG is ubiquitylated, and investigate how p97 recognizes CMG. In parallel, I will identify new termination proteins by mass spectrometry and investigate their involvement in CMG unloading.

Together, these experiments will coalesce into a detailed molecular model of CMG unloading, which includes p97 and CMG ubiquitylation, as well as novel termination proteins.

Long term objectives

Future work will build upon this study and address other questions about termination, such as how topological stress is dealt with between converging replication forks. It will also be important to test

whether the anticancer properties of Topoll and p97 inhibitors can be attributed to inhibition of termination.

"Molecular Basis for Integrin AlphaVbeta6 Mediated TGF-beta Activation and Structure-based Drug Design"

Integrins are cell surface receptors that link to the cytoskeleton, bind extracellular ligands, and transduce intracellular and extracellular signals. In vivo, alphaVbeta6 and alphaVbeta8 integrins specifically activate latent TGF-beta (pro-TGF-beta). TGF-beta regulates tissue development, wound healing, immune responses, and cancer progression. Furthermore, alphaVbeta6 is an emerging target for fibrosis and cancer therapies.

How alphaVbeta6 and alphaVbeta8 specifically activate TGF-beta is unclear. Our recent crystal structure of pro-TGF-beta3 peptide-bound alphaVbeta6 headpiece provides insights into how alphaVbeta6 achieves ligand specificity. Together with mutational studies, affinity measurements, and evolutionary analysis, we identified three surface exposed loops (specificity-determining loops) in alphaVbeta6 critical for ligand-specificity. We also demonstrated that an amphipathic helix following the integrin-binding RGD contributes to high-affinity binding.

The project goals are to 1) determine molecularly how alphaVbeta6 binds and activates pro-TGF-beta, and 2) rationally design a de novo integrin alphaVbeta6-binding protein (alphaVbeta6-BP) based on the crystal structure we determined and probe its therapeutic usage.

In Aim 1, we will measure affinity, kinetics, and thermodynamics to further probe alphaVbeta6/proTGF-beta binding. To test our hypothesis that other regions or conformational changes in alphaVbeta6 and pro-TGF-beta1 are important for their interaction, we solved a preliminary 3.6 Å crystal structure of the proTGF-beta1/alphaVbeta6 head complex. We will mutate residues revealed from this structure and assay their importance for binding and activation of pro-TGF-beta by alphaVbeta6.

In Aim 2, in collaboration with David Baker's lab, we design, totally de novo, an alphaVbeta6-BP that binds similarly to pro-TGF-beta. We will optimize the alphaVbeta6-BP structure to obtain higher affinity and specificity for alphaVbeta6. Lastly, we will test the therapeutic usage of the binder as a TGF-beta-activation inhibitor, a cancer cell label, and for a nanocage-based drug deliver system.

Our pro-TGF-beta1/alphaVbeta6 head complex structure represents the first reported co-crystal structure for an integrin head bound to physiological, macromolecular ligand. Since the ligand-binding pocket of integrins are structurally similar, determining how pro-TGF-beta and alphaVbeta6 interact will not only further our understanding of TGF-beta activation, but also provides insight into integrin-ligand interactions in general. Our work will have fundamental implications for the development of therapeutics for diseases associated with TGF-beta and alphaVbeta6.

"Capturing Co-Translational Protein Translocation in Action"

The goal of this project is to understand the mechanism by which proteins are transported across membranes. Specifically, we aim to elucidate how polypeptides are moved through the "translocon", an evolutionarily conserved protein-conducting channel in the endoplasmic reticulum (ER) of eukaryotes and the plasma membrane in bacteria and archaea. Although the players involved in the process are known and the structure of the idle channel has been determined, the mechanism of translocation is still only poorly understood, largely because there is no structural information about the translocon in action. Visualizing the active translocon with a translocating polypeptide chain inside the channel has been the major (and elusive) goal in the field for more than a decade. We will employ a newly developed system that allows us to trap intermediates of co-translational protein translocation at defined stages in intact *Escherichia coli* cells. We established a novel purification strategy to prepare ribosome-nascent chain (RNC)-translocon complexes for structural studies. These will be used for structure determination by state-of-the-art single particle cryo-electron microscopy. First, we will determine a high-resolution structure of a complex of the non-translating ribosome bound to the translocon (Aim 1). This structure will serve as a reference for actively translocating complexes. Second, we will determine a high-resolution structure of the RNC-translocon complex with a short nascent secretory polypeptide chain representing an early stage of translocation (Aim 2). These studies will clarify how the signal sequence of a substrate is recognized by the translocon. Aim 3 focuses on how signal sequences are cleaved during translocation. Newly developed in vitro and in vivo assays will be used to elucidate when the signal sequence is cleaved, and cryo-EM experiments (Aim 4) will clarify how the channel changes after signal sequence removal. This project will provide structural snapshots of co-translational translocation of a polypeptide at different stages. It will reveal how the translocon accommodates a nascent polypeptide, how it is activated by a translating ribosome, and how signal sequences are recognized and processed.

"Deconstructing Different Modes Of Heterogeneity In Human Leukemia"

Over the last several decades, there has been a revolution in our understanding of cancer growth, and leukemia in particular. It became increasingly clear that leukemia is not just one disease, as any single leukemia doesn't have just one genome, but instead, comprises of multiple genomes that belong to distinct subclones. These subclones may evolve in parallel over the lifetime of cancer and contribute to intratumoral genetic heterogeneity. However, even within single genetic subclone, not all cells are phenotypically and functionally equal, which adds another dimension to the intratumor heterogeneity. For example, cells vary in regard to their state of differentiation, capacity for self-renewal, and long-term clonal maintenance. It is, therefore, compelling to hypothesize that careful characterization of intratumor heterogeneity and understanding its mechanisms and sources may hold the key to improvement in cancer diagnosis, prognosis, monitoring of each patient, and ultimately for more effective therapies and control of cancer. Here, I will catalogue genetic and transcriptomic cell-to-cell variability within normal and malignant hematopoiesis to determine their functionality and shed light on a number of fundamental issues: the origin of leukemia (cell of origin), identification of pre-leukemic clone, distinguishing driver from passenger mutations, coexistence of normal and malignant

hematopoiesis within a patient, as well as, understanding and preventing therapy resistance. By delineating individual cell states (RNA-Seq) with superimposed mutation makeup, I will be able to tease apart the unique aspects of leukemia biology that until now has been obscured by population-based studies. With these distinctive insights, I will recreate genetic diversity of primary leukemia in vitro by generating a set of cell lines recapitulating genetic diversity found in individual leukemic cells and test them individually for leukemia initiation ability.

Ultimately, studying individual cancer cells may bring new implications for the cancer stem cell model, and may help to determine the extent to which it accounts for therapy resistance and disease progression. In the clinic, these approaches will have important applications in early detection and non-invasive monitoring.

"Dissecting Molecular Mechanisms Underlying Erythroid Progenitor BFU-E Self-renewal"

Many acute and chronic anemias, including hemolysis, sepsis, and genetic bone marrow failure diseases such as Diamond-Blackfan Anemia (DBA), are not treatable with erythropoietin (Epo), because the colony-forming unit erythroid progenitors (CFU-Es) that respond to Epo are either too few in number or are not sensitive enough to Epo to maintain sufficient red blood cell production. One attractive approach is to devise strategies to promote self-renewal of the upstream burst-forming unit erythroid progenitors (BFU-Es). My proposed study focuses on understanding the molecular mechanism that regulates a key decision made by BFU-E progenitors -- self renewal or differentiating into the later CFU-E progenitors -- which has major implications for both basic biology and the development of drugs to treat rare forms of anemia.

We previously showed that glucocorticoids (GCs) specifically target and stimulate self-renewal of BFU-E progenitors. My recent study demonstrated that PPAR α synergizes with glucocorticoid receptor (GR) to promote BFU-E self-renewal, and over time greatly increase production of mature red blood cells in mouse and human erythroid cultures. Indeed, PPAR α agonists alleviate anemic symptoms in acute and chronic anemia mouse models.

My ChIP-Seq data shows that both GR and PPAR α predominantly occupied distal intergenic and intronic chromatin sites. Importantly, 67.9% of GR peaks and 44.3% of PPAR α peaks co-localize. I analyzed the DNA sequences underlying these presumed enhancer regions, and uncovered enriched DNA binding motifs for 10 transcription factors, most of which are important for self-renewal of stem cells. I hypothesize that GR and PPAR α co-localized chromatin sites are critical regulatory elements to establish the BFU-E specific gene expression program, and are likely to be "super-enhancers", which are clusters of transcriptional regulatory elements that are highly occupied by critical transcription factors and coregulators and are important for cell identity. In my proposed study, I will use rigorous experimental and bioinformatic approaches to determine the key regulators and the enhancer functions of GR and PPAR α mediated BFU-E self-renewal. By understanding how these regulatory elements modulate BFU-E function, small molecules or gene editing approaches could be developed as new therapeutic strategies for Epo-resistant anemias such as DBA.

"A Metastasis-Targeted Cell-Based Delivery Platform For Prostate Cancer Therapy"

Prostate cancer (PCa) is the second leading cause of cancer-related deaths in American men. PCa lethality is mostly derived by the continuous development of disseminated metastasis, commonly found in the bone marrow. Despite significant progress in PCa research, there still exists a major need to efficiently target anti-cancer drugs to sites of PCa mets, while sparing host toxicity. Systemic administration of therapeutics may encounter multiple challenges, including severe adverse effects, uncontrolled drug levels, early degradation and rapid clearance from the body. While drug encapsulation in nano/micro delivery systems may reduce host toxicity and protect the drug from early degradation, effective targeting of such delivery systems to specific sites remains challenging. In this proposal, we aim to create a metastasis-guided cell-based drug delivery platform by transfecting mesenchymal stem cells (MSCs) with mRNA encoding metastasis-targeting ligands to specifically direct systemically infused MSCs to PCa mets. To be used for drug delivery, mRNA-engineered MSCs will then be loaded with microparticles encapsulating toxic payloads. We predict that this mRNA-guided MSC-based delivery vehicle will display active targeting upon systemic administration and facilitate the delivery of therapeutic agents to sites of PCa mets, resulting in significant anti-tumor effect, while minimizing host toxicity and adverse effects. To develop this targeted platform, we propose 3 specific aims. The first aim is to evaluate homing properties of mRNA-engineered MSCs in-vitro in a bone mets-simulated environment. The second aim is to assess homing of systemically infused mRNA-guided MSCs to PCa tumors in a mouse model simulating human PCa bone metastatic lesions. Finally, the third aim is to evaluate the therapeutic efficacy of systemically infused mRNA-targeted MSCs loaded with anti-cancer drug microparticles using the "humanized" PCa bone mets mouse model. Overall, pursuing this proposal may eventually lead to development of a systemic cell-based metastatic PCa therapy that may help millions of PCa patients.

"Dissecting Mechanisms Regulating Totipotency in Mouse"

In mammals, pluripotent stem cells can give rise to cells of embryonic lineage. Guided by the mechanism underlying pluripotency, pluripotent stem cells have been successfully induced through manipulating the transcriptional and epigenetic networks of various differentiated cell types. For therapeutic use of stem cells in regenerative medicine, it is important to obtain stem cells in a lineage-unrestricted state. The most unrestricted state is the totipotent state in which cells can contribute to both embryonic and extra-embryonic lineages. However, the factors that confer totipotency are poorly understood due to the limited availability of totipotent cells (eg. 1-cell and 2-cell mouse embryos). Recently, a rare and transient subpopulation of ESCs called 2-cell-embryo (2C)-like cells that express a group of 2-cell embryo-specific genes are identified. Amazingly, the 2C-like cells can contribute to both embryonic and extraembryonic tissues when injected into pre-implantation embryos, indicating that they are totipotent. When analyzing the role of Ten-eleven translocation (Tet) family 5-methyl-cytosine dioxygenases in ESCs, I found that triple KO of Tet genes results in a 6-fold increase in 2C-like cell population. Besides Tet proteins, only three factors (Kap1, Lsd1 and G9a) are known to regulate the totipotent 2C-like state.

Since the CRISPR-Cas9 (clustered regularly interspaced short palindromic repeat) system enables genome-wide functional screen in mammalian cells, I propose to systematically identify regulators of totipotent 2C-like state by performing genome-wide knock-out screen and to understand how the identified factors involve in the establishment and exit of the totipotent state in pre-implantation embryos.

Genome-scale CRISPR-Cas9 Knock-out screening will be carried out in cell line with tdTomato reporter driven by a 2C-specific promoter to identify genes responsible for increased or decreased tdTomato-positive cell population. Using this unbiased systematic approach, we anticipate to identify both positive and negative regulators of the 2C-like state. Factors identified in the screen will be further evaluated through depletion or forced expression in 1-cell zygotes and functionally evaluated by analyzing their effect on the 2-cell embryo-specific gene expression and embryo developmental potential. Completion of the proposed study will reveal insights into the establishment, maintenance and exit of totipotency, which will ultimately facilitate regenerative medicine.

"In Vivo Study Of Homeostatic And Non-homeostatic Control Of Feeding By Hypothalamic Neurons"

Consuming sufficient amount of food to maintain energy balance is fundamental for survival. However, environmental factors contribute to the motivation to eat and can override homeostatic signals to stimulate eating in sated states, or inhibit eating in states of hunger. These factors are believed to underlie the increasing vulnerability to obesity and anorexia nervosa in the developed world. Deeper understanding of the basic neural microcircuits controlling food homeostasis, motivation, and their interaction will provide critical clues for understanding and treating eating disorders.

Agouti-related peptide (AgRP)-expressing neurons in the arcuate nucleus of the hypothalamus are influenced by peripheral homeostatic signals, to drive or block feeding. These neurons were shown to be necessary and sufficient to drive feeding and weight gain: Their activation elicits voracious feeding even in sated states and their inhibition blocks hunger even after fasting. Recent studies indicated that AgRP neurons receive potent excitatory and inhibitory neuronal inputs, which can also regulate feeding. This raises the possibility that AgRP-neurons may be influenced also by non-homeostatic signals that arrive from the central nervous system, such as those concerning the availability of food and the motivation to pursue it, to control feeding behavior. To elucidate this question, direct monitoring of AgRP-neurons in awake behaving animals (in vivo) is necessary.

In my study I investigate AgRP neuronal activity across homeostatic states (fasted to well-fed) and in response to the circadian rhythm, homeostatic hormonal signals (ghrelin), and non-homeostatic sensory signals known to induce feeding. Subsequently, I will examine which upstream inputs to AgRP neurons contribute to the response of AgRP neurons to these signals.

My preliminary data indicates that AgRP neurons demonstrate a slow increase in activity throughout the light-cycle in accordance with the gradual decrease in energy balance. Surprisingly, they also show a fast decrease in activity at the onset of food availability, which cannot be explained by slower changes in hormonal signals of energy balance.

Together, my experiments will not only provide a new avenue for insights into hypothalamic control of feeding, but they should help overcome previous barriers in developing molecular therapies for obesity and other eating disorders.

"The role of mRNA localization in establishing and maintaining organelle identity"

One of the hallmarks of the eukaryotic cell is its organization into spatial compartments known as organelles. Organelles provide the cell with optimal subcellular environments in which to carry out fundamental processes critical to life, from gene transcription in the nucleus to ATP generation in the mitochondria. To maintain organelle identity, cells express organelle-specific receptors that selectively bind proteins from the cytoplasm and pass them to protein conducting channels for transport to the organelle interior, but how receptors find the correct organelle has remained unclear. I have established at single molecule resolution that the mRNAs encoding organelle receptor proteins localize to the sites of biogenesis for a variety of organelles, including the mitochondria, peroxisomes and endoplasmic reticulum. Based on this finding, I hypothesized that mRNA localization and spatially restricted translation of organelle receptor genes directs receptor proteins to the correct target organelle. In this proposal, I will test this hypothesis 3 ways. In Aim 1, I will measure the spatiotemporal dynamics of organelle receptor gene expression by placing the genes under inducible control and visualizing the mRNA and protein levels in space and time following addition of inducer. In Aim 2, I will identify the complexes responsible for mRNA traffic to target organelles by fusing the receptor mRNAs to a biotinylatable RNA sequence, affinity purifying the receptor mRNAs on streptavidin beads, and performing mass spectrometry on the purified material to identify proteins that co-purify with the mRNAs. In Aim 3, I will measure the phenotypic consequences of mislocalizing receptor mRNAs with a synthetic RNA binding protein I have developed that can bind RNAs and localize them to alternative organelles in a chemically-inducible fashion. Following receptor mRNA mislocalization I will measure the resulting protein distribution and effects on organelle physiology. Successful completion of these aims would establish mRNA localization and spatial control of translation as a major determinant of organelle identity in the eukaryotic cell, giving us unique insight into possible molecular origins of a wide range of developmental and metabolic disorders called organelle biogenesis disorders, highlighted by mitochondrial biogenesis defects, peroxisome biogenesis disorders and lysosomal storage disease.

"Combinatorial control of alternative splicing in determining neuronal specification and animal behavior"

Alternative splicing is an important means of regulating gene expression and of increasing the diversity of the transcriptome and proteome. This diversity has been demonstrated to be important for a number of complex organs including the nervous system, which exhibits high levels of alternative splicing. Indeed, dysregulation of neuronal alternative splicing or neuronal splicing factors has been implicated in a number of neurological diseases. Until my recent studies, however, little was known about alternative splicing within the nervous system between different classes of neurons, or about the factors responsible for regulating such alternative splicing. I demonstrated that alternative splicing between functional classes of neurons is widespread in the *C. elegans* nervous system, and showed that complex

neuron-specific alternative splicing patterns can be generated by partially-overlapping RNA-binding proteins working combinatorially.

These findings, along with a wide range of tools available in *C. elegans*, have set the stage for answering many outstanding questions in the field of post-transcriptional regulation, such as: How widespread is RNA-binding protein control of important neuronal and behavioral phenotypes? How extensive is combinatorial control of alternative splicing in the nervous system? What are the relationships among neuronal fate, splicing factors and the splicing events they control? How do RNA-binding proteins refine the identity of neuronal subtypes generated by the activity of transcription factors? The experiments outlined in this proposal aim to answer these questions and to expand our understanding of the role of post-transcriptional regulation in shaping neuronal fate, function and behavior.

AIM 1: How does neuronal fate shape alternative splicing networks?

1a: What are the factors linking cell fate to alternative splicing in the mechanosensory neurons?

1b: What is the mechanosensory-neuron alternative splicing network?

1c: How tightly linked is the relationship between neuronal fate and alternative splicing?

AIM 2: CRISPR/Cas9-mediated double-mutant analysis of neuronal RNA binding proteins

2a: Generating a library of single and double RNA-binding protein mutants

2b: Assaying defects of behavior and neuronal function in RNA-binding protein double mutants

2c: Focused analysis of RNA-binding protein synthetic interactions

"Function And Dysregulation Of Mycobacterial Clp Proteases"

Infection by *Mycobacterium tuberculosis* (Mtb) is a major cause of global mortality. Efforts to prevent and treat tuberculosis are challenged by the emergence of Mtb strains resistant to some or all conventional antibiotics. Consequently, there is an urgent clinical need for novel therapeutics that kill resistant Mtb, and a parallel need to identify and characterize new antibiotic targets.

The Clp-family of self-compartmentalized proteases is one promising class of targets. These enzymes consist of an unfoldase (ClpC1 or ClpX) and a peptidase (ClpP1P2) that together carry out regulated degradation of protein substrates. Clp protease activity is essential for Mtb viability, and inhibition or dysregulation of these enzymes can cause cell death. In recent work, I have shown that these enzymes are subject to complex regulation, and that Clp protease activity is tightly coupled to substrate availability. However, key information about how these proteases assemble and how they recognize substrates remains unknown. A comprehensive biochemical understanding of Clp protease function and the role of these enzymes in the cell will help to identify and characterize compounds that perturb their activity.

This project will address a number of major unanswered questions surrounding Mtb Clp protease structure and function. Aim 1 explores how the two unfoldases, ClpC1 and ClpX, interact with ClpP1P2. Using a set of functional and biophysical assays, I will determine if ClpC1 and ClpX compete for binding or interact simultaneously with ClpP1P2. Aim 2 will employ an assay for Clp protease activity in vitro to carry out high throughput screening for novel compounds that inhibit or dysregulate function. Aim 3 will

investigate how ClpC1 and ClpX recognize substrates for degradation, and will use a novel counter-selection system to build a profile of N- and C-terminal sequences that direct proteins for degradation by Mtb Clp proteases. By clarifying how these proteases function, this work will lead to a better understanding of their essential role in the cell and may lead to new therapeutics to combat tuberculosis.

“Unveiling the Functional Complexity of Heterochromatin by Spatially-Resolved Live-Cell Proteomic Mapping”

Eukaryotic chromosomes are organized into distinct subdomains that are critical for genome function. Heterochromatin is a substantial nuclear structure, which constitutes highly compacted DNA predominantly from centromeres and perinuclear domains. Constitutive heterochromatin is essential for the three-dimensional organization and integrity of the genome, as well as epigenetic silencing of large chromosomal domains containing repetitive DNA sequences. Despite the spatially distinct organization of heterochromatin in the nucleus, its exact protein composition remains as a fundamental unresolved research problem.

Here we propose a novel technology, which combines concepts in microscopy, mass-spectrometry (MS), and enzyme engineering to provide spatially- and temporally-resolved, unbiased proteomic maps of distinct chromosomal domains in living cells. By using this innovative strategy, we will delineate the proteomic complexity of heterochromatin in intact, living human cells, at nanometer scale resolution. Importantly, we will take the advantage of the temporal resolution of our approach to identify the factors that are specifically recruited to heterochromatin during DNA replication. These analyses will lead to identification, functional and mechanistic characterization of the key missing factors that regulate heterochromatin stability and dynamics. Given the impact of heterochromatin on genome stability and its remarkable redistribution during aging, we expect to significantly advance our fundamental understanding of the molecular mechanisms that influence human longevity.

The proposed interdisciplinary project represents a unique and powerful combination of chemical synthesis, enzyme engineering and chromosome biology, and it will introduce technological innovations that will benefit the entire chromatin research field. The outstanding broad long-term goal of this study is to improve the resolution of this novel technology to characterize the proteome of any single-copy genomic locus in human cells. The development and applications of this unique strategy will help us to tackle complex biological questions pertaining chromosome biology, which have been impossible to address by traditional approaches.

“Translational Control in Germ Cell Development: Mechanisms and Signaling”

Production of haploid gametes from diploid progenitor cells is mediated by a specialized cell division called meiosis in which two divisions, meiosis I and II, follow a single S phase. Errors in meiosis lead to aneuploid and polyploid gametes. In comparison to somatic cell production, gamete production relies heavily on translational control i.e. the activation and repression of previously transcribed RNA to govern gene expression. Using budding yeast, I have identified a translational control pathway that is

essential for establishing the meiotic chromosome segregation pattern. This pathway regulates the message-specific expression of gene clusters. Few examples of pathways governing the translational control of gene clusters have been identified. Despite the prevalence of translational control, the mechanisms by which translational control pathways act is poorly understood especially when compared to analogous knowledge of transcription control.

I have shown that the RNA-binding protein Rim4 and the kinase Ime2 regulate the timing and order of the meiotic divisions by controlling translation. Rim4 binds and inhibits translation of its targets during meiosis I. At the onset of meiosis II, Ime2 kinase activity rises and triggers a decrease in Rim4 protein levels thereby alleviating translational repression.

Moving forward, this proposal will address the following scientific aims: 1) Discover the mechanism by which Rim4 represses translation. Using genetic, biochemical, and cell biological approaches, I will determine co-factors of Rim4-mediated repression. I will determine how phosphorylation affects RNA-binding, degradation, and/or localization. Rim4 harbors low complexity domains which are important for intracellular compartmentalization. I will determine the function of these domains. 2) Determine the RNA-structure recognized by Rim4. I will use the PAR-CLIP method to purify Rim4 crosslinked to its target RNAs. Bioinformatic analysis of RNA sequences purified in this manner will lead to discovery of motifs recognized by Rim4. 3) Understand the signals that turn translational control on and off during meiosis. I will use genetic and cell biological approaches to determine how the translational control machinery is activated in meiosis and how Ime2 kinase is held inactive until meiosis II. Completion of these aims will give broadly applicable insight into gamete production and translational control.

“Dissecting Mechanisms by which Insulin Resistance Impairs Stem Cell Function and Metabolism in Human iPS Cells”

Type 2 diabetes (T2D) has reached epidemic rates worldwide. Human and animal studies have defined genetic and environmental contributions to this complex metabolic disease and identified insulin resistance as a predictor of T2D. However, the molecular basis of insulin resistance remains unknown. We propose to utilize a novel tool to approach this critical problem: induced pluripotent stem cells (iPSC) derived from patients with genetically determined insulin resistance. These cells will be analyzed in vitro to dissect the mechanisms by which insulin resistance alters cellular metabolism and proliferation.

We have successfully generated iPSC by reprogramming fibroblasts from 5 healthy controls and 4 patients with severe insulin resistance due to insulin receptor mutations and confirmed pluripotency of these iPSC. We demonstrate that insulin resistance alters critical functions of iPSC, potentially reducing proliferative capacity and inducing pathway-specific defects in insulin signaling. Furthermore, preliminary experiments aimed at identifying molecular mechanisms driving these functional defects revealed that insulin-resistant iPSC have increased energetic stress, as indicated by increased ADP/ATP ratios and robust activation of the energetic sensor AMP-activated protein kinase (AMPK). Mitochondrial size, number, and functional capacity are also dysregulated in insulin-resistant iPSC. Based on these exciting data, we will test the hypothesis that insulin resistance directly impairs cellular metabolic homeostasis, contributing to reduced proliferative capacity of critical stem cell populations.

To identify the cellular mechanisms responsible for defective energy metabolism (aim 1), we will perform detailed quantitative analyses of key metabolic pathways (e.g., glycolysis, TCA cycle, and oxidative phosphorylation) and cellular proliferation and identify regulatory signaling and transcriptional pathways contributing to these defects. To determine whether acute insulin resistance similarly impairs cellular metabolism (aim 2), we will use 2 approaches in control iPSC: a) treatment with a pharmacological antagonist of the insulin receptor and b) genome-editing technology (CRISPR) to introduce insulin receptor gene mutations. Together, these studies will address a fundamental question about the mechanisms by which insulin resistance dysregulates cellular metabolism, contributing to diabetes risk. More broadly, these data will illuminate the role of insulin resistance as an important modifier of stem cell function and development.

“Determining the Mechanism of Persister Formation and Resuscitation in Staphylococcus Aureus”

Bacterial infections caused by *Staphylococcus aureus* are the most common cause of complicated infection in U.S. hospitals. Even when appropriate antibiotic treatment is administered, patients often fail to fully clear the infection. Persister cells are phenotypic variants of regular cells which are dormant and tolerant to antibiotics. We recently established that *S. aureus* persisters can be killed by dysregulation of ClpP protease by ADEP4, facilitating eradication of a *S. aureus* mouse biofilm infection, highly recalcitrant to other antibiotics. This emphasizes the importance of persisters in deep-seated infection. Unlike other bacteria in stationary phase, the entire population of *S. aureus* behave as persisters and are tolerant to antibiotics. Under normal growth conditions, upon entry to stationary phase, ClpP mediates regulated degradation of various proteins, which, interestingly, mediates persister formation. A clpP mutant forms 100-fold less persisters. Antibiotic targets such as gyrase and the ribosome are among the proteins degraded at the onset of stationary phase. We will determine the impact of antibiotic target degradation by ClpP on persister formation. ClpP activity is regulated by its associated ATPases. We will determine the contribution of each ATPase to the persister phenotype. Furthermore, we will identify the mechanism of persister resuscitation. Understanding the precise mechanism of persister formation and resuscitation will facilitate the development of treatments to target and kill these cells and eradicate infection.

Aim 1: Identify the mechanism of ClpP mediated persister formation. Antibiotic target levels in a wild-type and a clpP mutant isolate will be monitored under a variety of growth conditions and correlated to persister levels. Antibiotic target levels will be artificially controlled in the wild-type and clpP mutant using RNA interference. The impact of this on persister formation will be measured.

Aim 2: Determine the role of Clp ATPases in persister formation. Persister formation in mutants of ClpX, ClpC, ClpB and ClpL will be examined under a variety of growth conditions.

Aim 3: Determine the mechanism of persister resuscitation. Using proteomics and metabolomics, we will analyze the changes within the cell as it transforms from an antibiotic tolerant state to an antibiotic susceptible state and will identify resuscitation factors.

“Chemoproteomic Studies of Serine Hydrolases active during Vibrio Cholerae Infection”

The chemoproteomic technique of activity-based protein profiling (ABPP) enables the direct evaluation of enzyme activity within complex proteomes. Small-molecule probes that are chemically tuned to react with a particular enzyme class allow selective detection, enrichment, and identification of active enzymes by mass spectrometry. ABPP can provide a more accurate assessment of enzymes that function under a particular set of conditions than either transcriptomic or non-activity based proteomic analyses, since post-transcriptional and post-translational regulation can lead to an imperfect correlation between gene/protein expression and enzyme activity. In preliminary work, I used ABPP to identify four secreted serine hydrolases from the cholera pathogen *Vibrio cholerae* that are consistently active in the infant rabbit model of infection. One of these four predicted proteases, VC0157, is also active in biofilm culture supernatants, but not under typical growth conditions, and appears to undergo significant post-translational processing to generate active enzyme. In the proposed research, I will investigate the hypothesis that these enzymes contribute to *V. cholerae* pathogenicity in infected rabbits, determine how VC0157 activity is regulated in vitro, and identify host-secreted serine hydrolases that modulate *V. cholerae* infection. I will generate a panel of mutants to test whether individual or collective loss of the *V. cholerae* proteases affects bacterial virulence in infected rabbits and to determine their in vivo proteolytic targets using ABPP and mass spectrometry. I will also characterize the molecular and environmental factors that govern the conditional activation of VC0157 in vitro. Finally, I will use ABPP to identify host enzymes that are specifically activated by *V. cholerae* in infected rabbits and human enterocyte-like cells. My work will define the enzymatic crosstalk between this global enteric pathogen and the host, with the long-term goal of identifying potential therapeutic approaches for cholera. In addition, these studies will provide a roadmap for future applications of ABPP to elucidate enzymes that facilitate infection by other pathogens.

“Molecular Mechanisms of microRNA and Argonaute Turnover”

MicroRNAs are small 22-23 nucleotide RNAs which bind to Argonaute proteins to negatively regulate protein-coding genes through sequence-specific complementarity. The expression of microRNAs is frequently dysregulated in many human diseases, including cancer. The biogenesis of microRNAs is extensively studied, and comparatively little is understood about their turnover. Untemplated nucleotide additions at the 3' end of microRNAs are correlated with destabilization, but their functional role remains unclear. The objective of this work is to discover the regulators and effectors of microRNA and Argonaute turnover. In addition, we will examine the role of 3' nucleotide additions in microRNA turnover.

We will use three approaches in *C. elegans* to identify regulators and effectors of microRNA turnover. First, microRNA biogenesis will be acutely inactivated in a temperature-sensitive mutant, and proteomic analysis will identify proteins that are preferentially bound to microRNAs over the course of their decay. In a second approach, we will transiently tag Argonaute at its endogenous locus; tagged proteins will be immunoprecipitated over the course of their decay to identify binding partners which are enriched during this process. Third, we will conduct a forward genetic screen for suppressors of a hypomorphic microRNA phenotype, with the rationale that a subset of these suppressors will increase microRNA levels and may impact microRNA turnover. We will use the systems established herein to assess the

impact of candidate proteins on rates of microRNA decay, Argonaute decay, and 3' untemplated nucleotide additions. By examining all three processes, we aim to elucidate if and how their mechanisms are functionally coupled.

Because microRNA levels are likely to be regulated by the balance of the rates of biogenesis and turnover, understanding the determinants and mechanisms of turnover will add to our overall understanding of microRNA regulation and normal development. Because microRNA dysregulation contributes to human disease, these studies may also open novel therapeutic avenues through the targeted inhibition or modulation of microRNA turnover.

"O-GlcNAcylation: A Glucose Sensing Pathway for Mitochondria and Energy Homeostasis"

The central nervous system plays an important role in regulating feeding behavior and metabolism; disruption of this regulation leads to obesity, metabolic syndrome, and Alzheimer's disease. This proposal addresses critical questions about how nutrient availability is sensed in the nervous system and what molecules are involved in the regulation of metabolic homeostasis. It builds upon our recent findings that the cytosolic glycosylating enzyme O-GlcNAc Transferase (OGT) diminishes mitochondrial motility based on glucose availability via a direct interaction with, and GlcNAc modification of, a key protein in the motor adaptor complex. I now seek to put this finding into a physiological context by determining the mechanisms by which extracellular metabolic cues regulate mitochondrial function via OGT, and how it contributes to bioenergetics, particularly in hypothalamic neuroendocrine circuit. I will accomplish these goals by investigating the following Specific Aims: Aim 1 concerns how mitochondria sense nutrient availability and how their subsequent change in localization regulates cellular bioenergetics and metabolic homeostasis in neurons. Aim2 investigates how the glucose-sensitivity of mitochondria affects whole-body energy balance by specifically studying this pathway in the arcuate nucleus of the hypothalamus. The anticipated findings should facilitate our understanding of the biochemical pathways that underlie diabetes, other endocrine and metabolic diseases, nutritional disorders, and obesity.

"Molecular Mechanisms Underlying Beige Adipocyte Dynamics in Response to Thermal Challenges"

Adipocytes are normally classified as white or brown, but a distinct type of fat cell, called the beige adipocyte, has recently been identified. These cells support thermogenesis and dissipate calories like brown adipocytes but reside within white adipose tissue regions, and express an overlapping but unique set of genes. They have recently been discovered in adult humans, holding therapeutic potential for obesity and diabetes. Beige adipocytes display dynamic population changes and cellular plasticity in response to temperature changes. Our long-term goal is to understand how to manipulate beige adipocyte number and activity for use in the therapy of metabolic diseases. It has been recently reported that beige adipocytes are newly differentiated from precursor cells upon cold exposure, and they convert into white adipocyte-like cells in response to subsequent warming. However, mechanisms underlying such beige cell dynamics are poorly understood, in large part because the cellular

heterogeneity of the adipose depot complicates the isolation and analysis of this specific minority cell type.

To elucidate mechanisms underlying beige adipocyte dynamics, we recently developed two mouse strains, UCP1-Cre and Rosa26fs-H2B-TRAP, which allow in vivo tracing of beige adipocytes and isolation of their transcripts and nuclei from a complex cellular mixture. My preliminary results using these strains suggest that beige adipocytes undergo one of two possible fates after warming: conversion into the white-like state or cell death. Also, this turnover process appears to be faster than has been reported for adipocytes generally, suggesting that beige adipocytes have a unique cell turnover mechanism. To address this, I propose two major aims. First, to determine cellular fate of beige adipocytes in response to warm conditions, I will analyze their fate and quantify turnover rate by tracing labeled beige adipocytes using immunohistochemistry and cell death assays. Second, to define molecular mechanisms that regulate beige adipocyte turnover, I will employ comprehensive transcriptional and epigenomic analyses to identify transcriptional pathways and downstream effectors that mediate beige adipocyte turnover during warming. These studies will advance our understanding of adipose biology, suggesting novel therapeutic strategies for obesity and diabetes.

"Molecular Tools for Precision Control of Cellular Signaling"

Standard therapies for many cancers and neurodegenerative diseases are lacking due to a paucity of drug-able targets, side effects, and, most importantly, an incomplete understanding of disease biology. The complexity of ion channel and receptor signaling renders our understanding of cellular signal transduction in even the best-studied types of cells incomplete. Generating tools that allow cell-type specific, rapidly-perturbable pharmacology is therefore of great interest to many fields of medicine and biology.

We have addressed this need by designing and implementing a new set of optogenetic reagents. These reagents, called lumitoxins, combine a photoswitch and an ion channel-blocking peptide toxin to actuate specific endogenous ion channels. Lumitoxins enable cellular physiology to be perturbed in a fully genetically encoded and rapidly reversible way, without the need for exogenous chemical co-factors.

Going forward, our strategy is to build on the lumitoxin technology, to further enhance and validate it, and to develop derivative technologies that are based on these novel optogenetic reagents and concepts of protein engineering. With lumitoxin technology, by acting on ion channels and ligand-gated receptors, it may become possible to alter specific signaling pathways in a defined set of intact cells, and then to study their effects on normal and pathological biological functions. In this way we address unmet needs in human health by furthering our understanding of how cells sense, integrate and exchange information about their environment, how pathologic changes in these processes relate to disease, and how insights into the disease's biology can offer new therapeutic points of intervention.

"Clonal Analysis of Hematopoiesis in Aging"

Aging of the hematopoietic system is characterized by progressive decline in homeostatic maintenance and gradual loss of regenerative capacity following hematopoietic stress. This aging process is frequently associated with the onset of chronic anemia, the diminished adaptive immunity, and the elevated incidence of myeloproliferative diseases, all of which have been suggested to result from dysfunctions of aged hematopoietic stem cells (HSC). Although the functional alterations of HSCs during aging have been extensively characterized with bone marrow transplantation experiments, it is currently unknown how exactly HSCs behave in their native bone marrow niche during the natural process of aging, and how the potential changes of this primitive population will contribute to the deterioration of the hematopoietic system over time.

In order to understand the clonal dynamics of native hematopoiesis, our laboratory has established a novel mouse model where cells can be uniquely and genetically labeled in situ. Using this approach, we carried out longitudinal analysis of hematopoiesis at steady state, and found the successive contribution by hundreds to thousands of clones to the maintenance of blood homeostasis, which is in stark contrast to the oligoclonal behaviors following bone marrow transplantation. Our data implied that progenitors, rather than HSCs as previously believed, are the main drivers of unperturbed hematopoiesis. These findings not only uncovered distinct cellular mechanisms driving blood regeneration under different conditions, they also raise new questions with regard to the contributions of the dynamic progenitor populations in the aging process.

In the current application, I propose to investigate the impact of aging on the clonal behaviors of hematopoietic stem and progenitor cells in their native niche. Specifically, I plan to examine the exact changes that will occur to the complexity and dynamics of the progenitor and stem cells during the aging process (Aim 1). I will also determine the effect of aging on the regenerative capacity of these populations following multiple hematopoietic stresses (Aim 2). These proposed studies are built upon my previous work on clonal analysis, and will promise to bring in new insights to the aging hematopoietic system.

"Hsp90 Regulation of Prion-Based Translation: Molecular Mechanisms and Evolutionary Conservation"

Prions are proteins that are able to convey epigenetic elements of cellular memory through conformational switching. Although originally associated with pathology, prion-like conformational switching is emerging as a novel mechanism for cellular regulation. The most abundant subgroup of cellular proteins predicted to have prion-like properties is the RNA-binding protein (RBP) class of proteins. The abundance of PrDs in RBPs is conserved from yeast to humans, suggesting a modular function for these domains. To date, little is known regarding the function or regulation of these PrDs. However, prion-based mechanisms can serve as a switch and a sensor to environmental cues, whereby the change in protein conformation alone is sufficient to induce an altered cellular response. In the case of RBPs, induced conformational switching could directly affect protein translation and cellular homeostasis. My goal is to explore the role of PrD-containing RBPs in regulating protein translation.

In yeast, prion propagation and inheritance is highly dependent on the chaperones Hsp104 and Hsp70. We have preliminary evidence that an additional chaperone, Hsp90, is a novel regulator of a protein

translation phenotype that is prion in nature. In this project I intend to characterize the evolutionary conservation (between yeast and humans) of the role of the chaperone machinery in regulating RBPs. Initially, I will examine all known RBPs in human and yeast cells and determine whether they have prion-like characteristics by high-throughput biochemical analysis of aggregating propensities. Next I will determine which chaperones regulate prion conformational switching. In the yeast model I will use genetic and pharmacological perturbations. In human systems I will analyze the interactions of all RBPs with Hsp90, Hsp70 and their co-chaperones in hope of identifying and characterizing specific co-chaperones that mediate RBP prion switching utilizing the LUMIER assay, which is high-throughput platform developed in the Lindquist lab.

I believe that the integration of the experimental results obtained in the yeast model together with the high-throughput data from the mammalian system will provide us with an integrative picture of what might be an ancient prion-based network of translation regulation that may be relevant to many other essential cellular pathways.

“Mechanisms Involved in the Formation of the ER Network and Nuclear Envelope”

The broad goal of this project is to understand how organelles are shaped, in particular, the endoplasmic reticulum (ER) and the nuclear envelope (NE). We will use *Xenopus* egg extracts to address these questions. Previous experiments have identified proteins that shape the tubules (RTNs and DP1) and mediate the fusion of ER membranes (ATLs). Now, we will address how these proteins and a new protein identified recently, termed lunapark (LNP), collaborate to form an ER network. The first aim is to test a possible role of LNP in stabilizing three-way junctions between ER tubules. Our preliminary data show that LNP inactivation induces tubule-to-sheet transition of the ER network. A cytosolic factor seems to be involved. The morphological changes are strikingly similar to those seen during the transition between interphase and mitosis. Our goal is to identify the cytosolic factor and to elucidate how LNP inactivation leads to the changes in ER morphology. This will also provide insight into the mechanism of tubule-to-sheet transition during mitosis. A second aim is to test whether ATL activity is required for the function of the tubule-stabilizing proteins (RTNs and DP1). We have made the surprising observation that ATL function is not only required for network formation, but also for its maintenance. Inactivation of ATL leads to the rapid disassembly of the ER network into small vesicles and short tubules. We hypothesize that many three-way junctions are actually tethered by ATL, rather than fused, and that ATL activity is required for the tubule-stabilizing function of the RTNs and DP1. We propose several experiments to test these hypotheses. The third goal is to clarify the mechanism of NE formation. We have recently reported that there are multiple fusion steps during NE assembly, including one that requires the function of ER SNAREs. Additional experiments show that importin beta and Ran play a role in NE formation. We suggest that a fusion factor is bound to importin beta in a RanGTP-dependent manner. Our goal is to identify the factor, clarify the connection with ER SNAREs, and characterize different vesicle populations required for NE formation.

“Phosphorylation Recognition and Wnt Signaling Complex Assemblies by the Intrinsically Disordered Scaffold Protein Axin”

Wnt signaling through the transcriptional coactivator beta-catenin (the canonical Wnt pathway) has pivotal roles in embryonic development, stem cell regulation, and cancer and disease pathogenesis. Understanding/targeting the Wnt pathway may offer new therapeutic opportunities. The Axin scaffolding protein is a tumor suppressor and acts to degrade beta-catenin, whereas the Wnt receptor LRP6 inactivates Axin to stabilize beta-catenin. Axin binds to activated/phosphorylated LRP6 (p-LRP6), constituting a key initiation step in Wnt signaling; Axin phosphorylation further regulates Axin/p-LRP6 interaction. Mechanisms by which the Axin/p-LRP6 complex is assembled and Axin phosphorylation regulates this assembly are poorly understood. Intriguingly Axin belongs to intrinsically disordered proteins (IDPs), which account for more than a third of the eukaryotic proteome and are essential for most or all cellular function. IDPs lack a fixed 3D structure and therefore provide unique features including flexibility and evolvability for dynamic protein interactions. Although the role of IDPs in protein-protein interactions is well documented, whether an IDP can function as a module for recognition of post-translational modifications such as phosphorylation is unknown. This may be in part a result of the dogmatic view that protein phosphorylation is recognized by “domains” that have defined 3D structures such as the archetypal SH2 domain. I have acquired preliminary and exciting data suggesting that Axin/p-LRP6 interaction represents the first example of phosphorylation recognition by an IDP, thus departing from the paradigm of phosphorylation recognition by structured protein domains. In this application I propose (i) to characterize the mechanism by which Axin recognizes p-LRP6; (ii) to investigate the mechanism by which Axin phosphorylation regulates the Axin/p-LRP6 complex assembly; and (iii) to identify compounds that disrupt the Axin/p-LRP6 complex, thereby blocking Wnt signaling. My studies will provide insights into the Axin tumor suppressor function and Wnt signal transduction, reveal principles governing IDPs in recognition of phosphorylation and possibly other post-translational modifications, and broaden our understanding of IDPs in biological regulation. My experiments may further facilitate therapeutic development for cancers with excessive Wnt signaling.

“Proteomics of Nucleocytoplasmic Partitioning”

The defining eukaryotic organelle, the nucleus, is bound by the nuclear envelope, which separates nuclear from cytoplasmic activities and allows for complex regulation. The nucleocytoplasmic distribution often encodes critical information during development, stress response, and general cell signaling. Despite the nucleus's central role, its molecular composition, how it adapts to perturbations, and how nuclear organization is related to disease is still poorly understood.

I chose the giant *Xenopus* oocytes as a primary model to study nucleocytoplasmic partitioning since it allows for physical isolation of the nucleus, avoiding protein loss or gain during isolation. Using two different methods of accurate quantitative proteomics, I found an unexpected trimodal distribution. Most proteins are exclusively located in nucleus or cytoplasm with a third subset approximately equally partitioned.

I will probe the selective barrier properties of the nuclear envelope. In apparent contradiction to the current model for nuclear pore permeability, my data indicates that many small proteins are sharply partitioned between nucleus and cytoplasm. I will explore the selectivity of the nuclear pore on a proteome-wide scale by injecting a prokaryotic proteome (passive to nuclear transport) into the cytoplasm of a eukaryotic cell. I then will measure the proteins' equilibration times with quantitative proteomics. As an alternative hypothesis, I will test if the majority of small proteins is bound in large protein complexes and therefore impermeable to nuclear pores.

Secondly, I will ask if substrate affinities to importins or exportins predict nucleocytoplasmic partitioning. Importins' and exportins' substrate affinity changes upon binding of Ran-GTP, which is restricted to the nucleus. I will quantify the Ran-GTP dependent binding affinity of substrates for all importins and exportins. An immediate application of this data will be to evaluate and improve algorithms to predict a protein's affinity to import/export receptors and subcellular localization.

By combining innovative mass-spectrometry based proteomics and classical biological tools, I have laid the foundation to study nucleocytoplasmic partitioning and the underlying mechanisms with molecular resolution on a proteome-wide level. The results will provide us with insight into cellular organization and may provide opportunities to treat nuclear mis-regulations often found in cancer and other diseases.

"Splicing Regulation of Drosophila Germline Stem Cell Self-renewal and Signaling Transduction"

Stem cells possess the remarkable capacity to generate two cells of distinct fate upon division, with one cell retaining the stem cell state and the other cell destined to terminally differentiate. Although mammalian cell culture approaches have provided insight in this process, it is more desirable to study stem cells in their native environment, where they receive signals and interact with the stem cell niche. To understand the molecular basis of stem cell self-renewal in vivo, I used *Drosophila* germline stem cell (GSC) as a model system and performed a large-scale RNAi screen covering ~25% of the *Drosophila* genome. I identified 366 genes required for GSC maintenance or differentiation, allowing me to construct a comprehensive network for GSC regulation.

I performed a complex-enrichment analysis and identified several protein complexes and decided to focus on RNA splicing genes due to their impressive phenotypes upon knockdown. In particular, *spenito* (*nito*), identified from my RNAi screen, gives a strong stem-cell-tumor phenotype. Its human ortholog, OTT was originally identified from infants with acute myeloid leukemia (AML). Chromosomal translocation, resulting in fusion of OTT with another gene MAL, leads to leukemia but the mechanism is poorly understood. Recently, I made the surprising observation that Nito regulates sex determination by affecting the splicing of the master sex determination gene *sex-lethal* (*sxl*). Moreover, I found that Nito regulates Dpp/BMP signaling pathway that is essential for growth and patterning during development. I propose to analyze the mechanisms by which Nito, as well as other splicing genes, controls GSC self-renewal and signal transduction during development. Specifically, I will: Aim 1: Characterize the mechanism by which Nito regulates *sxl* splicing; Aim 2: Determine how Nito controls Dpp signal transduction pathway; and Aim 3: Study the functions of other splicing genes identified from my unbiased genetic screen, such as the exon junction complex (EJC). By combining molecular, cellular and genetic approaches together with deep-sequencing technique, I hope to establish the mechanism by

which Nito regulates both sex identity and tissue growth, uncover the targets of its splicing function, and identify potential new therapeutic targets for OTT-mediated AML.

“Mitochondrial Energy Status Regulate SIRT3 Interactome and Function”

SIRT3 is the major mitochondrial deacetylase, which has been established to have a wide spectrum of substrates in mitochondria. This protein plays an important role in many diseases, including neuron degenerative diseases and cancer. Although over 20 different substrates have been identified, little is known about how this enzyme is regulated and how it preferentially binds to some substrates rather than others, under different conditions, to facilitate its multiple regulatory roles in mitochondria. By constructing and analyzing the mitochondrial sirtuin network, we found that SIRT3 exhibits a unique strong physical association with mitochondrial ATP synthase (Complex V). More importantly, we further discovered that this binding is affected by mitochondrial membrane potential and Complex V function. We hypothesize that SIRT3 plays an important role in energy metabolism and the existence of a feedback loop through Complex V, which regulates SIRT3 function to determine its mitochondrial distribution and interactome. We further propose that this regulation is governed by mitochondrial energy status. Specifically, Complex V holds SIRT3 under normal condition but releases SIRT3 into the mitochondrial matrix with a decrease in membrane potential.

The goal of this research is to test this hypothesis by first investigating how membrane potential and Complex V activity regulate the interactome of SIRT3; then we will decipher the binding mechanism between SIRT3 and Complex V, and last we will investigate how this binding balances mitochondria energy status through changing of SIRT3 interactome.

Taken together, this study may reveal a novel mechanism of post translational regulation of SIRT3 as well as a new function for Complex V besides ATP synthesis. By studying SIRT3 from a different angle, the proposed research can increase our understanding of this major mitochondrial deacetylase. Therefore this study should be of great interest to the sirtuin field, as well as to the general mitochondrial bioenergetics field. In long term, knowledge obtained from our work may benefit drug development targeting SIRT3. Considering SIRT3 may not be the only enzyme regulated in this manner, this study may also open a new window for studies on mitochondrial function and mitochondrial-related diseases.

“Mutations in QARS, Encoding Glutaminyl-tRNA Synthetase, Cause Progressive Microcephaly, Cerebral-Cerebellar Atrophy and Intractable Seizures”

Microcephaly is a congenital or early-childhood neurodevelopmental disorder that an individual's head circumference is significantly smaller than expected for age and gender. Progressive microcephaly associated with diffuse cerebral-cerebellar atrophy and epilepsy is a heterogeneous condition and accompanies various neurodegenerative diseases. We identified four children from two unrelated Caucasian families to display progressive microcephaly, diffuse cerebral-cerebellar atrophy and

devastating seizures. Through whole exome sequencing, we identified QARS as the only candidate causative gene in each family. These results lead to our first hypothesis that recessive mutations in QARS cause progressive microcephaly and intractable seizures. Specific Aim 1: to determine the role of QARS mutations in progressive microcephaly by modeling the human syndrome in zebrafish and genetic complimentary tests. We found that QARS is highly expressed in the developing human and zebrafish brains, and that *qars* zebrafish morphants and mutants display almost identical small brain, small eye and uncoordinated movement phenotypes. I propose to determine the pathogenicity of individual human QARS mutation through introducing them into zebrafish morphants and measuring the rescuing effects of brain and eye sizes. The effect of glutamine supplement will also be tested in morphants injected with mutant QARS mRNAs. The small brain phenotype in zebrafish morphant and mutants may be consequences of either defective cell proliferation or premature cell death, and these possibilities will be determined by immunohistochemistry assays on brain sections. Specific Aim 2: to investigate the molecular mechanisms how human QARS mutations impair QARS protein functions. QARS encodes the glutaminyl-tRNA synthetase, which conducts aminoacylation reactions and precisely attaches glutamine to correct tRNAs for faithful protein translation. We found that QARS aminoacylation activities are significantly reduced in cell lines derived from affected children and their QARS heterozygous parents when compared to healthy controls, with affected children's the lowest. This leads to our second hypothesis that each QARS mutations impair QARS aminoacylation activity. I propose to purify individual QARS mutant proteins and test their aminoacylation activity using the same assay as was done with patient cell lines. I'll also express individual mutant QARS cDNA in tissue culture cells and examine their interaction with the multiple synthetase complexes.

“Generation of Novel Probes to Explore the Role of Mrgprs in Pruritus”

There is an unmet need for novel strategies to treat pruritus (itch). Itch is defined as an unpleasant sensation that leads to a desire to scratch and is a symptom associated with both skin diseases as well as many diseases that affect other organ systems. Pruritus has a dramatic effect on quality of life of individuals suffering from this relatively poorly understood condition. Of particular concern, psychological manifestations including difficulties with daily activities, sleep disturbances, and disruptions in the quality of social life are reported among individuals suffering from chronic pruritus. Very few treatment options for pruritus exist and although there have been many advances with regards to understanding the transmission of itch sensations, there still remain large gaps in defining and characterizing the pathways that mediate this disease. Furthermore, better tools are needed to probe the interaction between neurofibers, target cell types, and the mediators of itch in model systems.

With enhanced knowledge of the molecular basis of itch, selected G protein-coupled receptors (GPCRs) have emerged as promising therapeutic targets. Histamine receptors are one class of GPCRs that have long been associated with itch. The subset of patients with histamine dependent itch can be successfully treated with histamine receptor antagonists. Outside this realm, many questions remain. Recently, the Mrgpr (Mrg/SNSR) family of orphan GPCRs has received attention due to their expression in primary sensory neurons. Of particular clinical interest, human MrgprX1 has been implicated in modulating histamine independent itch.

Despite this exciting progress, few pharmacological tools exist to explore Mrgpr receptors, in particular MrgprX1, as modulators of pruritus. Therefore, the goal of this proposal is to utilize a well-established strategy developed in our laboratory to generate and characterize novel probes for this receptor. Prior success in another disease area has been demonstrated using the proposed strategy to generate stable, long-acting modulators of GPCRs that show therapeutic utility in vivo. The overall impact of our proposed efforts with Mrgprs will include (i) the development of novel pharmacological tools for dissecting mechanisms involved in Mrgpr mediated itch and (ii) taking initial steps towards developing a new class of therapeutics for pruritus.

“Elucidating a Non Canonical Mechanism of mTORC1 Activation”

The mammalian target of rapamycin complex 1 (mTORC1) signaling pathway drives cell growth and anabolism by its ability to integrate signals from growth factors and nutrients. mTORC1 activity is deregulated in several complex diseases, as cancer, type 2 diabetes and aging. Hence, exploring the

mechanisms that lead to mTORC1 deregulation is key for improving our understanding of the pathogenesis of these diseases. We recently described the Rag family of GTPases as key for mTORC1 activation by amino acids, through a mechanism that requires mTORC1 shuttling to the lysosomal surface. In our efforts to generate mice with loss and gain of function alleles for the Rag GTPases, we have established a series of immortalized cell lines derived from mice that lack RagA. Although mTORC1 activity is barely detectable in RagA-deficient embryos, cell lines derived from them show reactivated mTORC1 signaling, which is now insensitive to amino acids withdrawal, but sensitive to growth factors withdrawal. Intriguingly, in these cell lines, mTORC1, although active, does not localize to lysosomes. This altered localization does not fit with current paradigm of mTORC1 regulation indicating that an unknown mechanism of mTORC1 activation is at work. Based on a combination of transcriptional profiling and proteomic-based approaches, we plan to find the genes responsible for the lysosomal-independent activation of mTORC1 and to understand how this occurs. In particular, we will aim for the following goals:

Aim 1. Characterization of the amino acid-independent activation of mTORC1 in RagA-null cells.

Aim 2. Identification of candidate genes responsible of this novel signaling mechanism, by two complementary approaches: 1) Transcriptional profiling of RagA-null cells; and 2) Identification of novel mTORC1 interacting proteins in RagA-null cells.

After validation of the candidates in cell culture (Aim 3), we will take advantage of RagA-null livers to study in vivo the consequences of altering their expression.

Aim 4. In vivo knock-down and overexpression of validated genes.

Further elucidation of the molecular mechanism leading to mTORC1 desensitization to amino acid withdrawal, together with the identification of potentially druggable targets within this pathway, may pave the way for novel therapeutic approaches aimed to target mTORC1.

"A Novel Bacteriophage Resistance Mechanism in Vibrio Cholerae"

Vibrio cholerae is the causative agent of cholera, an acute diarrhoeal disease that is endemic in over 50 countries and also causes devastating epidemics. Bacteriophages that specifically prey on *V. cholerae* have been hypothesized to contribute to the seasonality of cholera epidemics, particularly in the endemic region of Bangladesh. The most predominant group of phages found in cholera patients are the ICP1 related phages, which have sustained an association with *V. cholerae* O1 for over a decade. We hypothesize that ICP1-mediated predation of *V. cholerae* O1 has directed the selective emergence of pathogenic clones that circulate to cause epidemic disease. We have identified a novel anti-ICP1 resistance mechanism, designated a phage inducible chromosomal island-like element (PLE), which is found in many ICP1-resistant clones that were isolated from patients since 2005. Some ICP1 related phages have since evolved a counter-resistance mechanism, which effectively targets the PLE for destruction, however we currently do not understand how the PLE exerts its anti-ICP1 effect. Preliminary data suggests that the *V. cholerae* PLE represents a novel phage resistance mechanism; ICP1

infection of an individual cell triggers the PLE to undergo an excision-replication-packaging (ERP) cycle which effectively blocks ICP1 replication, but still results in cell death in order for the PLE to be effectively packaged and spread to neighboring cells. The net result is elimination of ICP1 from the surrounding environment, and we predict, better preparedness of the population as a whole against future ICP1 attack. In this proposal I describe experiments that will fulfill two main aims: Aim 1: To determine the biological parameters of the ERP cycle of *V. cholerae* PLE1. Aim 2: To determine the mechanism of ICP1 interference by *V. cholerae* PLE1. We will use quantitative PCR, mass spectrometry and transduction assays to address the features of the ERP cycle. Additionally we propose to use a mutational approach to identify which of the 23 PLE1 encoded genes contribute to its anti-ICP1 activity. The long-term goal of this proposal is an increased understanding of the dynamic between ICP1 phage and their pathogenic host, which will provide insight into epidemic occurrence and ultimately intervention.

"DNA Homology Sensing in the Absence of Double-Strand Breaks"

The ability of two homologous DNA molecules to recognize one another is fundamental to sexual reproduction and accurate DNA repair, and may also underlie other chromatin processes, such as regulation of allele-specific transcription. While the known mechanism of direct homology recognition is initiated by a double-strand break (DSB) in one of the participating DNA molecules, the existence of an alternative, break-independent pathway is suggested by several unrelated phenomena that include somatic chromosome pairing in *Drosophila*, meiotic chromosome pairing prior to or in the absence of recombination in diverse species, and transient pairing of X chromosomes prior to X-inactivation in mammals. The basis for such break-independent pairing remains one of the central unsolved mysteries of chromosome biology, with proposed mechanisms including direct DNA/DNA contacts, RNA-mediated co-localization, DNA-guided protein/protein interactions

I chose to characterize the break-independent recognition of DNA homology in the fungus *Neurospora crassa*, where the phenomenon of RIP (Repeat Induced Point mutation) has provided the strongest support for the existence of direct sequence-specific interactions between intact DNA molecules. I found that DNA pairing in RIP is initiated within a short region of homology (<25 bp) and stabilized into a productive interaction by the cooperative alignment of many trinucleotides (>13-14) spaced evenly with a period of 11 bp. My working hypothesis is that this trinucleotide engagement involves a stacked quadruplex structure. While such DNA/DNA interactions are geometrically possible, they almost certainly require additional factors to form a stable complex. I propose to identify factors involved in RIP by a combination of genetic and biochemical approaches. Specifically: I will probe the possible role of Rad51, a molecule known to mediate a triplet-directed homology search during recombination. I will identify and characterize dominant gain-of-function mutations that increase RIP. I will also identify proteins that interact with the NcRID methyltransferase, the only factor now known to be directly involved in RIP. Once the molecular mechanism of RIP is elucidated, I hope to apply this understanding to a wider range of questions regarding the structural dynamics of chromatin in *Neurospora* and other model organisms.

“Understanding Neonatal Immunity: The Influence of Gut Microbial Colonization on Neonatal Adaptive Immunity”

A hallmark of adaptive immunity is the ability to mount protective antigen-specific responses to foreign agents while preventing deleterious responses to the hosts' own tissue. Autoimmune diseases arise due to a breakdown in tolerance mechanisms that keep pathogenic self-reactive T cells in check. The neonatal period is a unique ontological stage that is characterized by a largely immature immune system prone to tolerogenic responses. While beneficial for thwarting inappropriate autoreactivity, the lackluster immune responses in neonates has poor prognosis for successful pathogen-specific immunity as well as vaccinations. Interestingly, while newborns and infants are more susceptible to infectious diseases, infants in developed countries have become increasingly sensitive to developing autoimmunity such as Type 1 Diabetes (T1D) as well as allergies and asthma.

Alterations in intestinal microbiota or dysbiosis have been associated with the precipitation of several diseases such as T1D and IBD in adults. While dysbiosis can be brought about by various factors such as feeding regimens and antibiotic exposure, dramatic changes in gut microbial compositions also occur naturally during the post-natal period. Microbial colonization of the sterile fetal gut at birth and the establishment of a symbiont microbial community are critical for the development and maturation of the neonatal immune system. Whether neonatal adaptive immunity perceives changes to the intestinal microbial environment and how it impacts peripheral T cell tolerance is largely unknown. Understanding how the neonatal immune system first interacts with and normally tolerates fluctuations in the microbiota will help dissect the events of pediatric autoimmunity resulting from genuine dysbiosis. Further, mechanistic insights into the evolution of neonatal T cell responses will aid in the improved design of infant vaccine strategies as well as immune-directed therapies.

Using multiple approaches including multi-color flow cytometry, in vivo manipulations of cell populations in mono-colonized germ-free mice, and cutting-edge single cell RNA sequencing technology, we will methodically characterize the neonatal T cell response to evolving gut microbiota, test the autoimmune potential of peri-natal T cells and comprehensively map the molecular profiles and developmental trajectories of neonatal thymic precursors that influence peripheral tolerance to intestinal antigens and microbiota.

“From Ancient History to Modern Medicine: Selection, Disease, and Genome Function”

The revolution in genomics has yielded vast datasets of full genome sequences, new methods for rapid functional analysis, and discoveries of thousands of genes associated with common human diseases. However, pinpointing and functionally validating causal variants has proven to be much more difficult. One powerful, but often overlooked, tool for understanding the biology of the human genome is analysis of our recent evolutionary history. As we traveled out of Africa into a wide range of new environments, we experienced dramatic alterations in diet and disease risk. The rapid rise in frequency

of newly advantageous genomic variants left distinctive signatures in the genome of the affected population, spotlighting important functional loci, yet providing few clues to their function. By pairing tests for selection with phenotype association, I will connect those loci to particular traits, and by then integrating high-throughput functional assays, I will elucidate their effects on cellular mechanisms.

I will focus on a phenotype and population for which we have historical, epidemiological and genetic evidence consistent with strong selective pressure to develop this approach: cholera susceptibility in Bangladesh. Cholera is an ancient, common and deadly disease in the Ganges River Delta, and genetics is known to influence susceptibility. I propose to develop a high-throughput computational and experimental framework to rapidly identify, pinpoint, and functionally elucidate biologically important human mutations under selection by integrating three different types of genomic information: (1) natural selection; (2) disease association; and (3) high-throughput functional screens. I will then validate this approach by functionally testing top candidates and pinpointing the adaptive variants.

By using large, publically available genomic datasets, I propose to develop a tool that is trait-independent and can be applied to many human diseases where associated variants may have been subject to selective pressure, including infectious disease susceptibility, autoimmune diseases, and metabolic diseases. With evidence mounting that much (probably most) of human adaptation has occurred in regulatory regions, not in coding regions of genes, this work is critically important, allowing us to leverage the power of natural selection to identify and elucidate genetic variants altering genome function.

"Investigating molecular mechanism in genetic forms of ALS using patient-specific iPSCs"

Amyotrophic lateral sclerosis (ALS) is a fatal neurodegenerative disease that affects motor neurons in the brain and spinal cord. The vast majority of ALS is sporadic in nature while familial transmission accounts for approximately 10% of cases with mutations in an expanding number of functionally distinct but ubiquitously expressed genes. Approximately 60% of all familial cases can be accounted for by mutations in SOD1 and C9ORF72. Understanding the mechanisms that cause ALS and the discovery of treatments that might cure it have been hampered by the inaccessibility of human motor neurons. One important unresolved question in ALS and in all neurological disease is whether individuals with distinct mutations suffer through common degenerative mechanisms. Patient-specific induced pluripotent stem (iPS) cells, which are generated by reprogramming from readily available adult cells such as skin cells, provide an invaluable tool for in vitro disease modeling and could be used to address these questions.

Our preliminary data shows that iPS cell--derived motor neurons harboring mutations in the SOD1 gene degenerate in a manner reminiscent of the disease in patients, recapitulating key aspects of ALS. We propose to utilize this novel cellular model to address two outstanding questions in ALS with broader implications for the understanding of neurological disease. Do distinct familial mutations act through common molecular pathways to cause ALS? Why are motor neurons selectively vulnerable to the effects of these mutations, in genes that are widely expressed? In order to address the first question we will examine whether shared molecular and functional changes occur in motor neurons that harbor mutations in the two most common familial ALS genes, SOD1 and C9ORF72. To understand their selective vulnerability in ALS we will compare the effect of the SOD1A4V mutation in motor neurons to

its effect in distinct neuronal subtypes, which are resistant to degeneration in this condition. These experiments will provide an insight into the functional defects of human motor neurons in the vast majority of familial ALS and into the characteristics that infer their selective vulnerability. If successful, our studies will illuminate broadly relevant, potential routes for therapeutic intervention.

“The Systemic Impact of Wounding on Tumor Immunity and Metastatic Outgrowth”

The vast majority of cancer deaths are caused by the growth of metastases in vital organs, far from the site of the initial growth. Because tumor cells can spread through the body early in tumor development, surgical removal of the primary tumor is often not curative. The disseminated cancer cells usually remain dormant for extended periods of time, and the stimuli that induce these cells to renew proliferation are poorly understood. I am investigating the hypothesis that wounding and wound-healing associated with surgical primary tumor resection have systemic effects that trigger the outgrowth of dormant metastases. Specifically, I am investigating whether wounding can trigger the growth of distant metastases by inducing systemic immune-suppression that allows the dormant cells to escape from immune-mediated dormancy. Recent advances have demonstrated that many, if not all, tumors display immunogenic properties which activate anti-tumor immune surveillance mechanisms. In order to grow at a primary or secondary site, the tumor cells must escape immune regulation, either by acquiring immune-suppressive properties themselves, or by recruiting stromal cells that generate an immune-suppressive microenvironment. My preliminary studies have demonstrated that wounding a mouse can inhibit the T cell-dependent rejection of distant immunogenic tumors. This phenomenon appears to involve the systemic mobilization of monocytes, cells that are commonly recruited to sites of inflammation and tissue damage where, among many functions, they can restore homeostasis by restraining T cell responses. In this proposal, I aim to understand the systemic mechanism by which wounding can inhibit the anti-tumor immune response. I will first analyze the impact of wounding on the activity of T cells in the microenvironment of distant immunogenic tumors. I then aim to determine the specific role of mobilized monocytes in inhibiting tumor-specific T cells at distant sites. In the future, I will extend the study to investigate the systemic impact of wounding in established models of metastasis, in which micrometastases are restrained by tumor-specific T cells. Ultimately, I hope to uncover systemic mechanisms of immune suppression that can be targeted in cancer patients shortly after tumor resection in order to mitigate the adverse effects of wounding on dormant metastases.

“Molecular and Neural Mechanisms of a Hypoxia-Inducible-Factor (HIF) Regulated C. Elegans Behavior”

Oxygen deprivation followed by reoxygenation causes pathologic responses in numerous medical conditions, including ischemic reperfusion injury and myocardial infarction. The discovery of the *C. elegans* gene *egl-9*, which encodes an O₂-sensing hydroxylase that modifies and destabilizes the hypoxia-inducible-factor-1 transcription factor, has led to the identification of an evolutionarily conserved pathway central for O₂ homeostasis in organisms ranging from nematodes to humans. The

inhibition of mammalian homologs of EGL-9 strongly protects from myocardial ischemia and reperfusion injury. EGL-9 and HIF-1 are required for a *C. elegans* behavioral response to reoxygenation (the O₂-ON response) that is analogous to mammalian stroke-reperfusion injury responses. The molecular and neural mechanisms of the O₂-ON response are unknown. Key factors that act together with EGL-9 and HIF-1 in controlling the O₂-ON response are likely to define conserved mediators and modulators of hypoxia/reperfusion injury in humans.

From a series of genetic screens, I have recently discovered new components of the EGL-9/HIF-1 pathway and also isolated *C. elegans* mutants that define additional regulators of the O₂-ON response, some of which likely act downstream of HIF-1. The overall goal of this project is to analyze the genes defined by these mutants and determine the molecular and neural mechanisms of the O₂-ON response. In Aim 1, I will analyze genes that function as effectors of the EGL-9/HIF-1 pathway in regulating the O₂-ON response. In Aim 2, I will determine how EGL-25, a novel *C. elegans* homolog of progesterin and AdipoQ receptors that I have found to be required for the O₂-ON response, controls this response and interacts with the EGL-9/HIF-1 pathway. In Aim 3, I will identify the key sensory neurons and circuit responsible for the O₂-ON response and investigate how EGL-9 and EGL-25 control the O₂-ON response by modulating the sensory neural circuit function.

Using combined molecular, cellular and behavioral analyses together with powerful genetic screens, I hope to discover novel regulators and effectors of the EGL-9/HIF-1 pathway, establish mechanisms by which EGL-9 and EGL-25 control the O₂-ON response, and identify potential new therapeutic targets for the treatment of human ischemic disorders, including stroke-reperfusion injury and myocardial infarction.

"A novel platform for a vaccine against gastrointestinal bacterial diseases"

This proposal addresses the problem of developing a suitable vaccine for diarrheal illness. Every year there are about two billion cases of diarrheal disease and millions of deaths. Ninety-nine percent of these cases occur in developing countries, where diarrhea is the second-leading cause of death in children. Although bacterial-induced diarrhea caused by *Salmonella* result in more than 2 millions of deaths annually, there is not an effective vaccine against this pathogen. Efforts to develop vaccines for *Salmonella* have been hampered by: i) the difficulty in creating live vaccine strains that colonize efficiently without triggering overt disease, and ii) the inability of mutant or killed vaccine strains to generate a fully neutralizing mucosal immune response.

Thus, we propose to overcome the limitations of prior vaccine strategies by implementing a novel approach. The platform for this strategy is based on our discovery that the pathogenesis of *Salmonella* depends on conserved caspase-3 motifs found within key virulence proteins. Mutation of the caspase-3 cleavage motif in these virulence proteins dramatically reduces the ability of the organism to cause disease, while conserving its ability to colonize the intestine. We posit that mutation of caspase-3 motifs in virulence proteins of *Salmonella* is a compelling strategy to create new attenuated vaccine strains that can colonize the host without causing disease, while generating a protective immune response. We will test this hypothesis by:

- 1) Determining the ability of attenuated Salmonella strains to provide immunological protection in a murine model of salmonellosis.
- 2) Comparing the immune response generated in mice as well as that observed in naturally infected human patients, to validate the potential of our vaccine to translate to human applications.

We expect these studies will provide the framework for a novel vaccine formulation that could have widespread utility in developing countries with a high impact on global health.

“Intravital Analysis of NFAT Signaling Dynamics In Tumor-Associated T Regulatory Cells And Its Role In Promoting Local Immunological Tolerance To Cancer”

The immune system can mount an effective response against cancer, but its efficacy is severely hampered by immunoregulatory mechanisms acting in the tumor-draining lymph nodes and within the tumor tissue. T regulatory cells are key to establish immune tolerance to tumor, and their suppressive activities are likely regulated in similar ways to the effector activities of conventional T cells. Therefore, therapeutically targeting T regulatory cells to specifically disable their functions may provide a novel therapeutic strategy to maximize the anticancer effect of the immune response.

T cell receptor triggering and the relocation of the transcription factor NFAT from the cytoplasm to the nucleus are key for the acquisition of suppressive function by T regulatory cells (Tang et al., J Exp Med 2004; Wu et al., Cell 2006). However, the anatomic location, the causative cellular interactions, and kinetics of NFAT activation in T regulatory cells have never been investigated.

Here we hypothesize that NFAT activation in T regulatory cells drives their expansion within tumor-draining lymph nodes and migration to as well as accumulation in the tumor tissue, which crucially contributes to the establishment of local immune tolerance. We propose to test this hypothesis through a novel technology that allows us to visualize and quantify the dynamics of NFAT signaling in T cells in live anesthetized mice through multiphoton intravital microscopy (Marangoni et al., Immunity, in press). In addition, genetic gain- and loss-of-function experiments will help us to identify the precise functional consequences of NFAT activation in T regulatory cells. Specific modulation of the NFAT signaling pathway in T regulatory cells, also explored in the proposal, may provide a therapeutic platform to overcome immunological tolerance to cancer.

“Innate Immune system over activation impairs Liver regeneration”

Nearly 20% of patients on the wait list for liver transplantation die before a donor liver becomes available. Although the unique ability of the liver to regenerate makes living and split liver donation

possible, the risk of small for size syndrome (SFSS), or death due to insufficient mass and failure of the remaining liver to regenerate, has limited their applicability. Successful liver regeneration is the summation of interacting pathways, and a key player is the innate immune system. We believe that modulation of innate immunity will promote liver regeneration, allowing smaller segment transplantation and effectively expanding the donor pool. The long-term goal of my research is to understand how activation of the innate immune system by liver injury, decreased hepatocyte mass, and bridge therapies impact liver regeneration.

In Aim 1, I will employ a non-human primate model of SFSS by 90% hepatectomy established in our lab, to dissect the role of the different innate immune cell populations in liver regeneration. I will test the hypothesis that inhibiting over activation of the innate immune system will limit hepatocyte injury and promote regeneration, and I will compare immune cell activation and liver regeneration in baboons that have undergone 90% hepatectomy with and without immunosuppression. Innate immune activation will be analyzed by flow cytometry, histology, serum cytokine levels and liver damage and regeneration measured by standard clinical laboratory parameters, histology, Ki67 and TUNEL staining, liver weight measurements, and immunofluorescence for cell cycle proteins.

We have also developed an auxiliary liver xenotransplantation model as temporary support for SFSS. In Aim 2, I will utilize this system to examine the possibility that additional activation of the innate immune system by the introduction of xenotissue impairs native liver regeneration, and I will explore how this is balanced by the presence of supplemental hepatocyte function. We will compare both native and xenoliver injury and recovery in animals that undergo 90% hepatectomy only, xenotransplant only, and 90% hepatectomy plus xenotransplant.

The proposed aims represent first steps in a research program geared to revealing how and why the over activation of the innate immune system affects liver regeneration.

"Degeneracy in Ion Channel Function and its Relation to Nervous System Robustness and Flexibility"

Nervous systems are inherently variable: the components that make up neurons and neural circuits vary between organisms of the same species and vary within the same organism over time. How can reliable nervous system function -- which is essential for life -- emerge from such variability? One important and reliable feature of nervous system function is that it can be modulated to generate different patterns of electrical activity that control behaviors such as sleep, feeding, attention and motor activity. Modulation is mediated by endogenous substances such as peptides and monoamines that alter the signaling properties of subsets of ion channels which determine the electrical properties of neurons. However, experiments have shown that ion channel expression in single neurons is highly variable and continually turning over to maintain some kind of 'target' activity. In addition, ion channel types often overlap in their functional properties within the same cell -- a phenomenon known as degeneracy. It is therefore something of a mystery that neuromodulators are capable of inducing reliable and physiologically important changes in the activity of neurons and networks in spite of ongoing 'homeostatic' tuning and the highly variable nature of ion channel expression.

This project will use computational methods to understand how reliable neuromodulation can be achieved in model neurons and networks that have biologically realistic properties. The models will be based on data from a well characterized model nervous system in which neuromodulation is known to be functionally important, the crustacean stomatogastric ganglion. A novel aspect will be a systematic investigation of degeneracy by constructing families of models that have membrane conductances that functionally overlap in a controlled way that mirrors experimentally-measured properties of ion channel subtypes. I will test the hypothesis that such degeneracy in fact facilitates reliable neuromodulation in self-regulating circuits. The overall goal is to understand if consistent neuromodulation is compatible with homeostatic regulation, or whether this requires novel mechanisms that are yet to be identified experimentally. This has important general consequences for understanding phenotypic variability and robustness in nervous systems.

"Function and differentiation of transnuclear CD8 T cells"

Herpesviruses and infectious agents such as *Toxoplasma gondii* cause significant morbidity in immunocompromised individuals, as is the case for those with HIV/AIDS. These pathogens cause persistent infections, the control of which requires T cells of appropriate specificity. A demonstration that antigen-specific CD8 T cells contribute to protection requires that these cells can be isolated in pure form and used in adoptive transfer experiments. In normal animals, the frequency of cells specific for a given antigen is very low and therefore a source of CD8 T cells of defined specificity, obtained from mice with a homogeneous T cell compartment, is required to study their contribution to protective immunity. Physiological models to explore the immune response to the antigen of *T. gondii* and ORF8 and ORF61 of the mouse gamma herpesvirus MHV68 (MHV68) were created by somatic cell nuclear transfer. These mice serve as a source of CD8 T cells of defined specificity, without relying on gene targeting or transgenesis. The functional properties and differentiation of CD8 TN T cells during persistent infections will be investigated using deep sequencing and other immunological methods. Follow up studies on some of the interesting hits obtained from RNA seq experiments will be performed to identify signatures of activated and memory cells. Additionally, how antigen specific CD8 T cell responses are affected by concurrent persistent infections will be investigated. The specific aims include:

1. Systematic analyses of the transcriptomes (RNAseq) of differentiating activated and memory CD8 T cells in order to identify their key molecular signatures, with definition of CD8 T cell subsets as a possible added dividend.
2. To assess the role of galectin-3 in differentiation of virus-specific CD8 T cells and in the outcome of gamma herpes viral infection.
3. To assess the influence of concurrent infection with *T. gondii* on the responsiveness of MHV-ORF8-specific CD8 T cells.

"A bacteria-based system for studying and uncovering amyloidogenic proteins"

The misfolding and aggregation of various proteins into highly ordered fibers termed amyloid is associated with a wide range of devastating human diseases that includes Alzheimer's, Parkinson's, Huntington's and the inevitably fatal prion diseases. Despite intensive scientific attention, many fundamental questions about the processes that trigger amyloid aggregation remain to be answered. With no effective therapies available to alter the course of amyloid-associated diseases, new experimental avenues are crucial. The objective of the proposed research is to mobilize bacterial genetics as a new experimental system to probe the behavior of amyloid proteins in a simplified cellular setting.

The proposed experimental system is based on our demonstration that a recombinant amyloidogenic protein can be targeted to the bacterial cell surface by exploiting a dedicated export pathway normally used for the export of two *E. coli* amyloidogenic proteins. Upon export to the cell surface, aggregation of the recombinant protein into the amyloid form can be monitored using a dye, Congo red (CR), which binds preferentially to amyloid aggregates. Therefore, *E. coli* cells grown on agar medium supplemented with CR form red colonies if amyloid fibers are being formed at the cell surface. By using colony color as a readout for the aggregation state of the exported protein, we propose to screen for small molecules that can disrupt the formation of amyloid aggregates as means to explore new avenues for the development of therapeutics for amyloid-associated diseases. Additionally, based on the efficiency with which the export system facilitates conversion of amyloidogenic proteins from bacteria, yeast and human into the amyloid form, it will be developed as a simplified method for generating disease-related amyloid aggregates, which will serve as an essential tool for the study of amyloid aggregates. Finally, the colony-color phenotype will also be used to screen for novel amyloid-forming proteins, the identification and characterization of which will provide a better understanding of mechanisms for controlling amyloid aggregation.

"The Mechanism of Tail-Anchored Membrane Protein Insertion into the Endoplasmic Reticulum"

Tail-anchored (TA) proteins are membrane proteins anchored on the cytosolic surface of cellular membranes by a single transmembrane domain at the C-terminus. This class of proteins includes SNAREs, which mediate vesicular transport, and members of the Bcl2 family, which mediate apoptosis. The majority of TA proteins are post-translationally targeted for insertion into the endoplasmic reticulum (ER) by a mechanism that has historically been difficult to pin down. In the past three years, I have made several prominent discoveries about this mechanism, which is called the GET pathway and is conserved from yeast to man. At the moment, the key unanswered question in the field is how the Get1/2 transmembrane complex mediates TA protein insertion. I have obtained preliminary evidence that the transmembrane regions of Get1/2 facilitate tail anchor entry into the lipid bilayer. Moreover, I have developed a complementing in vivo and in vitro yeast system for carrying out a structure-function analysis of Get1/2, which includes an engineered TA protein that arrests at the integration step of the GET pathway. Membrane protein biogenesis is still a poorly understood area of cell biology. In particular, the precise mechanism of membrane protein insertion by other pathways has been difficult to dissect because of the biochemically complex nature of the substrates and machineries involved. In published work, I have demonstrated that the biochemical requirements for TA protein insertion by the

GET pathway are relatively simple. Thus, I am in an ideal position now to exploit this system to reveal new fundamental insights into how cells chaperone membrane proteins. While this research is very basic it also has direct relevance to human cancer chemotherapy. Specifically, the GET pathway is a major determinant of cisplatin resistance in mammalian cells. Moreover, GET pathway knockdown confers cisplatin sensitivity leading to enhanced cisplatin-induced cell death of many cancer types. Thus, my work will also improve our understanding of cancer chemoresistance and enable better pharmacological approaches for treating many human cancers.

"Reticular Dysgenesis: How a rare disease reveals new insights into myelopoiesis"

Reticular dysgenesis (RD) is one of the most profound forms of combined immunodeficiency characterized by severe congenital neutropenia (SCN) and impaired lymphocyte development. The origin of the neutropenia consists in a maturation arrest at the promyelocyte stage. Recently, the disease has been linked to mutations in the gene encoding for Adenylate Kinase 2 (AK2). AK2 is a phosphokinase implicated in mitochondrial energy homeostasis. However, it remains unclear how defective expression and function of an ubiquitously expressed enzyme involved in energy metabolism would selectively manifest in defective myelopoiesis and lymphopoiesis. The mysterious pathogenesis of this rare disease makes it evident that fundamental principles of neutrophil development remain poorly understood. A significant obstacle to the study of rare diseases, like Reticular Dysgenesis, has been the inadequacy of animal models and limited availability of patient specimens.

The 2012 Nobel Prize in Medicine was awarded to Sir John Gurdon and Shinya Yamanaka for their discovery that somatic cells can be reprogrammed to induced pluripotent stem cells (iPSCs). The advent of reprogramming technology has presented us with the thus far unimaginable possibility to model human disease in a tissue culture dish.

We propose that induced pluripotent stem cells from various patients with different AK2 mutations can serve as a disease model for RD when differentiated in vitro along the myeloid lineage (aim 1). We further propose that the analysis of these cells for transcriptome, protein expression and nucleotide metabolite profile will enable us to understand how AK2 defects lead to a maturation arrest at the promyelocyte stage (aim 2A). We predict that this will allow us not only to solve the mystery of a devastating disease, but also yield new insights into the central pathways driving physiologic myelopoiesis (aim 2B).

As a proof of concept, we will gene-correct the disease specific iPSCs with the intent to demonstrate that gene repair restores normal neutrophil maturation in RD (aim 3). Such iPSC-derived, gene-corrected in-vitro differentiated cells may pave the way to future developments of "patient specific cellular therapy."

"Uncovering Mechanisms of MAVS Activation"

Pattern Recognition Receptors in the innate immune system serve as the first line of defense against pathogen infection by recognizing conserved molecular features commonly associated with pathogens. One important family of such receptors are viral RNA receptors, RIG-I and MDA5, which cooperate with their common adaptor, MAVS, to activate antiviral or inflammatory immune response. The interaction between RIG-I/MDA5 and MAVS represents a committed step in initiation of the innate immune response and is often subject to multiple layers of regulation from both the host and invading virus. Despite the importance, the molecular mechanism by which RIG-I and MDA5 interact with MAVS and link the upstream viral-detection events to downstream signaling events is yet unclear. This is partly due to challenges of analyzing protein aggregation or oligomerization, which occurs during signal activation, and seemingly transient interactions between RIG-I/MDA5 and MAVS. I here propose to investigate the assembly process and architecture of the oligomers of the signaling domains of MDA5 and MAVS, and their complex using an innovative "hybrid" approach that systematically integrates cellular assays, structural and biochemical analysis and computational modeling. I will first define the structural features of the signaling domain (CARD) of MAVS filaments using a combination of protein:protein crosslinking and surface mutagenesis (Aim 1A) and design constructs for crystallization for more detailed structural analysis (Aim 1B). Using similar approaches, I will further define the oligomeric architecture of the signaling domain (2CARD) of MDA5 (Aim 2) and the complex of MDA5 2CARD:MAVS CARD (Aim 3). This project stems from my previous studies on the structure and biochemical mechanisms of how MDA5 recognizes viral RNAs (Wu et al, Cell, in press), but represents a further evolution into the downstream event involving the MDA5:MAVS interaction. I believe that this study will provide a solid biochemical foundation to obtain integrated understanding of the tripartite system of the receptor, ligand and adaptor and would offer novel insights into therapeutic strategies for treatment of viral infection, cancer or immune disorders.

"Dynamic and Tonic Coding of Taste from the Brainstem to the Forebrain"

Brainstem taste regions take almost direct input from the mouth, and control some basic taste-driven behaviors. Thus it is reasonable to hypothesize that brainstem (specifically, the parabrachial nucleus of the pons, PbN) neurons might respond in a simple manner to activation of taste cells on the tongue--that is, they might respond to only one taste or another. However, the majority of input to PbN comes from forebrain regions such as gustatory cortex (GC), which processes tastes with complex 'temporal codes' signaling first the presence, then identity, and finally the desirability of tastes. Therefore it is also reasonable to hypothesize that PbN neurons may reflect this feedback, in the form of similarly temporally complex responses. Discerning whether PbN taste responses reflect simple ascending information, complex descending information, or some combination of the two--requires recording multiple neurons simultaneously in PbN and GC from conscious rats, bringing an extensive range of analyses to bear on these data, and directly assessing what happens when the connection between the brainstem and forebrain is disrupted. I will perform these experiments. First, I will record taste responses from PbN in conscious rats, evaluating the information available within the time courses of these responses (preliminary data demonstrates that these responses are temporally complex, even more so than those in GC). I will simultaneously record the responses of GC ensembles, enabling the first analysis of real-time interactions between forebrain and brainstem (using techniques already tested in our lab); I predict that these analyses will reveal coupled, information-rich temporal structure in the two regions. Next, I will use optogenetics and/or pharmacology to inactivate cortical feedback while recording from PbN, to directly test how GC influences PbN taste responses. These experiments will clarify how neural processing of tastes occurs in real time. Understanding how quality, concentration and hedonic values of taste are processed in the brain may also shed light on the neural underpinnings of eating disorders such as anorexia, bulimia, pathologies resulting from treatments to cancer, and aversions and craving that appear during pregnancy.

"Compartment-Specific Signaling by Striatal Opioid Peptides"

Opioid neuropeptides are abundant in the mammalian striatum, a brain region important for motor function, yet a role for endogenous opioids in locomotion has not been established. Striatal opioid peptides and their receptors are spatially distributed according to the boundaries of distinct microcircuits that receive inputs from either limbic or sensorimotor cortical areas, but the functional significance of this compartmentalization is not understood. The main objective of this study is to understand how endogenous opioids alter circuit function in the striatum and how they affect locomotive behavior. I propose that opioid peptides signal within and between these compartments and that these messages are important for incentive-based motor learning and recall. To test these possibilities, I will first anatomically define and functionally characterize the synaptic inputs from different areas of the cortex to each striatal compartment. This will be achieved using viral tracing

methods and electrophysiological recordings with optogenetic photostimulation in acute brain slices. Next, the cellular and synaptic actions of opioid peptides will be determined in the context of compartmental boundaries using electrophysiological and optical recordings. These efforts will be facilitated by photochemical tools that I previously developed for releasing opioid peptides in brain tissue with high spatiotemporal precision. A major goal of these experiments is to understand how the integrative actions of opioid peptides across striatal network components modulate net output from the circuit and how the limbic and sensorimotor microcircuits are differentially affected. To put these cellular phenomena into context, the involvement of opioid peptides in locomotive behaviors will be explored. I will determine if activity patterns observed in vivo are capable of driving peptide release in brain slices using optogenetic photostimulation. Finally, I will interfere with endogenous striatal opioid signaling during motor learning assays and attempt to pinpoint the location and timing of the pertinent activity. Collectively, these studies should uncover a novel, unified mechanism for opioidergic modulation of a neural circuit that is essential for motor function.

"Telomere-Directed DNA Fragmentation and Genome Stability in Meiosis"

Sexually reproducing organisms make gametes using meiosis, a cell division specialized to reduce ploidy by separating each set of homologous chromosomes. In most organisms, faithful homolog segregation relies on a physical connection established by controlled DNA breakage and exchange of chromosomal segments called crossover (CO) repair. Errors in this process can cause genome abnormalities such as chromosome loss, gain or rearrangement, leading to numerous human disorders. Meiotic cells are faced with a conundrum; they must introduce enough DNA double-strand breaks (DSBs) into the genome to ensure that each chromosome pair makes at least one CO, yet limit the potential damage to the genetic blueprint of their offspring.

To understand how this problem is solved, we previously devised a technique to measure meiotic DSBs across the yeast genome. We observed an intriguing non-random distribution of DSBs; they occurred far more frequently than expected in large ~100-kb zones close to the ends of chromosomes, yet were depleted directly adjacent to chromosome ends and repetitive DNA. I hypothesize that the telomere directed DSB targeting (TDDT) increases DSB levels close to chromosome ends to ensure that all chromosomes receive the CO necessary to segregate during meiosis, but this also places the cells at risk, as COs too close to chromosome ends often fail to hold homologs together. Moreover, DSBs in the telomere repeat-sequences leave cells at risk for non-allelic homologous recombination and genome rearrangement, possibly explaining the silencing of DSB formation immediately adjacent to telomeres. I have identified mutants that affect TDDT, and will use them to understand the function and regulatory mechanisms of TDDT. Specifically, I will:

1. Measure the contribution of TDDT to CO levels and chromosome segregation.
2. Define the attributes of chromosome ends responsible for TDDT and DSB repression.
3. Elucidate the mechanism of TDDT by mapping DSB factor binding, nuclear position and chromosome configuration in mutants that eliminate TDDT.

"Olfactory Processing in the Drosophila Larva"

In no other organ is the relation between structure and function understood as poorly as it is in the brain. Although our understanding of individual neurons is quite sophisticated, we are just beginning to understand how interconnected groups of neurons work together to process information. The complexity and relative inaccessibility of the mammalian brain complicates our ability to study neural circuits in higher animals. The *Drosophila* larva, on the other hand, has few neurons but performs complex behaviors. Further, thanks to recent advances in genetics, protein engineering, and microscopy, and the larva's transparent cuticle, we can optically activate, suppress, and visualize the activity of the neurons of a freely behaving animal. These properties make the larva an ideal model system in which to link structure and function of complete neural circuits.

I will study the olfactory circuitry of the *Drosophila* larva. How do larvae recognize odors, determine if they are attractive or repulsive, and then react appropriately? In order to move towards or away from an odor source, the larva may move forward, backward, or stop, sweep its head to one side or the other, move straight or curve. The rules by which the larva changes its motor output in response to sensory input in order to achieve a goal represent a navigational strategy. I will study the navigational strategies of larvae responding to a variety of odors to reveal details about the organization of the olfactory circuit and the relation of receptor activity to motor behavior.

I will take advantage of the genetic tools available in *Drosophila* and the larva's transparency to image the responses of odorant receptor neurons in the larva's dorsal organ (its 'nose') as a first step to understanding how odors are represented in the brain, and I will link the patterns of neural activity and the behaviors evoked by odor presentation. Finally, to further elucidate the rules linking sensory input to motor output, I will use light activated ion channels to directly manipulate receptor neuron activity to drive navigational responses.

"Chromatin Regulatory Circuits in Mammalian Pre-implantation Development"

During early mammalian development, embryonic cells go through major changes as they transform from the zygote to the inner cell mass (ICM). Decoding the epigenetic regulatory systems orchestrating pre-implantation would shed light on several key biological pathways, both in normal setting and disease. Furthermore, these pluripotent cells serve as a model system particularly suitable for epigenetic studies, due to the important role these mechanisms play in development.

Despite the importance of pre-implantation development, the concerted spatio-temporal programs controlling this process, and more specifically the regulation of chromatin organization, are poorly understood. For example, the exact involvement of Chromatin Regulators (CRs) in setting or maintaining pluripotency, or the role of histone modifications play during early embryogenesis, is poorly understood.

Here, I propose to use genomic strategy to study chromatin regulation during early embryogenesis, combining in-vivo ICMs and in-vitro mouse embryonic stem cells (mESC) model systems. I will initiate this study by measurements of detailed molecular profiles of ICMs and mESCs. These data include

genome-wide profiles of key histone modifications in ICMs. Together with public expression maps of mouse pre-implantation samples, these data will allow me to evaluate and focus on the aspects of the *in vivo* biological system that are recapitulated by the mESCs model. To address the challenges posed by the small number of cells in early embryos, I will use emerging technologies I developed. Finally, I will use a novel approach we established in human cells to generate maps of CR binding in mESCs. I will integrate these data into a model of chromatin regulation and CR combinatorial features during early development. This model will provide testable hypotheses for future perturbation studies; e.g. by shRNAs in mESCs.

The goal of my proposal is to identify and characterize chromatin regulatory mechanisms in early development. This study will promote understanding of developmental pathologies and cases of aberrant chromatin structures, such as those that are found in cancer. Additionally, my studies can allow better understanding of the principals governing pre-implantation embryogenesis; hence, have clinical relevance for reproductive medicine with potential to ultimately impact *in vitro* fertilization as well as early diagnostics or screening.

"How a Wide Spread Mammalian Parasite Dampens Intestinal Inflammation Through the Injection of a Potent Anti-inflammatory Effector Kinase"

Toxoplasma has spread throughout the mammalian kingdom to the extent that a third of the human population are chronic carriers. Reactivation of latent infection in immune compromised individuals, such as HIV AIDS patients, or acute congenital infection in the developing fetus, can lead to inflammatory related pathologies and even death. In mouse models of toxoplasmosis, the small intestine becomes severely inflamed following natural oral infection and bears striking resemblance to the human inflammatory bowel disease, Crohn's. Since Toxoplasma infection can spread through consumption of encysted tissue from chronically infected animals, it is hypothesized that Toxoplasma has developed ways to manipulate intestinal pathology to promote host survival. We have recently identified a polymorphic Toxoplasma kinase, ROP16 that is injected into the host cell and directly activates the STAT3 and STAT6 transcription factors. Once activated, these transcription factors induce the expression of a battery of genes controlling immune function and inflammatory responses, often in an anti-inflammatory manner. Interestingly, we found that when a pathogenic strain of Toxoplasma expresses versions of the ROP16 kinase that activate the STAT3/6 transcription factors, intestinal pathology is suppressed and host survival was enhanced. However, the mechanism by which ROP16 mediates these effects is not known.

In order to identify host factors that are activated by ROP16 and dampen intestinal inflammation, in AIM 1 we propose to use a recently described technique that allows Toxoplasma to inject the Cre recombinase into infected cells. Using this parasite strain to infect mice that contain loxP sites flanking candidate genes, we will induce the specific deletion of ROP16 target genes in infected cells during a natural oral infection. In AIM 2, we seek to understand the specific cell types manipulated by Toxoplasma in the Peyer's patch and how ROP16 works in these cells to achieve protective immunity early in infection. Thus, this proposal will identify specific host genes and cell types that mediate protection against Toxoplasma, and broaden our understanding of host pathways that dampen inflammatory responses in the small intestine.

"Regulation of Antagonistic Protease and Chaperone Activities in an Enzyme Required for Virulence"

Cells in all organisms have evolved quality control systems of proteases and chaperones to deal with the potentially toxic effects of protein misfolding. Degradation by proteases and refolding by chaperones are usually performed by different protein machines, which frequently are ATP dependent. However, DegP, a member of the highly conserved HtrA family, functions both as an ATP-independent protease and as a chaperone in the bacterial periplasm. Goal of my research is to understand the molecular mechanisms that allow a single protein to perform these apparently antagonistic functions in a regulated fashion.

Intriguingly, misfolded protein substrates trigger a dramatic structural transformation in which proteolytically inactive DegP hexamers assemble into active cage-like structures with 12, 18, 24, or 30 subunits. To probe molecular mechanism, I have developed biochemical assays that monitor DegP activation, cage assembly, substrate binding, and substrate cleavage. Studies using these assays, mutant enzymes and crystallography implicate an equilibrium between inactive and active conformations of DegP subunits as well as substrate-stabilized assembly into cages as potential regulatory mechanisms. I have also identified a DegP mutant, whose intracellular expression results in unregulated proteolysis and a dominant lethal phenotype.

Here, I propose to test whether cage formation and the control of conformational equilibrium are the major regulatory mechanisms that regulate DegP proteolysis and/or chaperone function or if additional mechanisms exist, including ones mediated by interactions with specific substrates. To address these questions, I will construct DegP variants with combinations of mutations that affect specific functions and assay their activities in vitro and in vivo. I will also screen or select for novel mutations that increase or suppress cytotoxicity in cells and that alter chaperone function. By studying the biochemical activities of these variants, their structures, and their interactions with model substrates, I will formulate and test molecular mechanisms of DegP function and regulation. I anticipate that the information and understanding that emerge from these studies will provide paradigms for the HtrA enzyme family, will aid in the development of antibiotics that target DegP, and will give mechanistic insights into homologs that are implicated in human disease.

"Mammalian Target of Rapamycin Complex 2 (mTORC2) Signaling in the Control of Glucose Homeostasis and Aging"

The mechanistic target of rapamycin (mTOR) is a widely conserved protein kinase that plays a central role in linking nutrient signaling to cell growth and proliferation. mTOR is a member of two complexes, mTORC1 and mTORC2, each of which regulates distinct cellular targets. Recent studies have demonstrated that treatment with rapamycin, originally thought to be a specific inhibitor of mTORC1, can extend the lifespan of yeast, flies, and mice, but the mechanism that underlies this extension is still unknown. Recently, the Sabatini laboratory discovered that chronic treatment with rapamycin disrupts mTORC2, suggesting a possible role for this complex in the lifespan extension brought on by rapamycin

treatment. In this proposal, I outline studies to identify novel substrates of mTORC2, examine the consequences of mTORC2 disruption on longevity, and determine the role played by mTORC2 in the response to calorie restriction.

Recent studies have begun to explore the crucial role played by mTORC2 in regulating organismal physiology, yet only a few direct substrates of mTORC2 have been characterized. In an effort to find physiologically relevant mTORC2 substrates, I will use a proteomics-based approach to characterize the mTORC2-regulated hepatic phosphoproteome. Further, I will examine how the regulation of these substrates by mTORC2 signaling changes with age.

To determine the effects of mTORC2 disruption on health, glucose homeostasis, and lifespan, I will use three genetic mouse models in which Rictor (an essential component of mTORC2) is depleted. I will use mice heterozygous for a Rictor null mutation, mice which specifically lack hepatic Rictor, and mice in which Rictor is deleted from all tissues in adult mice using a tamoxifen-inducible system. I will also determine how mTORC2 and aging interact to regulate health and glucose homeostasis.

Calorie restriction (CR) is an intervention in which caloric intake is reduced while maintaining adequate nutrition, extends lifespan in many organisms, including mice and primates. While the mechanism by which CR promotes longevity is unclear, CR promotes glucose tolerance and insulin sensitivity. I will determine if mTORC2 is required for the positive effects of CR on glucose homeostasis.

"Genetic Pathways Mediating Axon Death"

Wallerian degeneration is a conserved phenomenon where, upon axon transection, the distal portion of the axon degenerates. This was thought to be due to the lack of trophic support provided by the cell body. However, recent work directly challenges this view: First, long-term axon survival of severed axons is provided by the neomorphic WldS molecule. Second, our lab has shown that loss-of-function mutation in *Drosophila* dSarm blocks the degeneration of severed axons for the life span of the fly. These remarkable observations demonstrate that axon death is a genetically programmed mechanism, but the vast majority of axon death genes remain to be identified.

The long-term goal of this proposal is to define the molecular basis of axon death signaling. However, a lack of efficient screening methods to identify axon death genes has made this phenomenon refractory to incisive analyses. In preliminary work, I have established a powerful yet simple new genetic approach -- the *Drosophila* wing blade -- that will allow me to rapidly identify mutants that block the degeneration of severed axons. The efficiency of this approach relies on: the use of mosaic analysis for F1-based screening; a simple and highly reproducible axotomy; and the ability to score axonal integrity with single axon resolution *in vivo*. Using this approach, I have already discovered 5 new mutants; 3 suppress axonal degeneration, and 2 mutants exhibit normal axon degeneration but cellular debris persists.

In aim 1, I will use the wing blade to perform a genome wide saturation screen for mutants that suppress axon degeneration. In aim 2, I will identify and characterize the already isolated axon death mutants. These aims represent a bold attempt to genetically attack the question of how axons promote their own destruction.

My findings will substantially advance our knowledge of the biology of axon death. In addition, the results of my studies will improve our understanding of the nature of axon and synaptic loss -- a hallmark of every neurodegenerative disease and peripheral neuropathy. Importantly, each newly-identified axon death gene provides a novel potential drug target for intervention in neurodegenerative disease.

"Molecular Examination of the Microbial Influences on Host Health"

During my postdoc in the Ruvkun Lab, I have developed the already genetically tractable, high-throughput amenable and microbially 'tuned' nematode *Caenorhabditis elegans* into a system for interrogating beneficial microbe-host interactions. Contrary to popular views, microbes are not simply as a source of food for *C. elegans*. In their natural habitats (rotting fruits and vegetation), I have demonstrated that wild *C. elegans* adults harbor microbial communities in their guts. To explore this community more comprehensively, collaborators and I have sampled several field seasons of habitats to define the composition of this gut microbiota and the habitats as a whole by using metagenomic sequencing of community rDNA. I have found that wild *C. elegans* strains are genetically adapted to respond to these microbes. Similarly, they are more fit (better prepared) to respond to stressful microbes isolated from their habitats compared to *E. coli*-adapted lab *C. elegans*. Finally, using a combination of sequencing, comparative genomics, and biochemical approaches, I have demonstrated that *C. elegans* tunes its metabolism to both evolutionarily conserved and novel microbial products, specifically microbial RNA. This simple and natural system is well suited to expedite the identification and further characterization of the host and microbial signals and pathways that affect host health.

In the final 2-3 years of my postdoc, I plan to publish 2 papers based on the preliminary data presented here. The first is a description of the microbial ecology of natural *C. elegans* habitats and how population growth is affected by community composition. The second paper provides the first comprehensive look of the microbial determinants of host health from a metabolic perspective. From the studies proposed herein, I expect a third paper focused on a genetic examination of the host pathways that are responsive to microbes in *C. elegans* that will provide a solid foundation for the establishment of my own research group. Ultimately, I intend to center my research career on the interrogation of host microbial interaction pathways that affect host health using *C. elegans* and a variety of other systems.

"Multiplex Screen for Interacting Compounds Targeting Hepatitis C Virus"

Human diseases often involve more than one mechanism and signaling pathway. Consequently multiple therapeutic interventions are often needed to treat a disease. Our goal for this proposal is to develop a method that allows systematical identification of effective compound combinations and apply this method to identify drugs targeting Hepatitis C virus, which causes over 10,000 deaths each year in the US and presents an urgent need for better therapies. To that end, we use a pooled screening strategy to overcome the problem of the large number of combinations, which increases exponentially with the

number of compounds. We carefully selected 1000 FDA approved drugs or clinically tested compounds and constructed a library that consists of pools of 10 compounds that covering all the possible pair-wise combinations. We named it the MUSIC library (Multiplex Screen for Interacting Compounds). We validated this novel screening platform by discovering a number of compound pairs that act synergistically to inhibit HIV replication. The major focus of the proposal is to screen for anti-Hepatitis C virus (HCV) drug combinations. We aim to: 1) screen the MUSIC library on the fully infectious genotype 2a HCV strain JFH1 to identify drug combinations that inhibit HCV replication and validate the hits on the genotype 1 HCV replicons systems 2) mechanistically characterize the hits that show broad anti-HCV activity by RNAi knock-down of putative targets, gene expression profiling, SILAC mass spectrometry coupled with pull down assay etc. The Charles King Fellowship will allow me to gain experience with virology, especially HCV virology. With these training, in my own laboratory in the future, I will continue in the direction of applying high throughput technology to pathogenic diseases that cause serious human health problems.

"Structural Basis for the Regulation of the Molecular Motor Dynein by Lis1"

Cytoplasmic dynein uses the energy from ATP hydrolysis to step along microtubule tracks in eukaryotic cells. It is one of the most versatile molecular motors known, with critical roles in powering transport of diverse cargos, constructing the cell division machinery, and polarizing molecules during development. Remarkably, there is just one cytoplasmic dynein responsible for all of its diverse cellular tasks. It therefore relies on interactions with regulating proteins to achieve specificity of function but very little is known about these co-factors and how regulation is achieved. Recent data show that dynein's motile behavior is altered by Lis1, a ubiquitous dynein co-factor associated with a severe brain development disorder in humans (lissencephaly).

The objective of this project is to determine structurally and mechanistically, how dynein is regulated by Lis1. I will use a combination of cryo-electron microscopy, docking of known crystal structures and biochemistry to address the following specific questions: 1) how does Lis1 affect the structure of dynein in solution and when bound to microtubules? Can Lis1 constrain dynein in a particular structural state? 2) Which structural elements of dynein does Lis1 engage? What does this tell us about how Lis1 affects the flow of structural changes in dynein to alter its function? 3) Does Lis1 undergo conformational changes to engage dynein? By providing answers to these questions, this work will begin to provide mechanistic insight into how dynein's motile behavior is regulated to meet its wealth of functions in living cells.

In the longer term these studies could provide a foundation for developing lissencephaly treatments, and aid development of synthetic applications for dynein, such as drug delivery systems.

"Cortical-hippocampal Dynamics Governing Memory Consolidation"

The goal of my research is to understand how two brain areas (auditory cortex and hippocampus) are involved in storing memories. Previous work has suggested that the hippocampus plays a critical role in memory consolidation, temporarily storing a new memory and then transferring this memory to cortex during sleep. The proposed research uses electrophysiological, behavioral, and optogenetic methods to study the hippocampus and auditory cortex of rodents during memory consolidation of an auditory-spatial association behavioral task. A phenomenon central to this proposal is hippocampal replay, a process by which neurons in the hippocampus activated in a specific sequential pattern during a behavior get reactivated in the same way while the animal is sleeping (after the behavior). Hippocampal replay provides a neural correlate of the memory, and allows the experimenter to track when and where the memory is being transferred in the brain (e.g. by observing a coordinated replay event between two brain areas).

In Aim 1 of this research proposal, I will study how sensory input can modulate the content of hippocampal replay events and affect memory consolidation. Rats will be trained on an auditory-spatial association task and I will play task-related sounds during sleep to see if replay content is biased toward the spatial location associated with the sound. I will then determine if learning is enhanced for auditory-spatial associations strengthened during sleep (due to a replay content bias). In Aim 2, I will study auditory cortical responses during hippocampal replay, and examine the contribution of supra- and infragranular cortical layers to memory consolidation. In Aim 3, I will use optogenetics to inactivate auditory cortex during hippocampal replay events, and determine if the transfer of memories from hippocampus to cortex requires cortical activity during replay events.

My proposed research plan represents an initial step towards understanding how memories are stored in the brain through cortical and hippocampal networks. Understanding how information is stored and transferred between brain areas can be advantageous in developing new treatments for memory-related disorders such as Alzheimer's disease, dementia, and amnesia.

"Differential Regulation of Subsets of Inhibitory Synapses by the Transcription Factor Npas4"

Neurons receive thousands of excitatory and inhibitory (E/I) inputs throughout their dendrites, soma, and axon initial segment. Proper circuit function requires appropriately matched E/I synaptic activity -- a daunting task considering the heterogeneity of inhibitory neurons and constantly changing excitation. The importance of this balancing act is underscored by the myriad neurological disorders believed to stem from an E/I imbalance, including autism, schizophrenia, and epilepsy. I am interested in identifying signaling pathways that regulate subsets of inhibitory synapses in response to changing excitation.

The activity-dependent transcription factor Npas4 is induced by excitatory activity and regulates inhibitory synapses received by the active neuron, making it unique in its capacity to transcriptionally regulate E/I balance. I am studying Npas4 to address the following:

1. Does Npas4 regulate all or subsets of inhibitory synapses?
2. Through which target genes does Npas4 regulate inhibition?

In the hippocampus, we are using of a combination of electrophysiology and viral circuit-tracing techniques to locate the axons and somas of presynaptic interneurons regulated by Npas4. In acute slices, we simultaneously compared evoked inhibitory currents between neighboring wild type and Npas4-knockout pyramidal neurons in response to layer-specific stimulation of axons. Inhibitory currents originating from the soma and basal dendrites decrease while those from the apical dendrites increase in Npas4-knockout neurons suggesting Npas4 regulates at least two types of inhibitory neurons. In organotypic slices, we can infect a single pyramidal neuron with a modified rabies virus that replicates and infects monosynaptically connected presynaptic neurons. We are comparing connectivity between control and Npas4-knockdown neurons to gain insight into Npas4-regulated interneurons.

Npas4 exerts its influence by regulating the expression of genes. To identify targets, we used next-generation sequencing to survey the genome for Npas4 binding and activity-regulated transcription. In organotypic slices, we knocked down 52 of ~200 target genes and recorded corresponding miniature inhibitory postsynaptic currents; we are currently validating hits. Most Npas4 targets are neuropeptides or involved in neuropeptide biosynthesis and secretion. We speculate neuropeptides regulate subsets of interneurons.

These studies are fundamental to our understanding of circuit function and may suggest targeted interventions for neurological disorders associated with E/I imbalance.

"A Model-based Approach to Stem Cell Differentiation and Human Development"

Pluripotent stem cells possess the ability to differentiate into any cell of the human body. If we could effectively utilize this ability it would become feasible to study human disease directly in human cells, and to engineer tissues and organs for transplantation therapy. However, current protocols for stem cell differentiation are cumbersome and inefficient, and protocol development relies heavily on trial-and-error.

The proposed project explores the hypothesis that a quantitative model of human embryonic development could enable rational design of directed differentiation protocols. I will test this hypothesis in a proof-of-concept study that investigates and improves the differentiation of human pluripotent cells into motor neurons and cardiomyocytes. To that end, I have established collaborations with leaders in the fields of neural and cardiac development, and I have developed a genomic scorecard for predictive characterization of human pluripotent cells and their differentiating progeny. This scorecard will be used to obtain time series of neural and cardiac differentiation starting from human pluripotent cells. Based on this unique dataset I will computationally infer the epigenetic and transcriptional mechanisms that control neural and cardiac development in human. These predicted mechanisms will be validated

experimentally in a targeted gain-of-function screen.

Finally, I will evaluate bioinformatic algorithms for rational design of improved neural and cardiac differentiation protocols, and I will work with the collaborators to experimentally confirm the efficiency and utility of these protocols. In summary, the proposed project exploits the power of a novel genomic tool to derive a quantitative model of human embryonic development, and it applies this model to computationally design neural and cardiac differentiation protocols. This approach readily generalizes to other lineages and could overcome a critical bottleneck of stem cell research, fostering the use of pluripotent stem cells for drug discovery and regenerative medicine.

"Transnuclear Mice Derived From NKT Cells With Different TCR Vbetas"

NKT cells recognize lipid antigens presented on CD1d, and have been implicated in a range of diseases. NKT cells produce a variety of cytokines and have both pro and anti-inflammatory properties. NKT cells use a semi-invariant T cell receptor consisting of TCR Valpha14;Jalpha18 paired with a limited set of TCR Vbetas. Subtle differences in TCR Vbeta usage affect both the spectrum of ligands seen and the TCR affinity for those ligands. Functionally distinct subsets of NKT cells have been described, but the contribution of TCR Vbeta usage to NKT cell differentiation has not been explored. We propose to use somatic cell nuclear transfer to clone mice from NKT cells with different TCR Vbetas. The resulting panel of transnuclear mice will serve as a source of genetically identical NKT cells. These transnuclear NKT (TN NKT) cells will be adoptively transferred into Jalpha18^{-/-} mice, which lack invariant NKT cells, and the homing properties of each TN NKT line will be assessed. TN NKT cells will be cocultured with CD1d-expressing primary cells (hepatocytes, intestinal epithelial cells, B cells and dendritic cells) and with plate-bound CD1d loaded with host or pathogen-derived lipids to determine the spectrum of lipids seen by each TN NKT line and the profile of cytokines produced in response to those lipids. Finally, TN NKT cells will be adoptively transferred into Jalpha18^{-/-} hosts and assessed for their ability to cause hepatic damage upon activation with alpha-galactosylceramide or upon infection with adenovirus expressing the hepatitis B viral genome. The transnuclear NKT cell mouse panel will allow, for the first time, a clear distinction between the genetic contribution of the TCR versus the environmental contribution of the local tissues to the appearance of NKT cell functional subsets. Furthermore, TN NKT mice will be an invaluable resource for the NKT cell community as a source of primary NKT cells.

Specific Aims:

- 1) Generate transnuclear mouse lines from NKT cells with different TCR Vbetas.
- 2) Analyze the tissue homing patterns and cytokine profiles of each NKT TN line.
- 3) Assess the contribution of each NKT TN line to a mouse model of autoimmune hepatitis.

"Multisensory Integration Deficits in Autism: Molecular Mechanisms of Postnatal Development"

Most of our daily sensory experiences are dominated by inputs from more than one sense. We use these different senses to build a uniform concept of our environment and to improve our

perception. To bind the information from different senses, the brain has devoted specialized neuronal circuits to multisensory integration. These circuits are shaped postnatally in an experience-dependent manner. Interestingly, recent research has demonstrated that multisensory integration is deficient in complex neurodevelopmental disorders such as autism spectrum disorders (ASD).

I propose to test the hypothesis that abnormalities of multisensory function in ASD arise from disruption of normal postnatal plasticity. Furthermore, I will test whether restoration of proper critical period plasticity can rescue functional and behavioral impairments in animal models of ASD.

Towards this aim, I recently established a mouse model of cortical multisensory integration. I found that mice with impaired excitatory-inhibitory balance or myelin signaling, as well as an inbred mouse model of ASD, lack proper multisensory integration. These results have started to reveal molecular mechanisms regulating the development of multisensory integration in the healthy and diseased brain and raise further important questions:

(1) How is multisensory integration achieved at a cellular level across development and how do inhibition and myelin signaling contribute to the experience-dependent shaping of these circuits? (2) Do abnormalities of multisensory circuitry in ASD arise from disruption of postnatal, experience-dependent synaptic plasticity and can we (3) functionally and (4) behaviorally rescue multisensory deficits in animal models of ASD through the manipulation of critical period plasticity?

To address these questions, I will record single neuronal responses from the multisensory cortex of anaesthetized control and ASD mice at different ages and use genetic models to reveal which aspects of multisensory integration depend on proper inhibition and/or myelin signaling and whether these mechanisms are disrupted in ASD circuits.

I will then try to restore proper multisensory integration in ASD mice by manipulation of inhibition during postnatal development. Finally, I will address through behavioral testing whether restored multisensory integration in ASD mice also improves behaviorally the autistic phenotype.

"Targeting Antibiotic Resistance by Defining the Molecular Basis for Segregation Dependent Plasmid Incompatibility in Bacteria"

Infection by microorganisms remains one of the most serious threats to human survival in the 21st century. This threat persists due in part to the evolution and spread of mechanisms in bacteria that confer resistance to antibiotics. The majority of resistance genes are harbored on mobile genetic elements known as resistance, or R, plasmids. I believe that directly attacking the plasmids represents an attractive alternative to conventional therapies for suppressing antibiotic resistance. R-plasmids are stably maintained within bacteria over hundreds of generations because they encode stability loci. These loci ensure that both daughters of a dividing bacterium receive at least one copy of the plasmid.

Mutations that break this segregation machinery lead to the loss of antibiotic resistance. Before targeting the segregation machinery it is imperative to know how rapidly it can evolve because this will

make it possible to screen for compounds that target the least evolutionarily flexible regions of the target proteins.

To understand the evolutionary pressures on plasmid segregation, I will study the phenomenon of plasmid incompatibility - the inability of two different plasmids that use the same segregation machinery to both be stably maintained in a bacterial lineage. Plasmids escape from incompatibility when the proteins responsible for segregation acquire enough changes so that the machinery of one plasmid no longer interacts with that of the other plasmid.

I aim to define this region of evolvability for a group of stability loci that are homologues to that found on the R-plasmid from multidrug resistant *Staphylococcus aureus* (MRSA). These loci encode three components named ParC, a centromere like DNA sequence, ParM, an ATPase actin like filament, and ParR, a DNA binding protein. My data thus far suggests that sequence similarity specifically between the ParR proteins on two plasmids, is predictive of partitioning incompatibility. This proposal aims to define precisely the region of ParR that governs incompatibility and to use this knowledge to experimentally evolve two compatible partitioning systems. These insights will assist us in identifying optimal targets for anti-plasmid therapies.

"Molecular Dissection of Innate Defensive Behaviors in Rodents"

Sensory experiences play a fundamental role in sculpting normal brain function and behaviors, and may, in some circumstances, increase the risks for mental disorders. For example, stressful and life-threatening experiences are strongly associated with the emergence of mood disorders such as anxiety, depression and posttraumatic stress disorders. The molecular mechanisms underlying these long-term changes in brain physiology remain elusive. While recent evidence suggests that the establishment of adapted states involves chromatin regulation, precise causal links between chromatin states and mood disorders have not yet been established.

The vomeronasal system of rodents offers an excellent experimental system to dissect stress-induced behaviors. Importantly, the odors of life-threatening predators, mammalian predators and snakes, are known to generate distinct but partially overlapping innate responses with short and long-term consequences such as avoidance, hypervigilance, and modulation of feeding and foraging behaviors.

We recently identified a specific repertoire of vomeronasal receptors that differentially detect various classes of predators such as mammalian predators, snake, and birds of prey, and demonstrated that the vomeronasal organ (VNO) is required for avoidance behavior and feeding inhibition upon predator stress. Our results therefore open new avenues of research on the specific neural pathways controlled by different predator inputs and on the mechanisms by which predator stress generates long-term effects.

Specific Aim 1: What are the targets of predator inputs in the brain?

I will first identify specific brain areas activated by distinct classes of predators (mammals, snake and birds). Subsequently, I will molecularly characterize the activated neurons using RNA-seq. These experiments will reveal if distinct predator information is processed in either "generalist" or "specialist"

circuits, and will yield important insights into how predator cues may generate diverse behavioral and endocrine responses.

Specific Aim 2: What are the molecular mechanisms underlying the long-term effects of chronic predator stress?

I will use predator odors to chronically stress animals and identify alterations in gene expression and chromatin composition (DNA methylation, histone modification) associated with long-term changes in physiology and behavior. This comprehensive dataset will allow a detailed analysis revealing potential molecular strategies during long-term adaptation to chronic predator stress.

"Nitric Oxide Regulates Lymphatic Vessel Function in Health and Disease"

Chronic disruption of lymphatic function leads to lymphedema, which creates painful and disfiguring swelling. In addition, chronic infections are common in sites of lymphedema, carrying a heavy burden on the patient and requiring frequent and expensive medical treatment. While in the US about 3 million patients develop lymphedema as a result of cancer therapy, the major cause of lymphedema world-wide is lymphatic filariasis, which is caused by mosquito-borne parasitic infections of the lymphatic system. Globally, it is estimated that there are 120 million filarial infections, with over 1.3 billion people at risk.

During both inflammation and lymphedema, an impaired immune response is frequently observed. However, it is not clear which step of the immune response is impaired: i) antigen presenting cell (APC) activation, ii) antigen and APC entry into initial lymphatic vessels, iii) antigen and APC transport through collecting lymphatic vessels, iv) the capacity of APCs to present antigen or v) the induction of regulatory T cells. Here, I hypothesize that major defect is in the transport of antigen and APCs to the draining lymph node and that reduction in lymphatic function is mediated by myeloid-derived suppressor cell produced nitric oxide (NO).

I have developed a mouse model that allows intravital imaging of autonomous lymphatic contractions. Using my novel model, I have determined that NO regulates lymphatic contraction under physiological conditions and that lymphatic contraction was significantly attenuated during edema induced by inflammation. In this study, I will determine the roles of different nitric oxide synthases in regulating lymphatic contraction under inflammatory conditions (Aim 1). Second, I will characterize which cell types produce NO during inflammation and determine their effect on lymphatic function through functional blockade studies. Finally, I will measure each step in the T-cell response to ovalbumin and a self-antigen myelin oligodendrocyte glycoprotein after inducing inflammation (Aim 3).

The lymphatic contraction model established in this study will provide an invaluable tool to study lymphatic function. It will also improve our understanding of the mechanism of impaired immune response during inflammation and edema. Using this model, strategies to improve immune protection during lymphedema will be developed.

"Clock Gene Targeting in Monarch Butterflies Using Zinc-Finger Nucleases"

Biological timing is critical to many life processes, at both physiological and behavioral levels. In the last decade, much has been learned about the molecular clock and its behavioral outputs in animals using genetically tractable species, such as *Drosophila* and the mouse. Recently, the migratory monarch butterfly (*Danaus plexippus*) has emerged as a novel system to study animal clock and navigational mechanisms because it possesses a circadian clock necessary for its flight oriented behavior during the fall migration, whose molecular mechanism incorporates features of both *Drosophila* and vertebrate clocks. In addition to a *Drosophila*-like cryptochrome, monarch uses a vertebrate-like protein (designated CRY2). Our knowledge of monarch CRY2 function is limited to cell culture studies in which it functions as a transcriptional repressor of the core clock mechanism. In addition, its spatial and temporal expression patterns in the brain also suggest that CRY2 could be marking the neuronal network involved in time-compensated flight orientation. Yet, defining the roles of CRY2 for clockwork and navigational mechanisms *in vivo* has been challenging because direct genomic manipulation at a specific locus is not feasible. To access the monarch genome, which is being sequenced and annotated, we are pioneering a gene targeting approach using Zinc-Finger Nucleases (ZFNs). Our initial goal and the bulk of this proposal aim at knocking out *cry2* and knocking a membrane GFP tag into the *cry2* locus in individual butterfly lines. Preliminary data validate the use of ZFNs to introduce genomic lesions and mutations *in vivo*; surviving animals after embryo microinjection of mRNAs encoding the ZFNs are mosaic for *cry2* mutations. When germline transformants are recovered, knockout and knock-in lines will be established. The effects of the knockout will be monitored for the disruption of the molecular clockwork, and circadian and orientation behaviors using standard methods. The axonal projections of clock neurons expressing membrane-tagged GFP knocked into the *cry2* locus will be assessed by confocal microscopy for circuit mapping. This work will pioneer a novel and powerful strategy for genetically manipulating monarch butterflies, which could be extended broadly to "non-model" insects for which genome accessibility is still lacking.

"Structural and Mechanistic Studies of let-7 MicroRNA Regulation by Lin28"

MicroRNAs (miRNAs) are small RNA molecules that regulate specific target gene expression by recognizing mRNAs through sequence complementarity. Recent years' progress revealed major steps in miRNA maturation. However, many mechanistic questions remain, including substrate recognition by the RNaseIII molecules and potential modes of intervention. The *let-7* miRNA family controls a variety of cell fate determination genes to influence pluripotency, development, and tumorigenesis. The first example of post-transcriptional regulation of miRNAs was discovered when *Lin28* was found to inhibit *let-7* maturation. The overarching goals of this study is to understand how microRNAs are regulated at the post-transcriptional level, using the *Lin28:let-7* as a model system.

To study *Lin28* activity, I am using largely structural and biochemical approaches. I have established the groundwork to investigate *Lin28:pre-let-7* interactions in biochemical studies, including quantitative binding assays and NMR spectroscopy. Guided by the cumulative understanding of the complex, I

recently determined high-resolution crystal structures of Lin28 in complex with pre-let-7. I now have a compelling hypothesis for the specificity of Lin28, guided by the structures, and will use biochemical assays and NMR to validate it. The proposed work will also build upon the Lin28:pre-let-7 complex to decipher how a key downstream factor, terminal uridylyl transferase (TUTase) is recruited. In order to map the interaction surface, I can use binding and enzymatic assays as well as NMR spectroscopy. Combining these data with the structural information will already provide considerable insight, but I will also attempt to determine a co-crystal structure of the ternary complex. Finally, I will conduct a high-throughput search for inhibitors targeting the Lin28:pre-let-7 complex, using a fluorescence polarization assay.

By understanding how Lin28 specifically binds its target, recruits a downstream effector, and can be blocked, are all important questions to better understand let-7 regulation with many biological implications. In addition, mechanistic details from Lin28 may be applicable to a rapidly growing list of other RNA-binding factors that appear to regulate other miRNAs. Finally, investigating how Lin28 inhibits central events in miRNA processing will also provide a fresh perspective on mechanisms involved in miRNA maturation itself.

"Cytoprotective Factors Activated in Response to Mitochondrial Perturbation in Drosophila"

Mitochondrial injury usually elicits a robust compensatory response where signals emanating from damaged mitochondria activate signaling cascades to re-establish metabolic homeostasis. Studies in mammalian systems have uncovered a network of kinases, nuclear factors, and other molecules that contribute to this adaptive cytoprotective response; but a model system easily amenable to genetic studies has been lacking. I have established a paradigm in *Drosophila* that will allow such studies. Constitutive expression of RNA interference constructs to complex I proteins in *Drosophila* somatic muscles activate several signaling pathways that are required for cytoprotection and cell maintenance when mitochondria are injured. The extended larval phase associated with this phenotype is highly amenable to genetic screens. This *in vivo* system will facilitate the identification of novel regulatory factors that are preferentially required for the induction and sustenance of cytoprotective responses associated with mitochondrial dysfunction. Specifically, I will:

Aim 1. Establish the contribution of ferritin and hsp60 to adaptive mitochondrial stress signaling: Both hsp60 and ferritin are strongly induced in muscles with perturbed mitochondria. Using genetic, cell biological and biochemical analyses, I will examine the consequence of either overexpressing or knocking down the expression of these genes in muscles with perturbed mitochondria.

Aim 2. Characterize the mechanism by which the JAK-STAT pathway confers tolerance to mitochondrial stress: A genetic screen for factors that preferentially confer tolerance to mitochondrial perturbation identified multiple components of the JAK-STAT pathway. I will use various genetic and cell biological assays to assess the impact of this pathway on cytoprotection

Aim 3. Identify additional cytoprotective genes via expression profile analysis and functional validation: Using microarray and shotgun proteomic analyses, I will identify additional genes induced in NDUFS1-disrupted muscles; and establish their functional significance using genetic, cell biological and biochemical assays

In summary, I have established a system in *Drosophila* that allows mitochondrial adaptive stress responses to be studied and plan to identify the molecular framework associated with this phenomenon. Given the high degree of conservation between the *Drosophila* and human genomes, I anticipate that cytoprotective factors identified by this study will provide leads for improving/restoring mitochondrial function in humans.

"Identification of X-reactivation Mechanisms in Mouse Embryos and Induced Pluripotent Stem (iPS) Cells"

X-chromosome inactivation is a classic epigenetic phenomenon, by which female mammals (XX) avoid imbalances in gene dosage with males (XY). It involves multiple epigenetic processes such as DNA methylation, histone modifications, and expression of long noncoding RNAs. While X-inactivation is tightly maintained in differentiated cells, it is reversible both in vivo during embryonic development and in vitro during the generation of induced pluripotent stem (iPS) cells. As a hallmark of the pluripotent cell state, X-chromosome reactivation is a particularly timely research topic. The goal of the proposed projects is to functionally address the interplay and hierarchy of various genetic and epigenetic regulators of X-reactivation during reprogramming towards pluripotency.

In my proposed projects, I am addressing the question of how X-reactivation is achieved from two different angles. In Aim 1, I use a hypothesis-driven functional approach to ask, if the noncoding RNA *Tsix* is involved in X-reactivation. *Tsix* is a repressor of *Xist*, an X-linked long noncoding RNA, which is the master regulator of X-inactivation. While *Tsix*'s function during X-inactivation has been extensively studied, its role during X-reactivation is unknown. To answer this question I am looking at X-reactivation in *Tsix*-mutant mouse embryos and iPS cells. As both *Tsix* and *Xist* are regulated by pluripotency factors, these experiments could advance our understanding of how pluripotency and X-reactivation are mechanistically linked.

In Aim 2, I propose to investigate X-reactivation with an unbiased screening approach. By single-cell expression profiling in mouse blastocysts during X-reactivation, I have previously identified a number of potential "X-reactivator" candidate genes. Using lentiviral RNAi knockdown during reprogramming of fibroblasts into iPS-cells, I am planning to functionally validate the top X-reactivator candidates. While some of them might be necessary specifically for X-reactivation, others might be crucial for iPS-cell formation in general. Therefore this project has relevance both for the epigenetics and stem cell field and could potentially uncover previously unknown pathways required for epigenetic reprogramming and pluripotency.

"Characterization of the Fundamental Role of the Nervous System in Psoriatic Skin Inflammation"

Experimental data from various animal models of psoriasis, as well as the clinical efficacy of newer systemic therapeutics strongly implicate both innate and adaptive immune response in the pathogenesis of psoriasis. However, to designate psoriasis purely an autoimmune disease is too simplistic. The activation of the immune system alone fails to clarify various clinical and histopathological psoriatic

features. In exciting preliminary experiments we have observed the fundamental role by which peripheral nerves determine the magnitude of skin inflammation response in two psoriasis-like models. Therefore, we hypothesize that peripheral nerves control the initiation and determine the magnitude of the immune response during psoriasis. The central objective is to characterize the role of peripheral nerves in the initiation and modulation of the inflammatory response and determine how the interactive behavior between peripheral nerves and immune cells may influence the immunological outcome in psoriasis. To accomplish this objective, first we will perform the degeneration of sensory and sympathetic nerves in order to characterize the neuro-modulation of the skin inflammation. Second, we will introduce a multiphoton intravital microscopy (MP-IVM) technique to study the interaction dynamics between peripheral nerves and immune cells during skin inflammation in two psoriasis-like models. The demonstration of the crucial role of the nervous system on the cutaneous inflammatory response will lead to new therapeutic targets to treat psoriasis.

"Investigating the Molecular Basis of Function of a DEAD-box Protein DDX6 in Translation Control"

DEAD-box proteins, abundant RNA-dependent ATPases, are classically viewed as RNA helicases due to their homology with DNA helicases. However, emerging evidence suggests an anti-dogmatic possibility that DEAD-box proteins may instead function as stable mRNP components with their nucleotide binding states dictating different conformations and activities. For example, the exon junction complex (EJC) protein eIF4AIII stably clamps onto spliced mRNAs in its ATP-bound state, providing a binding platform for other proteins. ATP hydrolysis and subsequent release of ADP and inorganic phosphate from the protein causes it to dissociate from mRNA. Numerous other DEAD-box proteins also constitute stable RNP components. Given that no DEAD-box protein has been shown to be a processive helicase, it is possible that this recently discovered ATP-modulated RNA clamp activity might prove the rule for this protein family rather than the exception. My goal is to test this hypothesis by investigating other DEAD-box proteins that stably associate with Neuronal Granules (NGs), which are cytoplasmic translation repression complexes important for neuronal functions. To begin with, I propose to study a NG-localizing DEAD-box protein DDX6, a well-known translational regulator whose molecular mode of function is poorly understood. To test if DDX6 functions as an ATP-dependent RNA clamp, I plan to use a combination of biochemical, molecular biological and genomic approaches to study how and where on mRNAs this protein is recruited. My first specific aim is to identify proteins that selectively interact with DDX6's "closed" or "open" states, and modulate its activities to impact translation. To this end, proteins from rat cortical neurons that are purified with DDX6 in its closed state (RNA- and ATP-bound) and open state (free of RNA and ATP) will be identified using affinity chromatography and mass spectrometry. In my second aim, I will identify genome-wide RNA binding sites of DDX6 within its mRNA targets. This will be achieved by tandem immunoprecipitation of RNA-protein complexes containing DDX6 and one of its closed state interaction partners from rat cortical neuron extracts. High-throughput sequencing of purified footprints will identify RNA binding sites of the DDX6-nucleated complexes.
